Hearing

On the matter of the petition to repeal Section 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, Or Scheduled Maintenance* and replace with a new rule, 20.11.49 NMAC, *Excess Emissions*; to amend 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors*, to correct cross-referencing; and submit the newly adopted 20.11.49 NMAC, and amended 20.11.90 NMAC, and 20.11.65 NMAC to EPA as a revision to the State Implementation Plan (SIP).

Hearing Officer Bill Grantham opened the hearing at 5:32 p.m. Mr. Neal Butt, AQD Environmental Health Scientist, Mr. Alan Shar, EPA-Region 6 Air Planning Section, Matt Stebleton, AQD Environmental Health Supervisor, Damon Reyes, AQD Environmental Health Enforcement Supervisor, and Adelia Kearny, COA Deputy City Attorney, provided testimony and answered questions regarding the proposal to repeal Section 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, Or Scheduled Maintenance* and replace with a new rule, 20.11.49 NMAC, *Excess Emissions*; to amend 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors*. Hearing Officer closed the hearing at 6:42 p.m.

Minutes

CALL TO ORDER

The meeting was called to order at 6:44 p.m. on September 9, 2009 with six Board members present. Board Chairman Jens Deichmann presided.

Item # 1 Approval of the Agenda.

A motion was made by Chairman Deichmann to approve the agenda, seconded by Member Upson. Motion was carried by a vote of 6-0.

Item #2 Approval of the August 12, 2009 Meeting Minutes.

A motion was made to approve the minutes by Chairman Deichmann, seconded by Member Sharpe and the Motion was carried by a vote of 6-0.

PUBLIC COMMENT

There was no public comment.

ACTION ITEMS

Item #3 Decision on the matter of the petition to repeal Section 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, Or Scheduled Maintenance* and replace with a new rule, 20.11.49 NMAC, *Excess Emissions*; to amend 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors*, to correct cross-referencing; and submit the newly adopted 20.11.49 NMAC, and amended 20.11.90 NMAC, and 20.11.65 NMAC to EPA as a revision to the State Implementation Plan (SIP), AQCB Resolution #2009-6.

Chairman Deichmann moved to adopt AQCB Resolution #2009-6 with the following amendments: on page 2 after "NOW, THEREFORE BE IT RESOLVED BY THE BOARD THAT:" amend as follows: "1. Regarding 20.11.49 NMAC, *Excess Emissions*, and 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, or Scheduled Maintenance*, 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors* the Board hereby adopts the new rule to 20.11.49 NMAC, *Excess Emissions*, and repeals 20.11.90.12 NMAC, *Breakdown, Abnormal Operating Conditions, or Scheduled Maintenance*, and amends 20.11.65 NMAC, *Volatile Organic Compounds*, and 20.11.69 NMAC, *Pathological Waste Destructors* as proposed in AQD Exhibits 1a, 1b, and 1c; and 1d, respectively, which were admitted at the September 9, 2009 hearing as amended by 'Staff's Proposed Floor Amendments' shown as AQD Exhibit #14., and 'Supplemental Floor Amendments' shown as AQD Exhibit #16." The motion was seconded by Vice Chair Menache and was carried by a vote of 6-0.

Item # 4 Monthly Air Quality website update – Isreal Tavaréz

Damon Reyes reported on behalf of the AQD Monitoring section that they are working on the Agilaire web application project. The site upgrade was recently postponed pending completion of the official Version 1 release of AirVision, in order to avoid changes in the database that would disrupt the web site deployment. Agilaire has completed AirVision version 1.0 and has upgraded the web site code and tested internally at Agilaire to ensure compatibility with the release database. Agilaire is also ready to assist with the web site installation once the AirVision system is up and running. There will be two systems running in parallel, E-DAS and soon to be AirVision. We have received AirVision1.0 but have not yet installed and tested the software. Mr. Dario Rocha, Environmental Health Supervisor, added that AQD has been working with City of Albuquerque Information Systems Division to create a more “user friendly” format for the website.

Chairman Deichmann would like a demonstration of the improvements to the AQD website later in the year.
