Notice of the Intention to Consider The Adoption of a Rule or Regulation Pertaining to Albuquerque Housing Authority Board of Housing Commissioners

A public hearing will be held on Wednesday, November 20, 2013 at 12:00 p.m. (Noon) in the Manuel Cordova Conference Room, at the Albuquerque Housing Authority (AHA), Administrative Office, in the Carnis Salisbury Building, at 1840 University Blvd SE, Albuquerque, NM 87106 to consider the adoption of a revised edition of the Rules of Conduct for the AHA Board of Housing Commissioners. The public hearing will be held during a portion of the Regular Meeting of the Board of Housing Commissioners for the month of November 2013.

Pursuant to §2-6-1-4-C-a ROA 1994 this Notice of the Intention to Consider the Adoption of Rule or Regulation shall be posted in the lobby of the Albuquerque/Bernalillo County Government Center on the 1st floor at 1 Civic Plaza NW, Albuquerque, NM 87102 and posted electronically on the Albuquerque City Clerk's web site dedicated to the schedule of rulemaking hearings and meetings of public boards, commissions and committees (www.cabq.gov/clerk), and by giving written notice to the Mayor and the Chief Administrative Officer. This notice is provided at least 14 days prior to the hearing at which the proposed rule or regulation will be considered. The hearing, at which the proposed rule or regulation is considered, shall be open to the public and any person may give testimony in favor of or in opposition to the proposed rule or regulation, whether such testimony is given orally or in writing. Any written comments must be submitted to the AHA Executive Director prior to the public hearing, who will then forward the comments to the Board. In considering the proposed rule or regulation, the Board will give due consideration to all testimony.

This hearing is the first hearing of the AHA Board related to the adoption of a revised for 2013 set of Rules of Conduct for the AHA Board of Housing Commissioners.

Currently, the AHA Board follows the Rules of Conduct it adopted in 2011 to govern how it conducts its business. Currently, the AHA Board also generally follows the principles of Robert's Rules of Order, as well as federal law and HUD regulations, as well as state and city law and AHA polices. This Notice and the proposed 2013 revised edition of Rules of Conduct for the AHA Board can be found at http://www.cabq.gov/albuquerque-housing-authority/board-information and/or www.cabq.gov/clerk. Any proposed revisions to the proposed 2013 edition of the Rules, if any, will be posted as they become available. A summary of the major points of the proposed revisions include: allowing for greater amounts of Public Comment and allowing people to speak on non-germane topics, and for a longer period of time, during a portion of Regular Meetings of the AHA Board that are dedicated to listening to Public Comment.
