Instructions for Public Participation for the August 25, 2020 Public Safety Committee meeting

- To provide real time verbal public comment over Zoom, participants must sign up for public comment by 1:00 p.m. on August 25. The sign-up sheet can be accessed at this link: www.cabq.gov/aug-25-2020-psc
- o Note: Participants must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting. Persons who do not provide this information will not be allowed into the meeting, but may still view the meeting via YouTube live: https://youtu.be/IWjr_cbn17o
- Participants will standby in the Zoom virtual waiting room until the Zoom moderator moves them into the meeting.

• Public comment will be limited to 2 minutes or less, depending on the number of speakers signed up. Your time will start when you begin speaking and you will be informed when your time has concluded, at which point your microphone will be muted and your camera will be turned off.
