Any Business that purchases for resale:





What's Required?

- » For each covered item, a business must collect and Retain:
 - > Name, Address & DOB of pledger/seller
 - > A photo of the pledger/seller
 - > A thumbprint from the pledger/seller
 - > A photo of the item and serial number (if available)



How is Compliance Demonstrated?

» Electronic Inspections

- > Relevant Records must be uploaded to Leads Online by the next business day

» On-Premise Inspections

- > Records
 - + 15-day no-sell, no-alter
 - + 30-day hold (only by request after inspection)
- > Merchandise

What happens if you don't comply?

- » Notice of Violation may be issued
- » Administrative Hearing – if requested
- » Possible penalties upon **finding** of violation:
 - > Remedial
 - + Order to show proof of compliance
 - + Order to cease violating conduct
 - > Punitive
 - + Fines – could vary based on number of offenses
 - + Permit Revocation – only for multiple violations within 12 mo. period
