Key Items of Discussion

• Old Business

- A. Data Access update/ACES Evaluations: Brief discussion of difficulties with gaining access to identified data. It has been currently determined that a ROI will be needed in order to receive identified data from clients. The BHI will be exploring a contract for bringing on a national expert to assist with navigating issues with the sharing of data.
- B. Behavioral Health Advisor Update: Organizational structure; assisting with crisis services and identifying the gaps in crisis services; Providing support on the ACEs contracts; assistance with peer based case management; MCO outreach

 C. Status of Behavioral Health Proposals and RFP's: Supportive housing- Continuing to navigate single site model. Currently working on mission statement in order to guide process.

Prevention: Last committee meeting members heard from ACES providers. Community Supports: Early discussion on case management with a utilization of peers to provide the service. Focusing on a strengths based model combined with a peer based model in order to provide a strong support to connect clients to their needs. A suggestion was made to scale back the prescriptive nature and broaden the proposal to allow for a more problem based model.

Crisis: Met this week had a discussion on crisis continuum and further exploring gaps in the crisis system.

• New Business

- A. Rethink Health, Discussion of the Social Determinants and How Behavioral Health is Part of a Bigger System: Beginning discussion related to making sure that the behavioral health plays a role in the larger picture of general health and wellness. How do the social determinants of health impact behavioral health concerns of clients?
- **B.** Review of Proposals: Teaching Training and Education- Concern brought by Jim about further addressing "employers" as a specific target population. Further discussion on budget as well as the question of sustainability. Decision was made to take this proposal back to the prevention committee for clarification.
- **Public comment:** Committee notified of closure of St. Josephs Center. Concern for clients who are receiving services. Working to develop the Hopkins Center and partnering with Centro Savila.
