1 RESOLUTION

2 ESTABLISHING THE AD HOC POLICE OVERSIGHT TASK FORCE; NAMING
3 MEMBERS.

4 WHEREAS, the Police Oversight ordinance requires periodic
5 evaluations so as to *“undertake a complete evaluation and analysis of the*
6 *entire Police Oversight Process, and recommend any necessary changes or*
7 *amendments that would appropriately improve the process.” §9-4-1-11 ROA*
8 *1994; and*

9 WHEREAS, the City Council believes that the creation of a Police Oversight
10 Task Force is an appropriate first step in bringing expertise to bear on the
11 review of the police oversight process; and

12 WHEREAS, the City Council recently passed F/S R-13-143 which creates an
13 11-person ad hoc Police Oversight Task Force with membership that should
14 reflect the community and include 5 members of the community at large, a
15 retired APD officer, and members with experience in investigation or
16 prosecution, in non-profit/community groups, in civil liberties, in
17 governmental efficiency; and

18 WHEREAS, the City recently solicited applications from community
19 members who would be interested in and qualified to serve on the Task Force;
20 and

21 WHEREAS, the City received 115 applications from individuals requesting
22 to be selected as members of the Task Force; and

23 WHEREAS, staff has evaluated and recommended to the City Council the
24 following 11 individuals to serve on the Task Force; and
