- V. **Follow Up:**
 - a. **Debrief on CNM Presentation – Dr. Lisa Orick-Martinez**
Member Orick-Martinez debriefed the Subcommittee on the presentation provided by Ms. Amanda Bustos on April 11, 2017 at CNM Montoya Campus.
 - b. **CPOA office Updates – Amanda Bustos.** Ms. Bustos discussed the following topics:
 1. The POB/CPOA is invited to do a presentation for 3 to 5 minutes to the Albuquerque Area Community Engagement Fair on Saturday, May 20, 2017 from 1:00 p.m. to 4 p.m. at Tractor Brewing Wells Park. The fair is hosted by Bees + Seeds Festival.
 2. Ms. Bustos will be emailing some information to the Subcommittee members by Tuesday, May 2, 2017 regarding the Community Outreach's goals and objectives.

3. Ms. Bustos and Director Harness will no longer be attending the Community Policing Council meetings on a regular basis. However, the CPOA will be available to the CPC's if they have questions.

VI. Discussion on Outreach Efforts – POB Chair Joanne Fine

- a. POB Chair Joanne Fine suggested that the Community Outreach Subcommittee focus on Albuquerque and the following topics were discussed:
 1. That the committee establishes a presence at events located at Albuquerque community centers in order that people can come and speak their minds about what is happening in their communities.
 2. Compiling evaluations for feedback.
 3. Make the presentation a conversation such as the method Ms. Bustos used at the CNM presentation.
- b. Since the Airport Police are under the umbrella of APD, they are now requesting complaint forms, brochures and posters to be posted at the Airport.
- c. Clarified for several citizens who came to the Subcommittee meeting how the POB and the subcommittees operate and when they have the meetings.
- d. Discussed that Animal Control is not part of APD. However, if a citizen wanted to file a complaint against an Animal Control officer, the citizen would have to contact the Animal Control department.
- e. Ms. Bustos stated that the data for where complaints are coming from are trackable, but will not be able to compile the data until the CPOA gets a data analyst.
- f. Per the Settlement Agreement, all complaints are located at the community centers, police substations, and libraries and these locations are just a starting point. In addition, there are other city resources such as senior centers and hospitals where they can post complaints and brochures.
- g. A citizen discussed her concerns about the Albuquerque Journal's article regarding APD's negative posts on Facebook.
- h. Ms. Bustos clarified that we do receive comments from the public who are not filing complaints but are topics that the POB can discuss at their meetings.
- i. Discussed that citizens submit job well done reports for officers who are doing good in the city to the CPOA office and they are also posted on the website.
- j. Discussed the Ms. Bustos "talking stick" presentation method for future outreach subcommittee meetings.
- k. **Action items:**
 1. Ms. Bustos will email community center contact sheet to each subcommittee member (See attachment "A")
 2. Ms. Bustos to send the subcommittee members the goals and objectives.

3. Member Armijo will set up a meeting with the Director and Deputy Director of the City of Albuquerque community centers to let them know that the POB Community Outreach Subcommittee will be inquiring with each community center supervisor in order to organize meetings at those particular community center sites.

l. Member Armijo will speak with the manager of West Side Community Center of Bernalillo County to clarify the possibility of the committee meeting there.

VII. Other business.

a. Member Armijo would like to see the CPOA/POB included in APD's outreach presentation.

b. Ms. Bustos gave her business card to the citizen so she can contact her to discuss her concerns about APD's Public Information Officers.


VIII. Next Meeting. The next meeting of the Community Outreach Subcommittee meeting will be held on Monday, May 22, 2017 at 5 p.m.


