INTRODUCTION

This document contains a detailed inventory of revenues received by the City's General Fund. This document is an update of a May, 1994 publication, City of Albuquerque General Fund Revenue Sources. It provides documentation on all recurring General Fund revenue sources, including inter-fund transfers. The entries are generally arranged by revenue account number.

A typical entry for a revenue source includes the following: the revenue account number; the authority under which a fee or tax is imposed or a revenue producing activity is pursued; a description of the revenue source; a statement indicating the rationale or purpose behind the revenue source; a current schedule of fees or charges; a summary of changes in the schedule of charges or other events affecting the flow of revenues to the account; information on participation or activity levels; and the dollar amounts of revenues generated over the past several years or since the revenue source was first introduced.

Information contained in this document was compiled from a variety of sources, including enacted ordinances, joint powers agreements, State statutes, as well as from interviews with responsible City personnel. Prior to final editing, the entries for fees and charges were sent to the responsible departments for their review. While efforts have been made to establish the accuracy of the information contained in this document, the sheer volume of the information and the time constraint on labor hours suggest the likelihood of some errors and omissions. The user needs to be aware that some of the entries in this document will be outdated even as the document goes to press because departments continually review and revise charges, enter into new agreements, etc.

It is our intention to periodically provide updates of the material in sections of this document. We would appreciate any help the reader might give us regarding new revenue sources, changes in fee schedules, or other corrections that need to be made in the information contained in this document.
