POLICIES AND PROCEDURES

It is our goal to provide a fun and safe environment for all those attending MerryMakers.

We can only do that by everyone following a few simple rules.

- I. MerryMakers is not a "drop off" program for individuals requiring individualized attention. **STAFF FROM GROUP HOMES OR PARENTS/GUARDIANS MUST REMAIN WITH THE PERSON(S) YOU ARE RESPONSIBLE FOR.** (*Note: This is not a time for any staff to take breaks. We need the support of everyone to ensure safety.*)
- II. **All participants must be registered and all information kept current.**
- III. Areas outside the parameters of the community center (unless scheduled in the calendar) will not be supervised by "City" staff. Please monitor the individuals you bring to the program.
- IV. Inappropriate language and/or activities will not be tolerated. We reserve the right to suspend participants who are creating an unsafe situation for themselves or other participants.
- V. The program ends at 9:00 PM. Please be prompt in picking up individuals who are counting on you.
- VI. If someone is having a difficult time, please remove them from the program.
- VII. Smoking is permitted outside the community center grounds only! Smokers must be beyond the front wall. **Smoking is not permitted in the courtyard or outside any side-entry doors.**

You can expect us to make every effort to offer a safe and fun program. Your failure to follow these rules will result in disciplinary action. The program is growing and we are looking at ways to make it better. Feedback is always welcome. Also, if there are new staff members in your group home, please share these rules with them.
