- IV. MCB REPORT-** *Battalion Chief Chris Ortiz* gave the report due to Dr. Pruett's absence. He mentioned the changes/deletions and updates to the EMS Guidelines. - VI. AFR/BCFD Reports:** *Battalion Chief Chris Ortiz* from AFR mentioned the purchase of PALS Kits (CertaDose). They are single dose units that cost about \$250.00 with a shelf life of 5 years. AFR is going to a smaller Trauma Bags due o back injuries. *Michael Cross & Shawn Williams* from Bernalillo County Fire mentioned structure fire staging areas and the use of 12 leads.
- VII. AAS/SAS/AMR/SNL/PHI/LIFEGUARD REPORTS:** *David Chapek* from Albuquerque Ambulance mentioned the Ketamine update and Toradol coming in March. *Kelly Garvin* from Sandia Laboratory introduced Dr. Claire Escamilla there new Medical Director. Dr. Escamilla stated that she started at Sandia on November 4, 2019. She is Sandia's 1st medically trained EMS Director. So far she has been doing fact finding and getting things recertified that have lapsed. She came from Texas with Emergency Room and Trauma 1 experience. Sandia will now be following the guidelines that Medical Control Board has created. *James Allday* from Lifeguard had nothing to report. He did however mention a call that they serviced.
