**1. Greetings and Introductions**

- Kelli Murtagh opened the meeting and introduced Jim DeAngelo as a contractor with URS to assist Bernalillo County and the City of Albuquerque in completion of the plan update, offered the floor to Fred Hogan who echoed Kelli's welcome.
- J. DeAngelo briefly introduced himself and reviewed the purpose of the meeting and encouraged attendees to participate.
- Kelli Murtagh then asked for introductions of all participants
- J. DeAngelo then introduced Lawrence Frank who continued the slides and worked through the presentation. Topics included a review of the plan development, the summary of the risk assessment, explanation of the capability assessment, and description of the Mitigation action summary. The group then completed a handout which included the current plan actions for the identified hazards of high and moderate risk which allowed the attendees to comment on, revise and add to the list of specific mitigation actions identified in the planning process. The presentation closed with a review of next steps and a reminder to get final plan comments to Kelli Murtagh by September 7<sup>th</sup> 2014.
- During the presentation the following items were brought up by attendees:
  - The City of Albuquerque completed a THIRA, it will be included if provided to J. DeAngelo
  - There have been damages in the past due to collapsible soils, check into the NRCS report
  - If new specific actions are identified by the group during the comment period they should be sent to J. DeAngelo or K. Murtagh and will be incorporated if applicable.
  - Projects do not need to be shovel ready; this is more of a long term planning process.
  - Please update the project list if the project is already completed or underway.
  - An arroyo flood warning system has been completed and should be added, F. Hogan will provide information related to it to J. DeAngelo
  - URS is looking for specific comments. If you want a MS Word version please contact J. DeAngelo.
  - A public meeting was set up and conducted following the planning committee meeting on 8.21.14, in the same room as the planning committee meeting.
- L. Frank collected the completed worksheets and asked any outstanding worksheets to be submitted to K. Murtagh by 9.7.14. This is also the deadline for public comments.
- The timeline and next steps were reviewed with the group. Once the comments are collected, a final draft will be compiled and transmitted to the State and FEMA for review. The review process could take several months.
