RATIONALE:

The Monitor's previous reports did not give credit to the Northeast CPC for having made recommendations in 2015, even though these were posted online in the minutes.

We submitted three recommendations to the Chief in 2015; at that time there was not a standardized form for submittal nor a clear tracking procedure for the response process.

We are therefore re-submitting "A Recommendation to Convene A Gathering of All the Six Area Command Community Policing Council Members", which we passed in our July 14, 2015, public meeting. We are also attaching the July 14, 2015, meeting minutes that record its passage and original submittal.

While we have been aware that APD subsequently acted on this Recommendation by scheduling a get-acquainted and training session in September 2015, facilitated by Celina Espinoza, we are requesting official response using the recently adopted schedule and format, so that the Independent Monitor and his auditor, Steve Rickman, will have an auditable account for our CPC.

We as members of one Community Policing Council would like to meet and talk to our counterparts who have been serving with the other area commands, as a way to find out what other recommendations have already been made and to assess how we and the City and the Albuquerque Police Department feel we are doing in fulfilling our job descriptions as set out in the DOJ Settlement Agreement, paragraphs 266 through 270.

While such a collective gathering, or retreat, of all the Community Policing Councils is not mandated by the DOJ Settlement Agreement, neither is it prohibited. In the context of such a gathering there would be no intent to discuss or vote on future policies, actions, or recommendations.

We believe such a gathering would enhance communication among the six Community Policing Councils, which would help each council be better equipped to do their fivefold tasks (as spelled out in DOJ Agreement paragraph 269).
