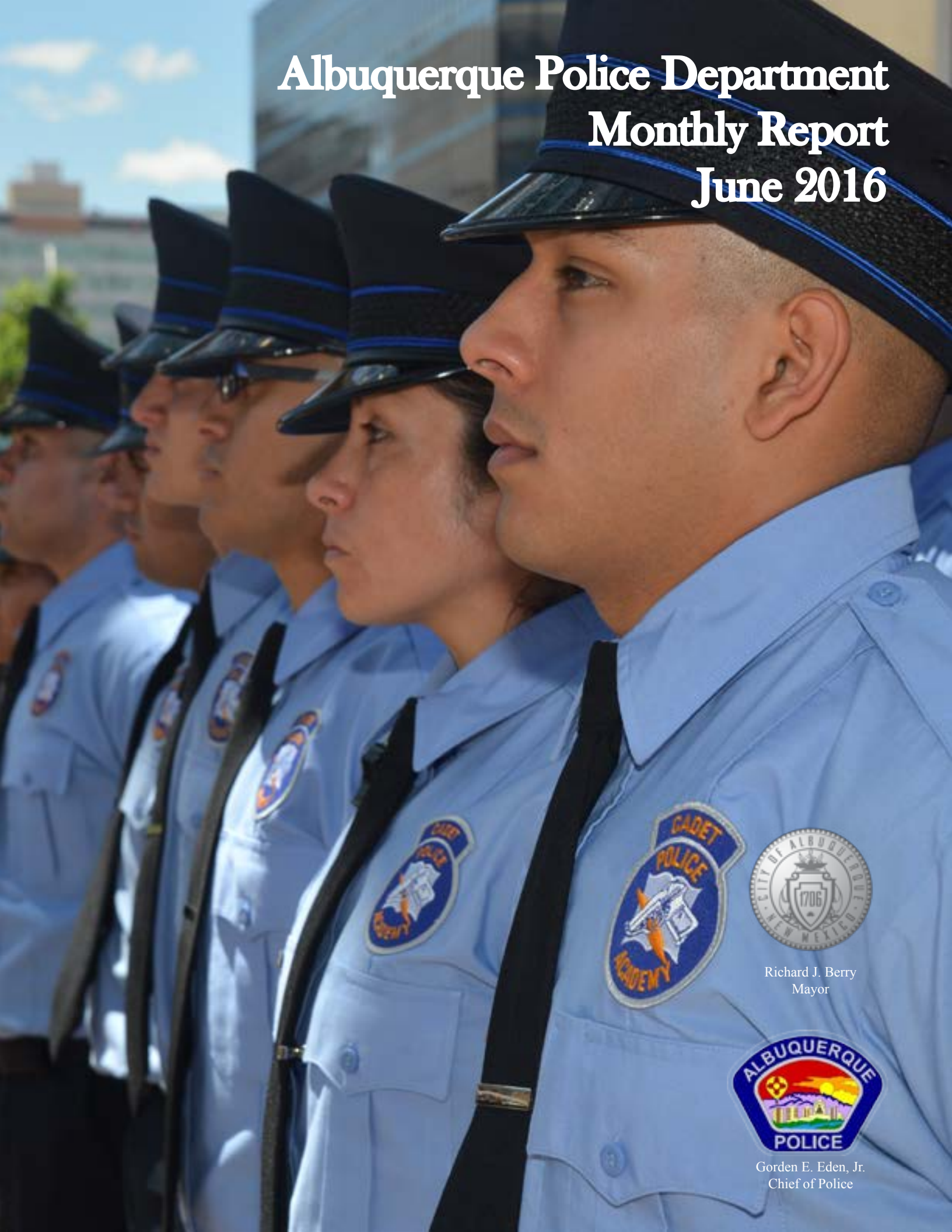

FIELD SERVICES BUREAU-EAST

Southeast Area Command...

- In June, the Southeast Area Command had 12,026 calls for service, wrote 2,365 reports and issued 445 citations. There were 227 felony arrests/warrants, 236 misdemeanor arrests/warrants and 34 driving while intoxicated (DWI) arrests. Seven community meetings were attended.
- On June 2, Officer J. Mares and Recruit Officer H. Mehus responded to a stabbing. Upon arrival, contact was made with the victim who had received several lacerations to his stomach from a broken beer bottle. He explained his girlfriend's friend was at his home and began arguing that he stole money from her. He told her to leave and the argument escalated. She armed herself with a broken beer bottle and used it to strike him in the stomach. She was located and arrested for aggravated battery with a deadly weapon.
- On June 12, Officer B. Daffron located a vehicle in a parking lot that was identified as stolen. A high risk stop was conducted and numerous individuals within the vehicle were taken into custody. A handgun was found near the driver and it was discovered he was a convicted felon. The passenger had her purse directly in front of her at the time of the stop. A syringe loaded with heroin was located on top of the purse. The driver was booked into the Metropolitan Detention Center (MDC) for receiving/transferring a stolen vehicle as well as being a felon in possession of a firearm. The passenger was arrested for possession of a controlled substance.
- On June 12, Officer R. Casaus was tending to a down-and-out female subject. As he was helping load the subject into the back of an ambulance, an individual approached Officer Casaus yelling he was going to kill her. Officer Casaus was barricaded in the ambulance and requested assistance immediately. The suspect smashed the passenger window of Officer Casaus' police unit with a large rock and took off running. The suspect was located near the area and a standoff with police began. Eventually, the subject was safely taken into custody and was arrested for assault on a police officer and criminal damage to property.
- On June 13, Officer J. Malecki and Recruit Officer Rubio-Gonzalez observed two males in a physical altercation in the middle of the road. As officers stopped at the scene, one of the males approached them with his fists balled and yelled at them. The officers gave commands to stop. The subject turned around and went to a nearby parking lot. The officers caught up with the suspect and conducted a pat down. The suspect began resisting but officers were able to handcuff him and put him in the police vehicle. As Officer Malecki was fastening the offender's seatbelt, he reared his head back and thrust forward, head butting Officer Malecki. The offender was booked into the Metropolitan Detention Center (MDC) for battery on a police officer.
- On June 20, officers responded to an armed robbery where a bicycle was stolen at gun point. Officers arrived and stopped a vehicle matching the description given by the victim. The two subjects in the vehicle ran at the time of the stop. Officers R. Casaus and D. Small gave chase while Officer Yuricson stayed with the vehicle. The robbery offender was caught and a gun was located near him. A perimeter was established and the second offender was located. The victim stated the two males approached him, pointed a gun at him, and took his bike after striking him with the gun. Both offenders were arrested and booked for armed robbery. The bicycle was returned to the owner.
- On June 2, Officer A. Quillman made two felony arrests after locating a male and female breaking into a vehicle.
- In June, Officer A. Quillman recovered five stolen vehicles.
- On June 19, Sergeant R. Barraza and Officers M. Groff and J. Montoya gave out bicycle helmets to children ages 3-12, and provided bicycle road safety tips to children at the South Los Altos Neighborhood Association.
- On June 8, officers were dispatched to a male subject who had gained entry into a residence by breaking the screen and entering. The resident was home at the time of the break-in and noticed the male subject was naked. The male ran out of the residence and later gained entry into a vacant home three houses from where the original crime took place. Officers were conducting an area search when they noticed the male hiding inside the residence. The male barricaded himself inside a closet. A perimeter was established and a K-9 unit assisted in extracting the subject from the residence. The subject was later booked into the Metropolitan Detention Center (MDC).
- On June 17, Field Training Officer Carlson and

Recruit Officer Zaleski were dispatched to a suspicious person call where two males, one with a shopping cart, were utilizing an unknown type of illegal narcotic. Upon arrival, officers located two individuals matching the description and made contact with them. Both subjects agreed to a pat-down and one was found to be in possession of possible illegal narcotics. The substance was field-tested and provided a presumptive positive for methamphetamine. A search prior to arrest also revealed the subject was in possession of a loaded firearm. Further investigation of his criminal history showed he had prior convictions in the county for felony crimes. He was booked on possession of a controlled substance and a felon in possession of a firearm.

- On June 14, Officers A. Suarez and W. Thomas were dispatched to a robbery call at a local grocery store. Officers were advised that a male had concealed alcohol in his backpack. Officers contacted the subject and advised him that he was observed stealing and he needed to leave the store. The male proceeded to cuss at officers and then punched Officer Suarez. The male was arrested for battery on a police officer and was found to be in possession of a narcotic.

Northeast Area Command...

- In June, the Northeast Area Command had 9,630 calls for service, wrote 1,969 reports and issued 642 citations. There were 129 felony arrests, 253 misdemeanor arrests, 15 driving while intoxicated (DWI) arrests and 117 felony and misdemeanor warrants issued. Eighteen community meetings were attended.
- On June 29, Officer R. Garnard was on his way home from his day shift when he observed a stalled vehicle. He stopped and helped a good-samaritan safely push the vehicle through the intersection. The female driver was out of gas and had no way of obtaining fuel. Officer Garnard went to the gas station across the street, bought a gas can, filled it with gas and gave it to the driver.
- On June 12, Officers J. Lopez-Shook and S. Drobik responded to a domestic violence call where the offender had been sending lewd photos via phones to the victim's family including her fourteen-year-old son. Officers attempted to contact the offender for the felony crime but were unsuccessful. Officer J. Lopez-Shook completed a warrant for his arrest and by the end of the week the offender was

apprehended.

- On June 11, officers were dispatched to a residential burglary. Upon arrival, they made contact with a subject matching the description provided by witnesses. Through further investigation, they determined the subject had broke into one of the apartments by kicking in the front door. The subject who was uncooperative with officers had to be transported to the hospital after admitting that he ingested 20 pills of a narcotic.
- On June 13, officers were dispatched to a call advising a victim had located her stolen vehicle occupied by two suspects. Upon arrival, officers were successful in taking the two suspects into custody without incident. Auto Theft detectives were notified and responded for further investigation.
- On June 14, Officer V. Varela was dispatched to an accident with injuries involving a vehicle that was stolen during an armed carjacking. Two male subjects fled the scene while pointing a firearm at bystanders. The two subjects were contained inside a perimeter and taken into custody without incident. Robbery detectives were notified and responded booking both subjects.
- In June, Detective C. Baker assisted Officer H. Chavez with a domestic violence case. The boyfriend of the victim beat and choked her until she was unconscious. Officer Chavez had very little information regarding the suspect. Detective C. Baker identified the offender and he was located and taken into custody. Detective C. Baker interviewed the offender and drafted an arrest warrant for him. The offender was booked, and the case was completed.
- In June, Officer J. Lucero investigated a felony domestic violence call. The victim was intentionally run over by the suspect. Officer Lucero obtained an arrest warrant for the suspect on the charges of attempted murder and aggravated battery against a household member resulting in great bodily harm. The Northeast Impact Team took the subject into custody without incident after receiving a tip on his location. The suspect was indicted on the listed charges.
- In June, Detective L. Neil was called to a shooting. After the offender was taken into custody, he smuggled multiple amounts of narcotics into the Metropolitan Detention Center (MDC) in his rectal cavity. Detective Neil charged the offender with trafficking

- Detective J. Carter arrested and charged a subject with 313 felony counts of embezzlement, fraud, forgery, racketeering, conspiracy, and insurance fraud. The suspect, a former law enforcement officer was arrested at his probation officer's office. The suspect confessed to Detective Carter that he took \$150,000. The suspect was booked on his warrant and remains in custody.
- On June 1, Officer E. Keiper was dispatched to a store regarding the theft of merchandise totaling over \$2,000. The store manager provided a still photograph and the license plate of the subject who took the merchandise. Officer Keiper located the subject in the Foothills Area Command. The subject was taken into custody without incident. It was later determined the subject was the alleged offender in several other felony larcenies.
- On June 16, Officer D. Sprague was dispatched to two males in a physical dispute. One of the males fled the scene prior to officers' arrival. It was determined that this male struck the other male with a crowbar. The alleged victim sustained a large laceration to his head and a black eye. Officer Sprague conducted an intensive investigation using police databases and determined the alleged offender's last known address which was in the Bernalillo County Sheriff's Office (BCSO) jurisdiction. Officer Sprague enlisted the help of BCSO who found the alleged offender at the address. Officer Sprague took the offender into custody without incident. It was later determined this offender was suspected of sending several threatening messages to kill his former wife. The information was turned over to the Family Abuse Stalking/Training Team (FASTT) for further investigation regarding felony domestic violence charges.

Foothills Area Command...

- In June, the Foothills Area Command had 6,415 calls for service, wrote 1,223 reports and issued 535 citations. There were 76 felony arrests, 60 misdemeanor arrests and 18 driving while intoxicated (DWI) arrests. One community meeting was attended.
- On June 26, Officers S. Thompson and T. Schmelzer were dispatched to a battery call. Remarks on the call stated an unknown male walked into an apartment and started hitting the caller's roommate for no reason. Upon arrival, officers made contact with the victim.

He stated a male knocked on his door and asked for water. The victim closed the door but didn't lock it when he went to get water. The male entered without permission and began to strike the victim with an unknown object. He then left on foot. While attempting to locate the suspect, Officer Thompson saw a male at a nearby bus stop who matched the description. The victim identified the male as the intruder. He was arrested and was charged with breaking and entering.

- On June 19, Foothills Area Command officers were dispatched to a parking lot where Special Investigation Division (SID) detectives had a subject boxed in his vehicle. The ordeal lasted for six and a half hours. Eventually, the suspect was taken into custody and arrested on a warrant for a bomb scare.
- On June 23, Foothills Impact Detective D. Sanchez responded to a shooting call. Upon arrival, Detective Sanchez observed a large amount of blood on the sidewalk near an apartment. The security door to the apartment was propped open by a backpack. Next to the backpack was a large fixed blade knife and metal bat. The front door to the residence was also open. A window adjacent to the front door was broken, a screen in the window was torn and the barrel of a shotgun was pointing partially out of the window. During the investigation, it was determined that a male gained entry into the residence armed with a shotgun, fixed blade knife and metal bat and threatened the occupants. The homeowner shot the suspect while protecting the occupants of the residence. Detective Sanchez arrested the suspect on the charge of aggravated burglary.
- On June 10, Officers Render and Huston investigated what started out as a traffic crash but evolved into a shooting investigation. During the investigation, it was discovered the vehicle had been stolen and was fleeing the area. The vehicle ran a red light hitting four other vehicles. The driver and passenger fled on foot. Officer Render located the suspects and took them into custody. Through further investigation it was learned that the driver had shot into a motel and stole his girlfriend's car.
- On June 24, Officer Calt and his Recruit Officer located an extremely intoxicated female who was having difficulty walking. They learned she had a four-month-old infant in a stroller nearby and was clearly unable to care of the child. Officers attempted numerous phone numbers

to contact a family member to take custody of the child with no results. Officer Calt contacted the Children, Youth and Families Department (CYFD) and the child was placed on a 48 hour hold.

- On June 11, Officer Shultz was dispatched to a traffic accident where a vehicle crashed into a yard of a house and the driver fled on foot. The vehicle came back as stolen. Officers eventually located the driver. The vehicle was also being sought by Rio Rancho Police due to it having dropped off a shooting victim at Rust Medical Hospital. The vehicle was related to a residential robbery in Rio Rancho. The driver confessed to being the driver of the stolen vehicle and was arrested.
- On June 19, Officer C. Shultz was dispatched to a welfare check where the caller believed her friend was being beaten by her husband and had no contact with her in several days. Upon arrival, Officer Shultz contacted the female and male. The male subject told officers the female was okay and they did not need police assistance. Officer Shultz determined the female was not okay and continued his investigation. Upon speaking with the female further, she disclosed that her husband had been beating her for several days and would not let her leave the home for five days. The male was arrested for domestic violence, battery on a household member and false imprisonment.
- On June 5, Officer N. Elsmann was dispatched to a priority one disturbance call. While in route, dispatch advised that a male was throwing a female around inside the apartment. Upon arrival, Officer B. Knipprath could hear a female yelling "get off me". After several unanswered knocks at the door and the fight sounding like it was escalating, the officers decided they had to force entry. When Officer Knipprath attempted to gain entry, a male opened the front door. Officers cleared the residence and found a female who had locked herself inside the bathroom. Officer Elsmann learned through his investigation that the two occupants were in a domestic argument that turned physical. During the physical confrontation, the female attempted to leave the apartment but the male would not let her out of the bathroom and physically battered her. The suspect was arrested for false imprisonment, domestic violence, and battery on a household member.
- In June, Officer Scott Harmon was awarded with a certificate from the National Alliance

for Mental Illness (NAMI) for rescuing a male subject attempting to commit suicide by running a vehicle in his garage. The male was located unresponsive in the vehicle and had to be dragged to the street due to extreme fumes and heat in the garage. Rescue arrived and transported the subject. Officer Harmon also included Officer Render in the acceptance as he was his back-up officer.

FIELD SERVICES BUREAU-WEST Valley Area Command...

- In June, the Valley Area Command had 8,052 calls for service, wrote 1,450 reports and issued 522 citations. There were 104 felony arrests, 147 misdemeanor arrests and 21 driving while intoxicated (DWI) arrests. Fifteen community meetings were attended.
- On June 15, Officer J. Lee was dispatched to a suspicious subject. Upon arrival, Officer Lee located a vehicle in the parking lot of a park and observed a male subject sleeping inside. A check of the license plate revealed the vehicle was stolen. Contact was made with the subject and as he exited the vehicle a small clear plastic bag fell out of the car which contained several shards of a crystal like substance. The contents tested presumptive positive for crystal methamphetamine. The subject was taken into custody and booked on various felony charges.
- On June 16, Team 8 officers were assigned to the Downtown Entertainment District when they were flagged down in response to a stabbing that had just occurred. Officers immediately began first aid on the victim who was bleeding profusely. They secured the scene and identified witnesses. Officers S. Molina and J. Wolffbrandt made contact with one witness who provided a detailed description of the offender and a last known direction of travel. Officers located the offender and took him into custody without incident. The knife used in the stabbing was found hidden on the subject.
- On June 2, Officer D. Shrouf responded to a disturbance at a local pharmacy. Upon arrival, he contacted a male who had needles and other drug paraphernalia on his person. A warrant check found an outstanding misdemeanor warrant for his arrest. He was searched and arrested for the outstanding warrant. During the search, a large amount of narcotics was located. He was booked for the outstanding warrant and felony narcotics.
- On June 25, Officers J. Clemons, while working

the downtown tactical operation, observed a male who matched the description of a person reportedly selling drugs according to a citizen's tip. Officer Clemons made contact with the male and found the subject had needles on him. Permission to search was obtained and five Oxycodone pills were located on the subject. During the interview, the suspect admitted to trying to sell the Oxycodone to bar patrons downtown. He was arrested on possession of a controlled substance and trafficking a controlled substance

- On June 26, Officers J. Clemons, J. Bowe and J. Chafin responded to a priority one domestic violence call in which a male was armed with a handgun. As officers approach the male, he exited the house holding a handgun in his hand. After a tense ten minute standoff, officers talked him into dropping the firearm and surrendering to officers. The suspect was detained and after it was confirmed there were no domestic violence related charges, he was transported to the University of New Mexico Hospital for a mental health evaluation.
- From June 16 - 19, Officer J. Lee conducted a tactical plan at a convenience store due to a recent spike of criminal activity. This tactical plan was conducted to reduce various problems occurring in the area including theft, loitering and stolen vehicles. During the course of the tactical plan, Officer Lee located two stolen vehicles, responded to an armed robbery and wrote three reports. Officer Lee has continued contact with the night clerks and advised he will maintain a periodic watch on the business in an attempt to deter crime.
- On June 24, Officer C. Daniel conducted a driving while intoxicated (DWI) tactical plan throughout the Downtown District. The goal of the tactical plan was aimed at reducing drunk drivers, as well as alcohol related accidents. During the course of his patrol Officer Daniel stopped one vehicle, issued two citations, made a DWI arrest and had the vehicle towed.
- In June, Team 9 conducted a traffic tactical plan at the five points most frequented by the individuals participating in illegal street racing. During the operation, officers worked on Friday and Sunday nights to curb street racers by conducting traffic stops and handling numerous calls for service involving an unruly crowd of individuals which surpasses 200 vehicles on most occasions.
- In June, Sergeant T. Apodaca received a letter of

commendation through his chain of command for the response and supervision of a call for service that took place in March 2016.

- In June, Sergeant N. Wheeler received a letter of commendation from his chain of command for his location of a stolen vehicle and the apprehension of the offender in April 2016.
- On June 14, Valley Officers assisted Northeast Area Command officers in locating two armed carjacking suspects who wrecked a stolen vehicle and fled on foot. A perimeter was established and both offenders were taken into custody. A firearm, believed to be used in the carjacking, was located discarded just south of the perimeter.
- On June 28, officers responded to a male subject armed with a handgun, yelling and creating a disturbance. Officers learned the suspect was a guest at a hotel. When officers located the suspect, he was found to have a gun in his waistband. He was arrested without incident. A truck reported stolen/embezzled was located in the parking lot and returned to the company.
- On June 30, officers responded to an individual threatening neighbors with a firearm. A perimeter was established and the suspect was taken into custody without further incident. The subject was subsequently charged with aggravated assault with a deadly weapon and child abuse/endangerment.

Southwest Area Command...

- In June, the Southwest Area Command had 6,157 calls for service, wrote 1,202 reports and issued 684 citations. There were 92 felony arrests, 75 misdemeanor arrests, and 24 driving while intoxicated (DWI) arrests. Five community meetings were attended.
- In June, Team 8 officers conducted a tactical plan in an area with increased gang activity. Officers responded to calls in the area, including one where a stray bullet struck a vehicle and shattered the glass injuring a child. Numerous graffiti referrals were made and a stolen vehicle was located but fled from officers.
- On June 27, officers responded to a local motel in response to a disturbance call. Upon arrival, Officer Luchetti located a male looking into the windows of several vehicles. Officer Luchetti contacted the subject and identified him. The male was found to have two felony warrants for aggravated battery and strong-arm robbery. He also had a misdemeanor warrant.
- On June 13, officers responded to a local

motel for a vehicle recovery. Officer A. Lee made contact with the owner of the vehicle, who stated her daughter and boyfriend took the vehicle without permission a month prior. Officer Lee made contact with a male and female inside the vehicle and identified them. The male in the driver seat was found to have two felony warrants and was on probation. After searching his person, he was found to be in possession of narcotics. The male was arrested and his probation officer was contacted and his probation was revoked.

- On June 28, Officer J. Garcia located a robbery offender's vehicle. He initiated a traffic stop and with the assistance of additional officers detained the driver until a positive identification was made. The driver was later identified as the individual who had been involved in two armed robberies earlier on this date. He was interviewed by robbery detectives, arrested and booked into the Metropolitan Detention Center (MDC).
- On June 3, Officer J. Garcia stopped a suspicious subject who was hiding in a yard. He was later identified and found to be in possession of stolen property. The stolen property included a ballistic vest which the suspect was wearing. It was learned the ballistic vest along with the other stolen property belonged to a New Mexico State Game and Fish Officer. The property had been stolen from his unit that same day. The investigation was turned over to the New Mexico State Police.
- On June 10, Officer A. Michaud responded to assist Officer R. Graves on a call. The call stated the owner of the residence wanted two male subjects that were currently inside the residence removed. When officers made contact with the subjects, they were found hiding in the bathroom. One male subject took off running from the residence and backup officers ran after him. During the chase, the male battered three of the officers. The subject was eventually caught and taken into custody. Both males were found to have felony warrants. During the investigation, officers learned both male subjects dismantled a firearm and hid it in a towel under the bathroom sink.
- On June 23, Officer C. Romero was dispatched to a store in response to a male subject attempting to steal a vehicle in the parking lot. A witness reported they observed a red truck circling the parking lot. The truck dropped off a subject and he was attempting to steal a vehicle

when officers arrived. Both subjects were arrested; one for stealing the vehicle and the other for an outstanding warrant.

- On June 30, Officers C. Chavez and A. Michaud were dispatched to a burglary call. Upon arrival, both officers made contact with two subjects who were sleeping inside an abandoned residence. The male was arrested for a felony and misdemeanor warrant. The female was arrested for a felony warrant.
- In June, Officer A. Michaud conducted a traffic tactical plan near an elementary school. He patrolled the school zone and monitored traffic. As a result of his tactical plan, Officer Michaud issued four moving citations.
- On June 18, Officers R. Graves, T. Nadas and A. Zwicky were dispatched to a domestic violence call where a suspect was violating a restraining order. Contact was made at the residence and the subject exited the residence with a knife in his hand and approached officers. Officers managed to get the subject to put the knife down. When officers were attempting to put him in handcuffs, he began fighting. During the struggle, the suspect called for his pit bull to attack officers. Officers Nadas and Graves were both bit by the dog as they were taking the subject into custody. The suspect was arrested and charged for violating a restraining order and aggravated battery on a police officer. Officers were cleared by medical staff at Presbyterian Hospital.

Northwest Area Command...

- In June, the Northwest Area Command had 5,652 calls for service, wrote 986 reports and issued 619 citations. There were 48 felony arrests, 89 misdemeanor arrests, 10 driving while intoxicated (DWI) arrests and 77 felony and misdemeanor warrants issued. Two community meetings were attended.
- On June 23, Officer R. Perea was dispatched to a disturbance call. The comments stated the caller's son was breaking into her residence. The caller advised her son did not have permission to be at her residence. Officer Perea arrived on scene and arrested the offender for felony breaking and entering charges.
- On June 20, Officer E. Wilensky responded to a suspicious person call. He arrived on scene to find a male sleeping inside a vehicle in the passenger side. The officer made contact with the subject and he told the officer that he was over at a friend's house, but was kicked out before nightfall. The subject was homeless and

was living out of his vehicle. Officer Wilensky asked the subject if he had any weapons on him. He stated no but he had needles and a substance resembling heroin in his pocket. The substance tested presumptive positive for heroin. The subject was arrested for possession of the heroin. He was transported to Metropolitan Detention Center where he was booked and processed.

- In June, Officer R. Rodriquez responded to a runaway juvenile. Officer Rodriquez made contact with the mother of the runaway and obtained a possible location where the juvenile may be located. Officer Rodriquez located the runaway and discovered there may be possible abuse in the mother's home. Officer Rodriquez ensured the safety of the juvenile and referred the case to the Children, Youth, and Families Department (CYFD) for follow-up investigation.
- In June, Officer C. Harp conducted a tactical plan in an area where speeding was becoming an issue for the residents. Officer Harp conducted radar and issued five citations for speeding
- On June 22, Officer Holmes and Recruit Officer Martinez responded to a larceny call when they observed a white truck parked near their location. Two suspicious persons exited the vehicle and went to a nearby apartment. Officer Holmes obtained the plate information and found the truck to be stolen. Officers made contact with the female passenger of the truck who told officers that the truck was stolen. Officers made contact with the driver of the truck and he admitted to knowing the truck was stolen. The male subject was arrested without incident.
- On June 19, Officer Hoisington and his Recruit Officer were dispatched to a suspicious vehicle. The call stated that someone drove up in a vehicle, took the license plate off another vehicle in the parking lot and left in another vehicle. Upon arrival, officers contacted security and located the suspicious vehicle. After the investigation, it was determined the vehicle left behind was stolen. Officers recovered the stolen vehicle.
- On June 20, Officers Alvidrez and Lewis were dispatched to a domestic violence call. The husband stated his wife had threatened to kill herself and locked herself in the master bedroom with a knife. The husband also stated that there was a loaded hunting rifle inside the bedroom. Officers established a perimeter around the house and attempted to contact the suicidal subject, but she would not answer the phone for

police. Officer Hoisington and his recruit officer arrived to assist at the same time other family members arrived. Family members were on the phone with the suicidal subject and she told them that she had just cut her wrist. Eventually, the officers and the family members were able to talk her out of the house. The suicidal subject did have numerous cuts to her wrist and scratches on her throat. Medical personnel were called to the scene and she was taken to the hospital by ambulance.

- In June, Northwest Impact detectives investigated a series of identity thefts involving four victims. In all the cases, the victim had been notified by his/her bank of suspicious activity. Further investigation revealed an unknown subject cashed several checks and opened new credit accounts totaling over \$20,000. Detectives identified the offender and learned he had stolen the victims' mail to retrieve personal data. During the investigation, detectives learned the suspect was wanted for a triple homicide in Sandoval County. A completed case was turned over to the District Attorney's Office for a Grand Jury indictment.
- On June 23, Northwest Impact detectives were dispatched to a dealership in response to an embezzled vehicle valued at over \$100,000. Upon arrival, detectives arrested a male subject and his wife. Detectives seized a second embezzled vehicle valued at over \$20,000 at the dealership. Detectives learned both subjects conspired to commit fraud at two different dealerships over a period of four months. The vehicles were returned to the owners and both subjects were booked on several felony charges.
- On June 28, Officers J. Wharton and E. Ibarra conducted a traffic stop with an individual leaving a known drug trafficking house. Officers made contact with the driver and determined the vehicle was both unregistered and uninsured. The driver also disclosed to officers he was carrying a firearm. Once officers towed the vehicle, they ran the firearm and discovered it was stolen. A felony arrest for possession of a stolen firearm was made.

SPECIAL SERVICES BUREAU APD Academy...

- In June, the Recruiting and Selection Unit received the following: 361 interest cards including 276 cadets, 69 public service aides (PSAs), 12 laterals and four military certification by waiver.

- The June 10-12 testing consisted of 92 individuals scheduled to test; 18 attended city entrance; nine attended Saturday testing and nine were passed to background.
- The June 24-26 testing consisted of 84 individuals scheduled to test, 19 attended city entrance, 14 attended Saturday testing and 12 were passed to background.
- In June, five cadets and two Prisoner Transport Unit cadets were seated for the 117th class.
- On June 11, the unit attended Councilor Pena's District 3 Neighborhood/Government Fair. On June 15, they attended the Michael Padilla job fair. On June 25, the unit attended the Omni Arms Anniversary event.
- In June, the Advanced Training Unit was presented with APD's team of the month award.

Special Operations Division...

Tactical

- In June, the K-9 Unit responded to 187 calls for service. The K-9 Unit conducted 64 building searches and nine area searches. The K-9 Unit responded to two SWAT activations and conducted a K-9 demonstration for the public.
- On June 7, K-9 officers responded to a residential burglary in progress. Upon arrival Southeast Field Service personnel advised the subject had fled from the scene and was possibly hiding inside a vacant apartment. Officers were given permission by the owner to search the apartment. The subject was located and taken into custody without incident.
- On June 14, K-9 officers conducted a K-9 demonstration for the Junior Police Academy. There were approximately 64 Junior Police cadets present for the demonstration.
- On June 15, K-9 officers responded to the scene of a domestic violence. The comments on the call stated a female was being held against her will. Her boyfriend was armed with a handgun and threatened to shoot the female multiple times. Upon arrival, K-9 officers deployed in an attempt to isolate and contain the incident. Southwest Field officers were deployed and the subject was contacted via telephone. The subject exited and was taken into custody without incident.
- In June, SWAT conducted four activations.
- On June 30, Officer Z. Cancilla heard a call for service of three suspects fleeing the scene of an auto burglary. Two offenders were located and detained by Field Services personnel and they provided a description and

possible address of the third offender. Officer Cancilla set up surveillance at the suspect's apartment and observed the subject walk inside. Officer Cancilla called field officers who assisted with establishing a perimeter. The Tactical section responded to the scene. The offender barricaded himself inside stating he was going to kill himself and was armed with a .22 rifle. The suspect was wanted for a warrant and had a violent history. SWAT evacuated five apartments in the vicinity with use of the armored Bear Cat and established a perimeter. Several tactical strategies were utilized to successfully evacuate the offender into the courtyard where he was arrested without incident.

- In June, SWAT assisted on 283 calls for service.

Office of Emergency Management... (OEM)...

- In June, OEM met with faith leaders pertaining to the OEM Faith-based Initiative. Faith leaders from the Metro area will attend a conference on disaster preparedness on July 22, 2016.
- OEM is developing the first ever city shelter plan with operating guides for city employees.
- On June 29, OEM convened the first meeting of stakeholders to begin developing an Animal Disaster Management Operating Guide.
- On June 29, OEM met with representatives from the Department of Homeland Security Center for Faith-Based and Community Partnerships, the Mayors' Office and members of the faith-based community regarding planning for a 'Building Resilience with Diverse Communities' project. This initiative will engage the community on disaster preparedness activities and organize the faith-based community with the Office of Emergency Management response process.

Open Space...

- In June, the Open Space Dive Team conducted an Open Water Diver Certification for members of the APD Field Services Bureau. Each area command provided a top performer to participate in the class. The participants in the class also expressed interest in being considered for future Search and Rescue/Dive Team collateral positions.
- On June 4, Open Space was alerted by the Southeast Area Command dispatch about numerous calls for service in the area of Mesa Del Sol. Open Space responded and discovered that a large scale event was taking place at the Albuquerque Dragway. Open Space spent the

majority of the day dealing with racing in the neighborhoods, traffic control, trespassing, and disturbances that blanketed the Mesa Del Sol neighborhood.

- On June 10, Open Space officers were requested by Bernalillo County Sheriff’s Office to assist with a person threatening to jump from the Paseo Del Norte Bridge over the river. Open Space officers deployed with the hovercraft as a precaution and the dive team was prepared for a rescue or recovery mission, if necessary. Fortunately, the incident was resolved without injury.
- On June 11, Open Space officers assisted the Southeast Area Command with a subject, who had a noose around his neck, threatening to jump from an overpass. Officers assisted with shutting down roadways. Open Space officers utilized their mountain rescue equipment with securing the Crisis Intervention Team (CIT) officer while he negotiated with the subject on the edge of the bridge. The incident was resolved peacefully after extended negotiations with the subject.
- On June 13, while conducting dive team certifications in Santa Rosa, NM, the APD Dive Team assisted lifeguards in rescuing a drowning victim in the Blue Hole swimming area. While officers were doing paperwork between dives, they noticed a commotion and a lifeguard advised that a male subject was drowning. A lifeguard retrieved the subject’s body before it sank and Sergeant Bassett helped the lifeguards drag the subject to the water’s edge. The subject was unconscious, not breathing and had no heartbeat. Sergeant Bassett worked with the two lifeguards to implement cardiopulmonary resuscitation (CPR). Officer Melvin arrived with an oxygen kit while Officer Schmidt monitored for a heartbeat and signs of life. Sergeant Bassett was able to open the subject’s airway and support his C-spine. Officers detected a faint pulse and shallow breathing. They utilized oxygen kit, secured the subject to a back board and prepped him for transport. The subject was unconscious, but breathing and had a heartbeat. He was flown to Rust Medical Center in Rio Rancho where he made a full recovery. The Santa Rosa lifeguards, Sergeant Bassett and members of the APD Dive Team saved this young man’s life.

Horse Mounted Unit (HMU)...

- On June 3, HMU attended the Cub Scout Day Camp at Chelwood Elementary and spoke to

approximately 150 Cub Scouts.

- On June 4, HMU attended Vick’s Vittles Restaurant. Robert Vick presented the unit with a check for the purchase of a Theraplate.
- On June 4, HMU attended a Memorial Benefit for Officer Benner in Rio Rancho, NM.
- On June 10, HMU was honored by the City of Albuquerque for the Friday Hero’s Presentation by Mayor Berry.
- On June 25, HMU attended a community gathering at a park in the Foothills where there were 600-700 citizens in attendance.
- On June 17, HMU attended the Junior Police Academy where riders interacted with several hundred children.

Homeland Security...

- In June, Homeland Security sponsored, scheduled and attended the Improvised Explosive Device (IED) search and Vehicle-Borne Improvised Explosive Device (VBIED) detection courses held at the APD Academy. A total of eleven APD officers attended these two courses.
- In June, Homeland Security met and coordinated throughout the month with representatives from United States Department of Homeland Security, Albuquerque Fire Department, Homeland Security, City of Albuquerque, Cultural Services and Office of Emergency Management in response to the Freedom 4th event.
- In June, Detective Brokaw attended and assisted Officer A. Lehockey during a “Civilian Response to Active Shooter” presentation at the National American University.

Metro Traffic Division...

- In June, the Traffic Division responded to 274 calls for service.
- In June, the division issued 556 moving citations.
- In June, the division wrote 193 reports, had 13 driving while intoxicated (DWI) arrests, three felony arrests, four misdemeanor arrests/warrants and issued one felony warrant.
- In June, the division investigated 212 crashes and wrote 193 reports.
- In June, the division recovered four stolen vehicles.
- In June, the DWI Seizure Unit checked in 54 vehicles, returned 12 vehicles, booted 13 vehicles and removed 24 boots.
- In June, 329 vehicles were on the seizure lot.

- In June, 43 vehicles were auctioned and 15 were ready for auction.

Prisoner Transport Unit (PTU)...

- In June, PTU processed 1,176 prisoners through the Prisoner Transport Center. The Albuquerque Police Department arrested 914 prisoners and other outside law enforcement agencies arrested 262 prisoners.
- In June, PTU made 197 trips to the Metropolitan Detention Center and accepted 11 walk-in prisoners at the Metropolitan Detention Center.
- In June, PTU worked four hospital guard duty assignments for a total of 28 days.

Metro Court Protection Detail (MCPD)...

- In June, 59 individuals were remanded by the court and booked and four were remanded but bonded out on site.
- In June, 40 individuals were booked with arrest warrants. An additional 50 were booked with arrest warrants but bonded out on site.
- In June, 83 misdemeanors and seven felony warrants were cleared.
- In June, 154 individuals were in police custody.
- In June, MCPD had a total of 865 calls for service and self-initiated activities.
- In June, two felony narcotic cases were submitted to the District Attorney's Office for prosecution. Both cases involved individuals entering the courthouse and narcotics being located during the screenings.

INVESTIGATIVE BUREAU

Scientific Evidence Division...

- In June, the Major Crime Scene team responded to eight call-outs.
- In June, Field Investigations responded to 1,275 calls for service and 145 primary burglary calls.
- In June, Field Investigations collected 915 latent fingerprint cards, completed 924 reports, tagged 771 evidence items and tagged 533 photograph CDs.
- In June, the Photography Laboratory tagged 654 discs and received 369 requests resulting in the production of 9,645 prints and 509 discs.
- In June, the Evidence, Identification and Disposition Unit supported the following backgrounds: 84 case dispositions, 18 employment, 47 firearms, 109 FBI and 54 CODIS requests. 34 RAP's and photos were distributed, 20 new APD applicants were finger printed, 1,288 fingerprints were classified in

- AFIS and 1,879 new and old arrests were processed into APD's criminal history records.
- In June, the Evidence, Identification and Disposition Unit received 12,473 evidence items, duplicated 7,019 audio/video recordings and supported 19 pretrial viewings. Efforts to reduce the inflated inventory resulted in 524 items returned to owners, 4,468 items disposed of and \$569.34 received from auction income. The Evidence Disposition Team coded 8,090 case disposition transactions into evidence history.
- The New Mexico DNA Identification System (NMDIS), received 442 new convicted offender/arrestee DNA samples for June with a cumulative total of nearly 112,000 collected. 458 samples were analyzed, uploaded and searched in CODIS with a cumulative total of over 106,000 searchable DNA profiles. As a result of these convicted offender/arrestee samples, 73 unsolved cases were matched to convicted offenders/arrestees and 15 case-to-case matches were made, with a resulting total of 90 investigations being aided.
- In June the Controlled Substance Unit completed 78 drug cases (53 were APD and 25 were Bernalillo County Sheriff's Office).
- In June, the Biology Unit completed 23 APD cases.
- In June, the Latent Fingerprint Unit completed six APD cases.

Property Crimes Division...

Auto/NITE Unit ...

- In June, the Auto Theft Unit conducted two community policing VIN etching events, resulting in service to 476 citizens. Detectives also educated citizens on how to best defend themselves against becoming victims of crime, specifically auto theft. During the events Detectives gave away approximately 100 free gunlocks to those citizens who requested one.
- In June, the Garage provided 60 free Level III vehicle identification numbers (VIN) inspections to citizens who had been referred for a higher level of inspection by the New Mexico Motor Vehicle Division.
- In June, the Auto Theft Unit, along with Wrecker Services staff, conducted the mandated annual wrecker inspections ensuring that all tow companies on city contract and on-call rotation pass Public Regulation Commission (PRC) requirements. Twenty-one companies are currently on rotation with over 100 trucks being

- utilized throughout the city.
- The unit used undercover follows of offenders driving stolen vehicles. The officers follow the vehicle to its final destination and when the offenders separate from the vehicle, they are contacted and taken into custody. This tactic has facilitated the recovery of 30 stolen vehicles worth an approximate \$289,000 in the month of June.
- In June, the Auto Theft Unit was responsible for 38 felony auto theft offender arrests.

Burglary and Organized Crime Unit ...

- In June, Detective Candelaria completed a residential burglary case in which a suspect who had three outstanding felony warrants was taken into custody. Property Crime detectives set up surveillance on the suspect's residence and watched him exit on foot. He was taken into custody without incident. The same suspect was also charged with a recent residential burglary in which approximately \$3,000 worth of stolen property was taken. Detective Candelaria obtained an arrest warrant for an accomplice to this incident. These suspects are currently two of the most active residential burglars in the city.
- Detective V. Natewa completed her investigation involving embezzlement at a local non-profit agency. The case was completed with the arrest of three employees. The suspects used their positions as caseworkers to defraud the non-profit of approximately \$46,510 of funds which were meant for its clients. The suspects opened several bank accounts which they illegally funded with money from the non-profit. The bank accounts were opened under false rental companies created by the suspects.
- In June, Detective V. Natewa completed an investigation in which a subject defrauded a local co-op business of approximately \$30,000. The suspect was an employee working as a cashier. For an extended period of time, the employee would void transactions and pocket funds. The suspect now faces numerous embezzlement and fraud charges.
- In June, Detective D. Candelaria completed a fraud and embezzlement case involving an employee at a local business. The employee worked as a bookkeeper at the company and gave himself a pay raise without authorization for approximately \$34,000. An extensive investigation was conducted resulting in the employee being charged with multiple counts of embezzlement, fraud, and forgery.

- During the week of June 13 - 20, detectives with the Pawn/Burglary Unit led by Case Agent V. Santistevan conducted inspections and investigations at all local pawn shops in the City of Albuquerque. As a result, 18 inspections were completed, over \$6,000 in stolen property was seized, six stolen firearms were recovered, two subjects were apprehended with warrants, 16 violations were observed and documented and four businesses were cited and found to be non-compliant. Follow up investigation and compliance checks will be administered.

Criminal Investigations Division...

- In June, the Homicide Unit responded to seven call-outs. Of the seven, five were homicides while two are being investigated as major cases.
- On June 7, officers were dispatched to a suspicious persons call. The caller stated her cousin advised them he had "hurt his girlfriend." When officers arrived, they located a deceased female. The scene was secured pending investigation and would later result in a Violent Crimes call-out. Detectives with the assistance of other department units and several state agencies located the offender as he attempted to leave the state. This case is considered solved/closed and will be carried as a homicide.
- On June 11, officers were dispatched to a shots fired call. When they arrived, they located a male victim with apparent gunshot wounds. The subject was pronounced deceased at the scene. The scene was secured pending investigation and would result in a Violent Crimes call-out. Detectives later identified and arrested the subject responsible for the shooting. This case is considered solved/closed and will be carried as a homicide.
- On June 22, officers were dispatched to assist the Albuquerque Fire Department on a down and out call. When officers arrived, they were advised the subject was deceased. The scene was secured pending investigation and would later result in a Violent Crimes call-out. Further investigation showed the subject died of a drug overdose. This case is considered closed and will be carried as a major case.
- To date, the Homicide Unit has cleared 20 cases by arrest.
- In June, the Armed Robbery Unit responded to 11 robbery callouts and cleared 39 cases. Of those 39 cases, 31 were sent to the District Attorney's Office for prosecution. The unit also made 15 in-custody arrests and wrote seven

arrest warrants. Furthermore, they wrote and conducted 15 search warrants. The Robbery Unit had 31 new cases assigned this month and now has a total 152 active cases.

- The Sex Crimes Unit responded to seven sex crimes call-outs this month. They also cleared 26 cases with 11 of those going to the District Attorney's Office. The unit also wrote ten search warrants. There were 29 new cases assigned for investigation in June. The unit currently has 99 active cases.
- On June 9, Detective Wild was presented with the non-uniformed officer of the month for June.
- In June, Family Abuse Stalking/Training Team (FASTT) received and reviewed 90 reports.
- In June, FASTT cleared ten cases.
- In June, FASTT assisted the Victims Assistance Unit with 20 cases which included follow-up with victims.
- In June, the Missing Persons Unit was assigned 96 cases and cleared 104 cases.
- In June, the Crisis Intervention Unit (CIU) provided 50.5 hours of training and conducted 43 meeting hours. The unit contacted 218 individuals and assisted 82 mental health consumers with services. They referred 116 individuals to services and received 123 referrals. CIU took 78 calls for service and was assigned 21 cases. The unit completed 20 home visits with mental health clinicians and transported 11 individuals to the hospital.
- As of June, there are 459 officers in the field that are CIT-certified including Sergeants and Lieutenants (98%)
- In June, the Crisis Intervention/Juvenile section continues to participate in the CIT Knowledge Network Echo project. This innovative project brings physicians and officers together to staff cases and raise the standards in law enforcement interactions with people living with mental illness. This project brings experts in mental health and crisis intervention to officers in a video telecommunication platform giving them access to continuing education.
- In June, the Crimes Against Children Unit (CACU) received 920 Children, Youth and Families Department (CYFD) referrals.
- In June, CACU detectives were assigned 55 new cases to be investigated and had 36 call-outs.

Special Investigations Division (SID)...

- In June, SID had 25 felony and 11 misdemeanor arrests.
- In June, SID wrote 19 felony warrants.

- In June, SID wrote six arrest warrants and executed three.
- In June, SID made 17 controlled buys and 37 buy busts.
- In June, SID has 18 call-outs for APD and two for outside agencies
- In June, SID submitted ten cases to the District Attorney's Office for prosecution.
- In June, SID seized three pounds of marijuana; 1,9273.10 grams of methamphetamine; five grams of cocaine; 1.224.50 grams of heroin; ten grams of prescription drugs; and 1,010 grams of other drugs.
- On June 15, detectives from the Gang Unit responded to a shooting where a known gang member did a drive by shooting and returned while marked units were at the scene. He aimed a firearm at the officers and drove off. He was apprehended shortly afterwards. A search of the offender's vehicle was done after obtaining a warrant. Two rifles, spent rifle casings, one empty magazine and one full magazine with 24 rounds were recovered.
- In June, the Vice Unit conducted an ongoing narcotics investigation where drugs were being sold out of a residence. The Vice Unit and Central Narcotics Unit served a search warrant at the residence. Detectives seized a quantity of heroin and paraphernalia consistent with trafficking narcotics. Detectives arrested two adults for felony charges, cleared one felony warrant and created a Children, Youth and Families Department (CYFD) case for a child living at the residence.
- On June 9, Air 5 was requested to assist the Gang Unit in the apprehension of a male whom had a felony warrant for his arrest. Air 5 conducted a tactical follow of the subject's vehicle. After some time and numerous stops, the male was taken into custody without incident.
- On June 21, Air 5 was on patrol and dispatched to a stolen vehicle call. Air 5 located the vehicle and directed field units to its location. The vehicle eluded the field units and Air 5 continued a tactical follow until the vehicle crashed. At this point, the passengers exited the vehicle while leaving it in gear. The vehicle came to a stop after striking an electric pole. Air 5 provided the direction of travel of the driver and one of its passengers and field officers took them into custody. A K-9 search was conducted for the remaining two passengers and they were taken into custody.

- On June 27, Air 5 was dispatched to a stolen vehicle a field unit was following. Once in the area, Air 5 began calling out directions and the ground unit fell back. The vehicle began picking up speed through a residential area, lost control and collided into a tree. The vehicle exploded and rolled over. Two people were taken into custody.
- On June 28, Air 5 was dispatched to a pharmacy in response to a suspicious person attempting to switch license plates on a vehicle. Once in the area, a field unit verified the vehicle being driven by that individual was stolen. A field officer attempted to stop the vehicle but it fled. Air 5 followed the vehicle and directed units to two different locations where the vehicle stopped. Each time, as officers approached, the vehicle fled. At one point, the offender parked the vehicle and walked away. Air 5 followed the subject and directed units to his location where he was taken into custody. Air 5 also directed units to the stolen vehicle where it was recovered.
- In June, the Central Narcotics Unit conducted five undercover buy bust operations; served four search warrants; and recovered 12 firearms.
- On June 1, the Central Narcotics Unit conducted an undercover operation in the Foothills Area Command after numerous reports of drug dealing activity. Undercover detectives conducted surveillance and identified the drug traffickers. A buy bust was conducted and three subjects were arrested on felony narcotics trafficking charges. Detectives also recovered a stolen vehicle which was being used to sell the drugs.
- In June, the Central Narcotics Unit received information that a subject was selling crack cocaine throughout the Northeast Area Command. Detectives identified the subject who had a criminal history for narcotics violations. On June 7, undercover detectives set up a buy bust operation where they located the suspect and purchased crack cocaine from her. Detectives observed the suspect selling drugs in the presence of her 13-year-old son. After the buy, the suspect was taken into custody and arrested on felony drug trafficking and child abuse charges.
- For the past several weeks, the Central Narcotics Unit had been conducting an ongoing investigation in the Albuquerque area. Central Narcotics Detectives identified a Drug Trafficking Organization (DTO) operating in

New Mexico and surrounding states. Detectives used several investigative techniques and operations to identify the individuals involved in the organization. On June 17, the Central Narcotics Unit arrested an individual tied to the DTO. The United States Attorney's Office accepted the case and the subject will be prosecuted federally. As a result of this arrest, the Central Narcotics Unit seized \$26,250 in United States currency, 19,264 grams of methamphetamines (43 pounds) and 1,209 grams of heroin (2.7 pounds). Eight firearms, of which one was confirmed stolen, 1000 quantities of MDMA (ecstasy), and twenty doses of steroids were also seized. The total value of the drugs seized was \$250,000.

Real Time Crime Center (RTCC)...

- In June, the RTCC had 13 pre-cadets who received extensive training on ten codes, databases, video network and learning how to provide pertinent information to officers in the field. The pre-cadets started their police academy on June 28, 2016, with better knowledge of investigate tools because of the training they received from the RTCC.
- In June, RTCC operators assisted with three SWAT activations by supplying the field with subject work-ups, photos and pertinent information. In one of the call-outs, the RTCC was able to pull up video footage at a possible active shooter location.
- In June, representatives from the Tucson Police Department visited the RTCC. They toured and received information from all units including the Video Unit, Crime Analysis Unit and the Bridge (live operations) to help build their own center in Tucson.
- In June, the Crisis Intervention Training (CIT) was utilized approximately 1,700 times, video network was utilized approximately 300 times and more than 1,700 logs were generated.
- In June, Crime Stoppers received 152 tips, five of which resulted in arrests. One of the arrests involved a homicide case.
- In June, the RTCC video trailers were requested seven times to help monitor drug activity, possible auto burglaries and suspicious activity.

PROFESSIONAL ACCOUNTABILITY BUREAU

Communications Division...

- In June, the APD Emergency Communications Center staff answered 91,493 incoming calls. There were 35,068 calls answered for 911 and 51,310 calls answered for 242-COPS. 911 Operators answered 88.81% of the 911 calls within 10 seconds (national standard is 90%, APD's standard is 92.0%); operators also answered 78.98% of the 242-COPS calls within 30 seconds (APD's goal is 90% answered within 30 seconds).
- In comparison to last year for June, 911 call volume decreased by 3.05% and 242-COPS call volume increased by 5.23%. This represents an overall increase of 1.70%.
- Total Calls answered for Fiscal Year 2016 ending June 30 was 961,076 compared to Fiscal Year 2015's total of 883,845. This represents an 8.74% increase.
- On June 11-17, several members of Communications attended the National Emergency Number Association Conference (NENA) in Indianapolis. This provided an opportunity to interact with other 9-1-1 representatives across the country and exchange business practices and problem solving.
- In June, interviews and pre-employment testing took place for both Telecommunication Operator I and Telecommunication Operator II positions. Drug and hearing tests are currently being scheduled.
- In June, a data coordinator attended an ARC-GIS meeting to review software and mapping solutions.

ADMINISTRATIVE SUPPORT BUREAU

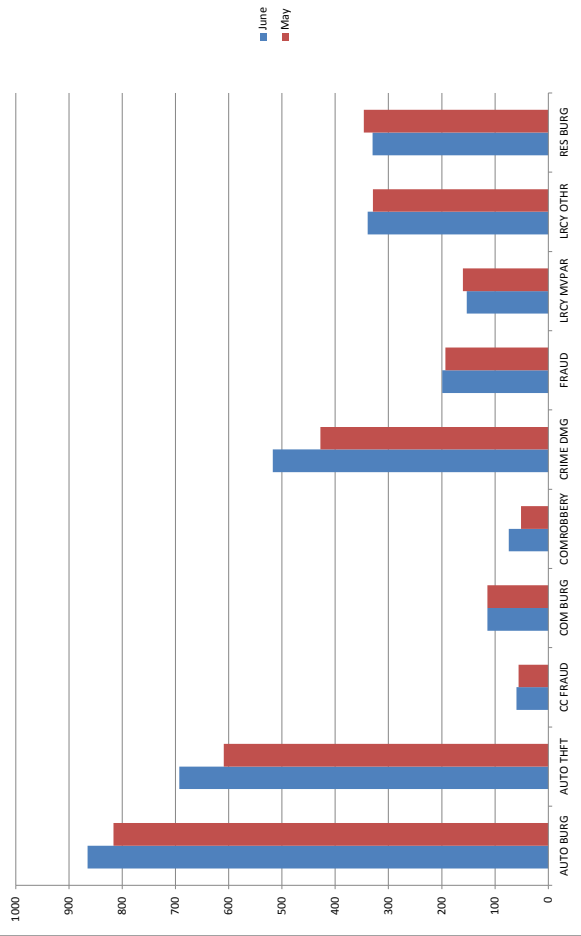
Planning Division...

- In June, The Grants Management Unit attended a grants training sponsored by the New Mexico Department of Transportation (NMDOT).
- In June, R. Wright attended the New Mexico Department of Public Safety Civil Rights training.
- In June, two grant applications were submitted to the Department of Justice, Bureau of Justice Assistance.
- In June, interviews for the vacant Management Analyst I position were completed. S. Sotelo was chosen and will start July 25.

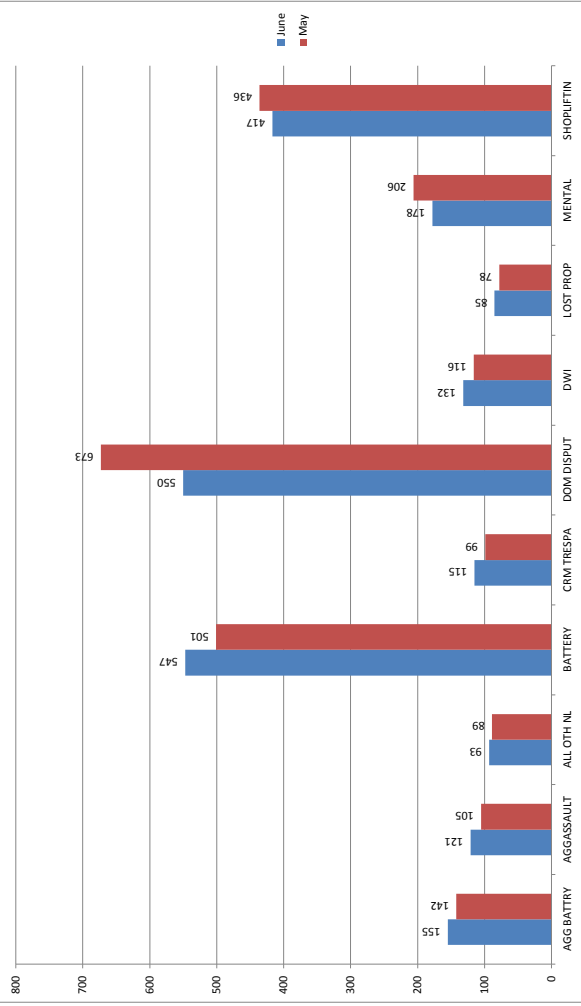
Central Records Division...

- In June, the Public Information Unit received 1,071 requests totaling \$8,484.95 in revenue generated from citizen requests/registers.
- In June, the Report Review Unit completed the following: 3,127 Automated Reporting System (ARS) transfers, 1,106 ARS supplements, 3,730 National Crime Information Center entries, 1,941 accidents, 2,622 officer calls and 381 Unified Crime Reports (UCR).
- In June, Court Services completed the following: 120 pretrial hearings scheduled, 345 arraignments processed, 347 felony cases submitted to the District Attorney's Office and 574 summonses submitted to the Metropolitan Court.
- In June, the False Alarm Reduction Unit collected \$101,265 in fees and fines for a total of \$1,196,612 for the fiscal year. The unit entered 663 new accounts and mailed 11,249 pieces of correspondence. There were 1,661 false alarms which was a decrease of 7.9% from last year's 1,802.
- In June, the Telephone Report Unit generated 621 original reports and 122 supplemental reports for a total of 743. This resulted in a savings of 1,932 hours of field services time and a savings of \$29,720.
- In June, the Telephone Report Unit processed 636 on-line (Cop Logic) reports resulting in a savings of 1,654 hours of field services time and a savings of \$25,440.
- In June, the Inspection of Public Records (IPRA) received 145 requests, completed 117 requests, and collected \$3,584 in revenue.
- In June, the Inspection of Public Records (IPRA) billed 18 IPRA requests for a total of \$391.

TOP 10 PROPERTY CRIMES FOR JUNE COMPARED WITH MAY

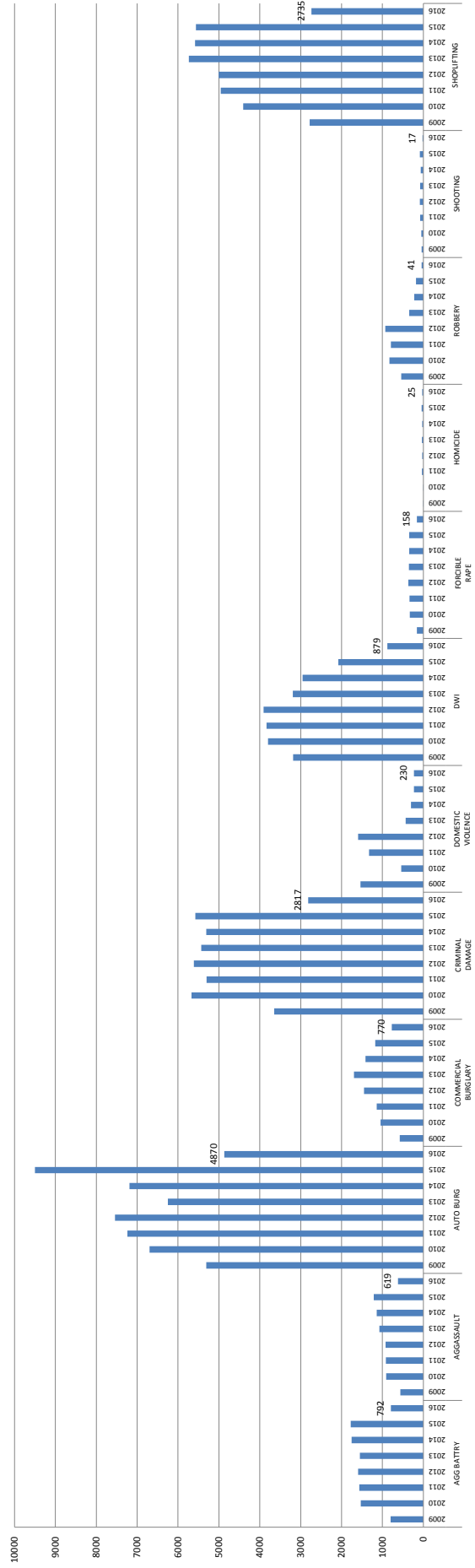


TOP 10 PERSON CRIMES FOR JUNE COMPARED WITH MAY

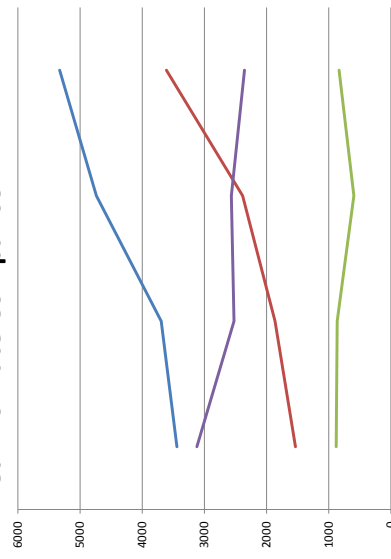

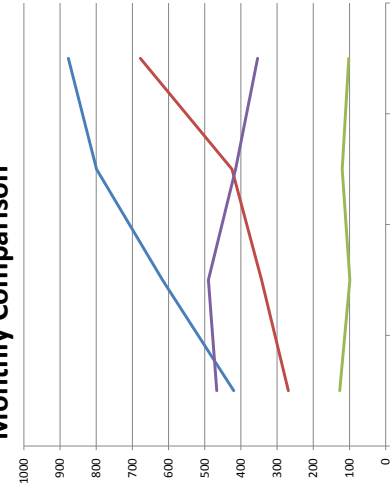

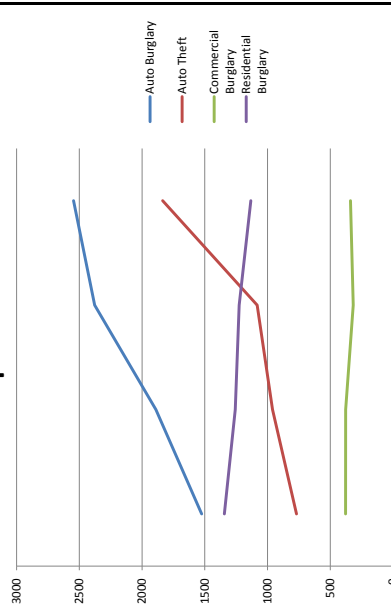
Year-To-Date Comparison
