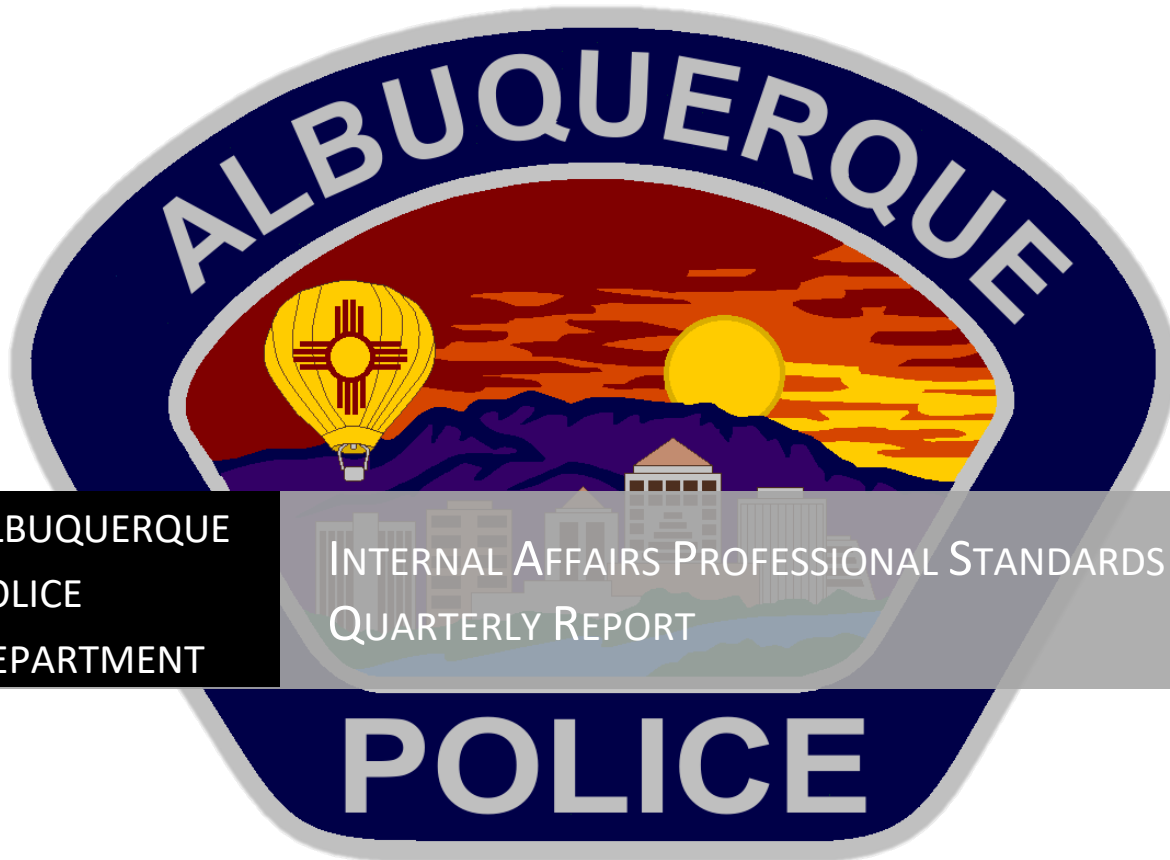

## **Introduction**

The Internal Affairs Professional Standards quarterly report is required by the Albuquerque Police Department and the City of Albuquerque. APD's Standard Operating Procedure (SOP) 7-1-14-A Quarterly IAS Reports, establishes guidelines and parameters for the Quarterly Report. The data provided in this report is from the 2<sup>nd</sup> quarter of 2020 (April through June).

This report is intended to notify the Administration of the Police Department, the City Council, Police Oversight Board and the citizens of Albuquerque with statistics and the status of Internal Affairs investigations within the Albuquerque Police Department.

## Legends

### Disposition

Administratively Closed	The policy violations are minor, the allegations are duplicative, or investigation cannot be conducted due to a lack of information.
Exonerated	The investigation determines, by a preponderance of the evidence, that the alleged conduct did occur but did not violate APD policies, procedures, or training.
Not Sustained	The investigation is unable to determine, by a preponderance of the evidence, whether the alleged misconduct occurred.
Sustained	The investigation determines, by a preponderance of the evidence that the alleged misconduct did occur.
Sustained/NBOOC	Sustained violation not based on original complaint – the investigation determines, by a preponderance of the evidence, that misconduct did occur that was not alleged in the original complaint but that was discovered during the misconduct investigation.
Unfounded	The investigation determines, by clear and convincing evidence, that the alleged misconduct did not occur or did not involve the subject officer.

## Data Collection

For the 2020 2<sup>nd</sup> Quarter Report, data from the 2<sup>nd</sup> quarter 2020 was pulled from the data warehouse. The data was filtered to include only cases with an Incident Type of "IA Investigation". The data included, but was not limited to file number, case number, received date, completion date, allegation, directive, finding, action taken, incident division (area command), incident section (assignment), officer payroll ID, name and rank.

To determine the number of cases received in the 2<sup>nd</sup> quarter, the data was filtered to only include cases with a receive date within the quarter; received between 2020-04-01 and 2020-06-30. This data was also used to determine the incident division, allegation, directive (SOPs violated) and number of employees involved and their ranks.

To determine the number of cases completed in the 2<sup>nd</sup> quarter, the data was filtered to only include cases with a completed date within the quarter; completed between 2020-04-01 and 2020-06-30. This data was also used to gather statistics on case findings and actions taken.

To determine the number of cases pending, the data was filtered according to both the received and the completed dates. Receive date was set before 2020-06-30, and the completed date was set after 2020-06-30. Pending data includes uncompleted cases from the previous quarter, and those received during the quarter, but not completed as of the end of the quarter.

Each quarter the data for the preceding quarter(s) is recalculated to ensure that the data is being reported as accurately as possible at the time each report is produced.

## Use of Force Case Synopses

The following are synopses of use of force cases being investigated by Internal Affairs for allegations of misconduct. This does not include every use of force investigation.

### I2019-000256 1.1.4.D.15, Sustained; 2.52.4.C.2, Sustained; 2.52.4.C.3, Sustained

On May 6, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP sections were observed:

(1) 1.1.4.D.15

Police officers and Department employees are expected to conduct themselves in a professional manner at all times. Personnel are discouraged from using any language that could be considered profane, derogatory, or disrespectful toward any person. In certain situations, profanity may be acceptable, subject to review on a case-by-case basis.

(2) 2.52.4.C.2

In their interaction with subjects, officers shall use advisements, warnings, verbal persuasion, and other tactics prior to escalating to the use of force, if feasible. Officers should recognize that they may be able to move to a more tactically sound position or to a position which allows greater distance between them and the subjects, in order to consider or use a greater variety of tactical options.

(3) 2.52.4C.3

Officers are expected to recognize that their approach to a civilian interaction may influence whether a situation escalates to the need for use of force.

### **I2019-000069 2.54.5A.1, Sustained**

On March 30<sup>th</sup>, 2019, officers were involved in a use of force. During the review of the incident violations of following SOP sections were observed:

(1) 2.54.5A1 A Officer Responsibilities Involving a Use of Force or Show of Force

The primary officer shall complete a uniform incident report providing an accurate, detailed account of the incident, from the officer's perspective. Officers should use descriptive language detailing their observations of the event rather than judgments, generic, or conclusory statements. Officers shall not merely use "canned" or "boilerplate" language. Officers should be aware of the requirements for supervisory force investigations and should articulate all aspects of the incident which are relevant to the supervisory investigation. At a minimum, officers' accounts must include these elements:

- a. The justification for police contact with the subject
- b. All circumstances which led to the decision to use force, including a specific description of the subject's behavior
- c. The amount and type(s) of force used, including a specific description of the officer's actions and any physical contact with the subject
- d. A specific description of any resistance by the subject
- e. The officer's justification for the amount and type of force used
- f. A specific description of any de-escalation tactics employed by the officer
- g. The identity of all officers, witnesses, subjects, and any other involved parties
- h. The nature of medical aid provided

### **I2020-000307 2.52.4.C.1, Sustained; 2.52.4.C.1, Sustained**

On December 24<sup>th</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2.52.4.C.1 Force is necessary when no reasonable alternative to the use of force exists. When force is necessary, officers shall use the minimum amount of force required that is reasonable.

### **I2019-000158 2.52.4.C.2, Not Sustained; 2.52.4.E.2 Not Sustained**

On April 4<sup>th</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2.52.4.C.2 In their interaction with subjects, officers shall use advisements, warnings, verbal persuasion, and other tactics prior to escalating to the use of force, if feasible. Officers should recognize that they may be able to move to a more tactically sound position or to a position which allows greater distance between them and the subjects, in order to consider or use a greater variety of tactical options.
- (2) 2-52.4.E.2 While utilizing a particular force option, officers should continually assess whether the opportunity exists for them to safely de-escalate their level of force while still achieving the arrest or lawful objectives.

### **I2020-000231 1.1.4.D.15, Sustained; 2.52.4.C.3, Administratively Closed**

On December 13<sup>th</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 1.1.4.D.15 Police officers and Department employees are expected to conduct themselves in a professional manner at all times. Personnel are discouraged from using any language that could be considered profane, derogatory, or disrespectful toward any person. In certain situations, profanity may be acceptable, subject to review on a case-by-case basis.
- (2) 2.52.4.C.3 In their interaction with subjects, officers shall use advisements, warnings, verbal persuasion, and other tactics prior to escalating to the use of force, if feasible. Officers should recognize that they may be able to move to a more tactically sound position or to a position which allows greater distance between them and the subjects, in order to consider or use a greater variety of tactical options.

### **I2019-000595 2.54.4.A.1, Sustained; 2.54.4.A.6, Sustained; 2.54.5.C.1A, Unfounded; 2.54.4.C.2.i, Sustained; 2.54.5.C.2.m, Sustained; 1.1.4.D.19, Sustained; 2.52.4.F.2 Sustained; 2.52.4.H.1 Sustained.**

On August 24<sup>th</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2.52.4.A.1 Policing at times requires that an officer exercise control of a violent or resisting subject to make an arrest or to protect the officer, other officers, or members of the community from risk of imminent harm. Clearly, not every potential violent confrontation can be de-escalated. However, officers do have the ability to impact the direction and the

outcome of many situations they handle, based on their decision-making and the tactics they choose to employ. The officer shall consider and use, where appropriate, de-escalation techniques.

- (2) 2.54.4.A.6 The responding supervisor shall be one rank higher than any involved officer at the time of the investigation. An acting first-line supervisor who has not completed the 24-hour supervisory use of force investigation training will not conduct any portion of a use of force investigation. Acting first-line supervisors who have completed the 24-hour supervisory use of force investigation are authorized to conduct use of force investigations.
- (3) 2.54.5.C.1A Refrain from reviewing any use of force which they ordered or participated in. "Participating" is defined as physically assisting in overcoming the subject's resistance.
- (4) 2.52.4.C.2.i Review all use of force narratives and ensure that all Use of Force reports include the information required by APD policy.
- (5) 2.54.5.C.2.m Evaluate all evidence to determine whether the use of force was consistent with APD policy and identify any policy, training, tactical, or equipment concerns.
- (6) 1.1.4.D.19 Personnel will not alter, misrepresent, or make any false statement in any verbal or written report or in any other written document that has been completed in the course of their employment.
- (7) 2.52.4F.2 Officers must not engage in actions or tactics that precipitate the use of unreasonable force or that unduly jeopardize their own safety or the safety of others. Officers shall not use force to attempt to effect compliance with a command that is unlawful.
- (8) 2-52-4H-1 Officers may use force consistent with this policy to accomplish lawful objectives.

### **I2020-000272 2-52-4G, Unfounded**

On July 23<sup>rd</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2-52-4G - Use of Force to Effect a Detention, Conduct a Search, or Make an Arrest  
Officers shall, whenever possible, make clear their intent to detain, search, or arrest a subject before resorting to use of force. When feasible, officers will identify themselves as peace officers before using force.

### **I2020-000198 2.52.6.A.8, Sustained; 1.1.4.D.16, Sustained**

On February 27<sup>th</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2.52.6.A.8 An officer shall immediately notify a supervisor and document any use of force as set forth in Department SOP –Use of Force –Reporting by Department Personnel.
- (2) 1-1-4-D.16 .Police officers and Department employees are expected to conduct themselves in a professional manner at all times. Personnel are discouraged from using any language that could be considered profane, derogatory, or disrespectful toward any person. In certain situations, profanity may be acceptable, subject to review on a case-by-case basis.



## **I2020-000279 2.52.6.F.5, Sustained**

On April 8<sup>th</sup>, 2019 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2.52.6.F.5 Duty to Provide Medical Attention and Transportation. If an officer transports an individual to a medical facility, the officer shall notify communications of the starting and ending mileage of the transporting vehicle.

## **I2019-000341 2.80.2.R.1, Unfounded; 2.52.7.B, Unfounded; 2.80.R.2 Unfounded.**

On April 8<sup>th</sup>, 2018 officers were involved in a use of force. During the review of the incident violations of following SOP, sections were observed:

- (1) 2.80.2.R.1 Photographs of Officers and Suspects/Prisoners1. Photographs will be taken of all persons, the officer, suspect and arrested person(s) involved in an incident where: a. An officer, suspect or prisoner has been injured even though may not be visible. b. Subjects resist in any manner that would require a Use of Force report (2-52-7-B).c. Subjects are charged with Battery on a Police Officer, Aggravated Battery on a Police Officer, and Resisting Arrest. d. Persons have pre-existing injuries. Officers will document these injuries on the Offense and Incident Report Form.
- (2) 2.80.R.2 It is the responsibility of the arresting/reporting officer to ensure that a designated personnel or Field Investigator responds to the scene to assume the responsibility for taking photographs
- (3) 2.52.7.B Supervisors shall investigate use of force incidents pursuant to the requirements set forth in SOP 2-54 – Use of Force Reporting and Supervisory Force Investigation Requirements.

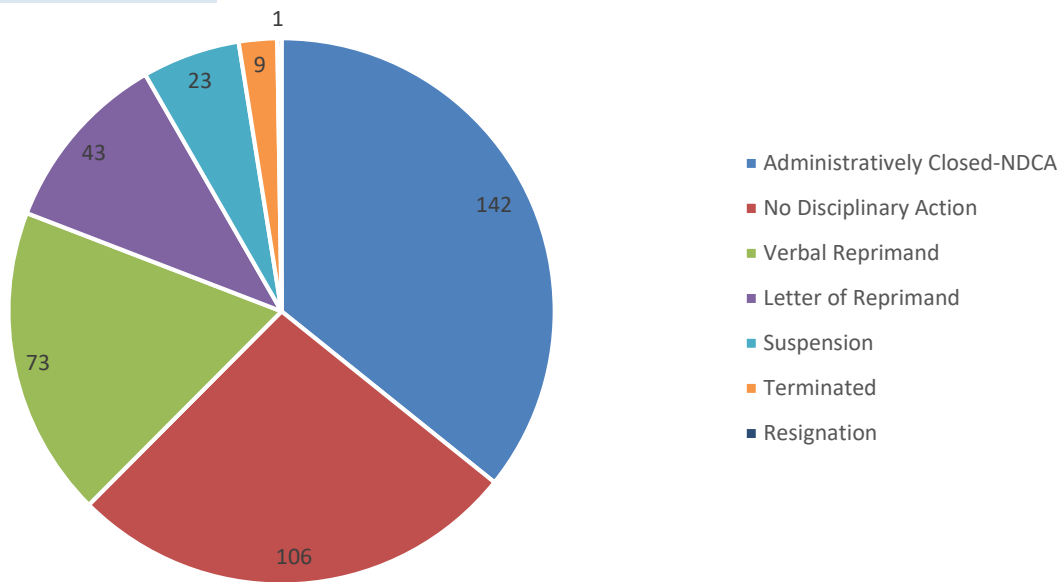


## Actions Taken

Action Taken 2020 Q2

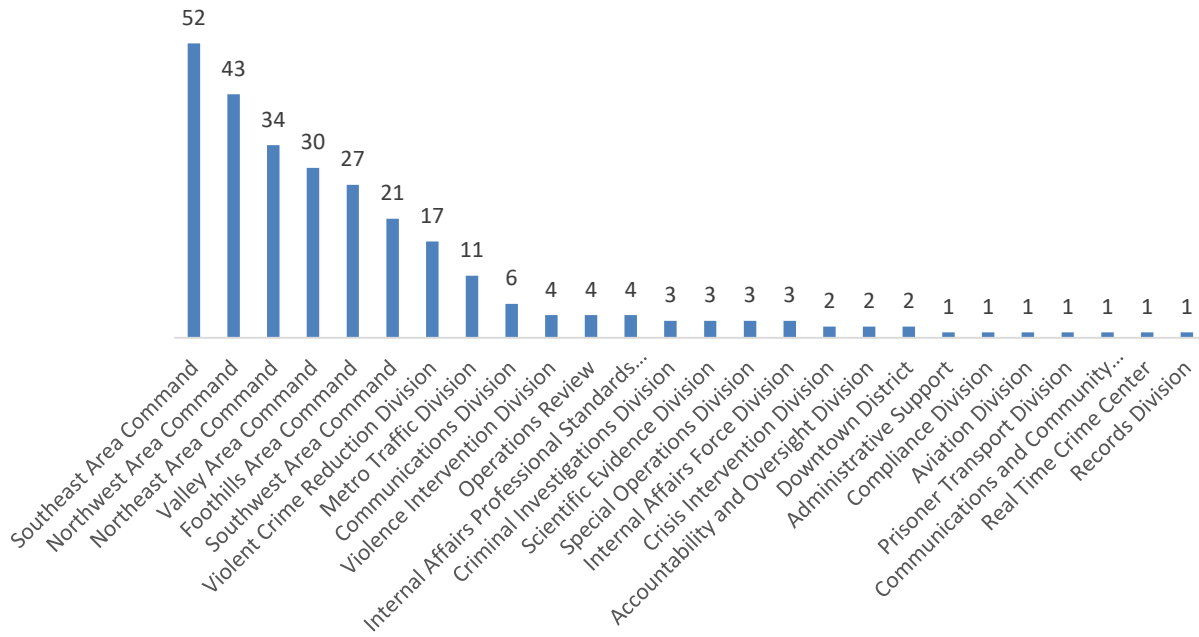

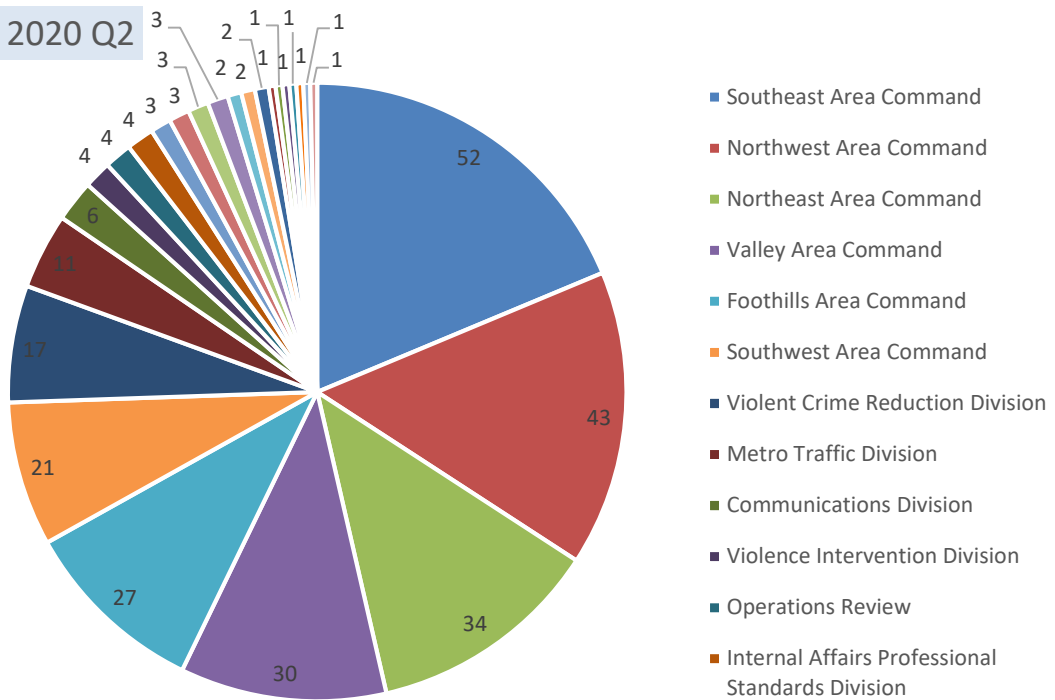


## Division (Area Command)

Division 2020 Q2

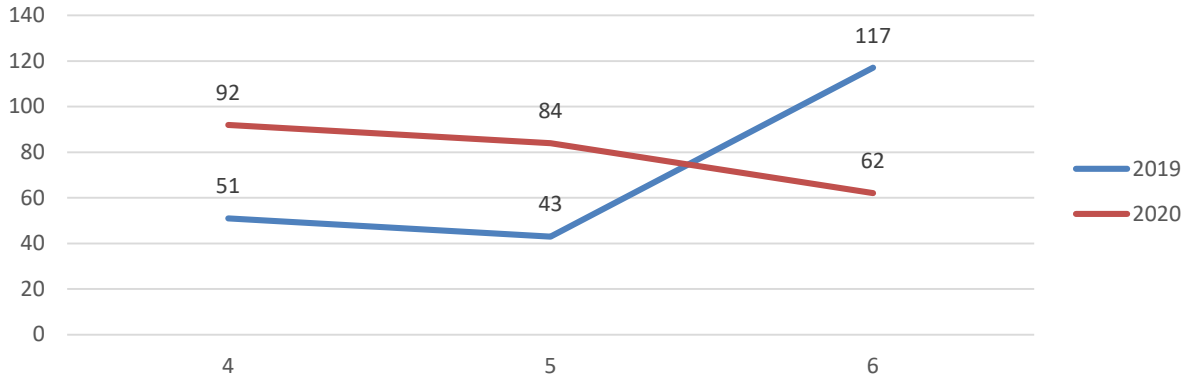

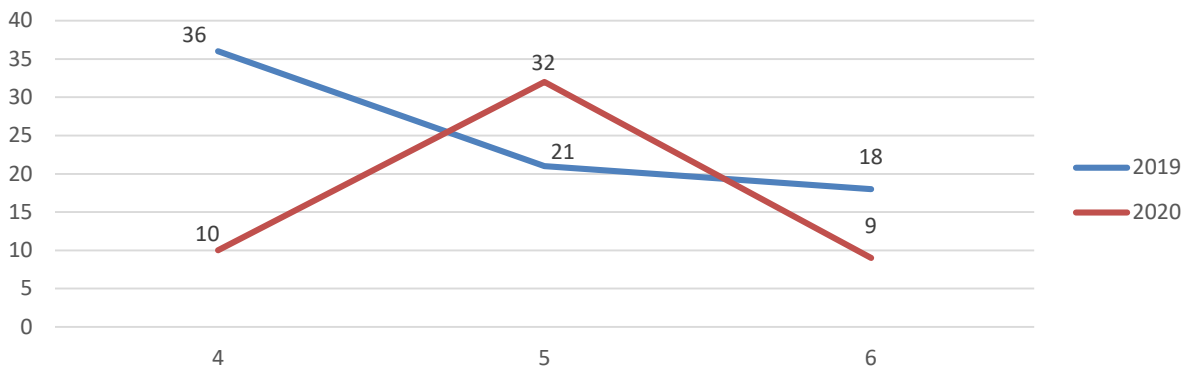

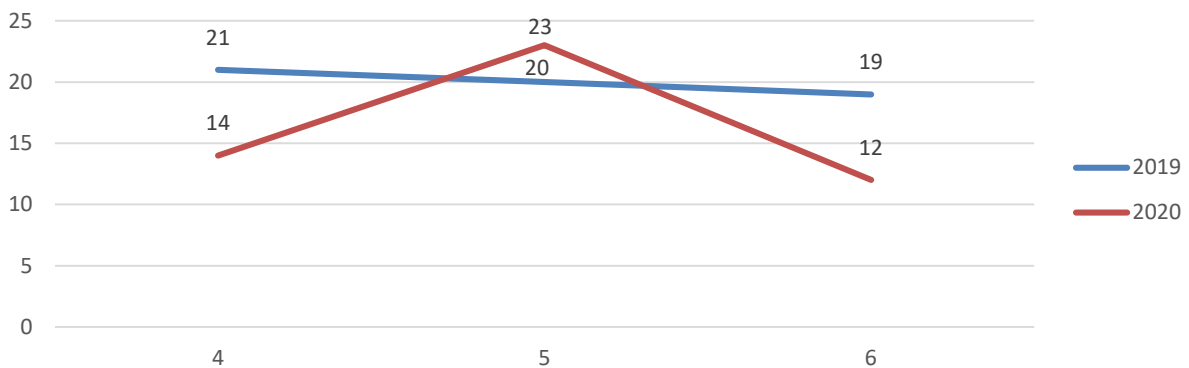
### IA Cases Received 2020 Q2
