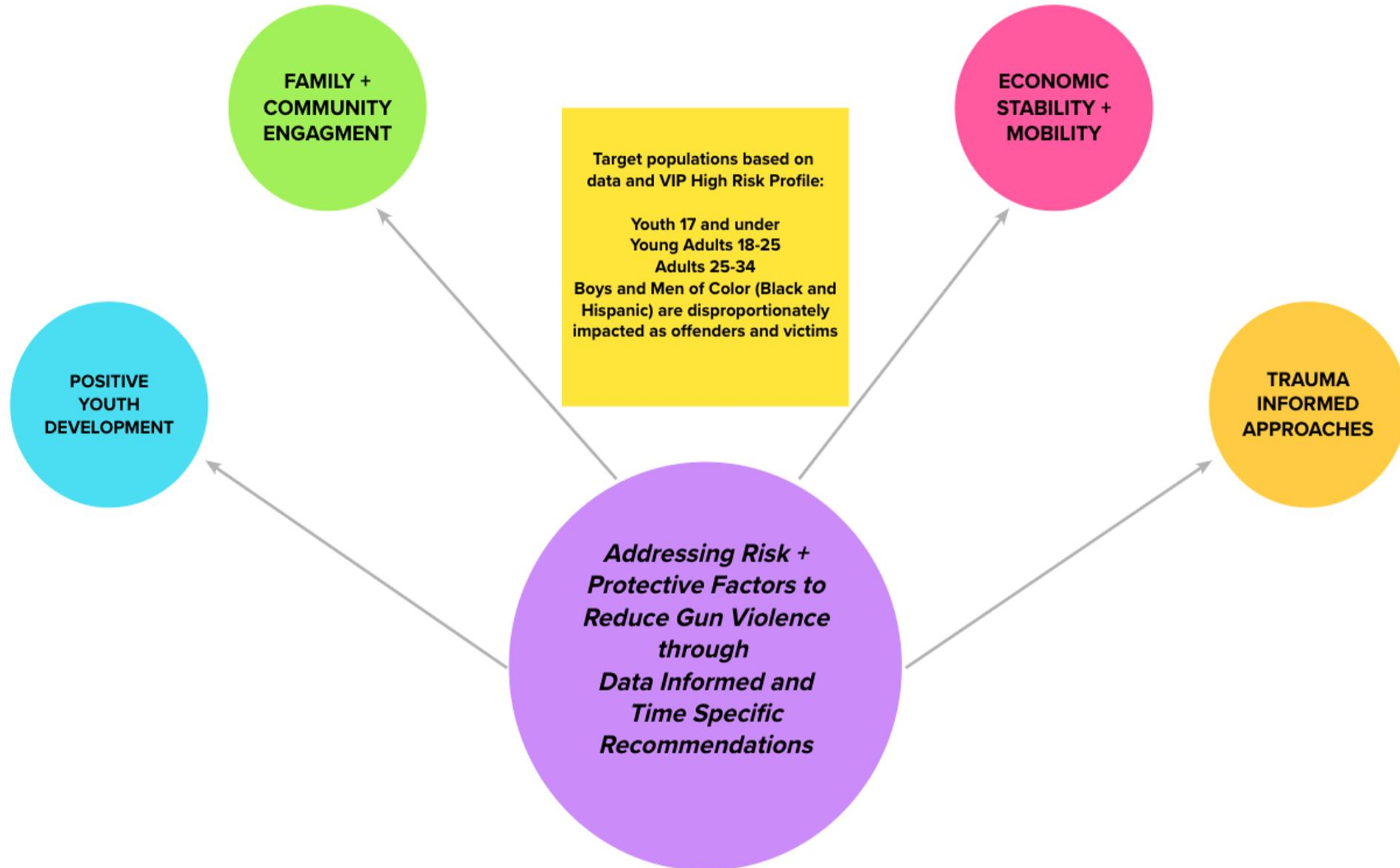


Gun Violence Task Force Committees - Prioritization Exercise



EXECUTIVE ORDER - RECOMMENDATIONS

5. The Task Force shall develop a set of SMARTIE recommendations of actions the City can take to address gun violence as follows:
 - a. Recommendations for how to improve cooperation among city departments and outside entities with respect to gun violence issues;
 - b. Recommendations for substantive system change in City policies and ordinances aimed at reducing instances of gun violence;
 - c. Recommendations for how to ensure culturally responsive, trauma and equity informed frameworks are used to guide effective gun violence strategies;
 - d. Recommendations for how to effectively increase services through grants and programs, and other new sources of funding to ensure resources and capacity to build community strategies, aligned with the Violence Intervention Program's two-year strategic priorities.
6. The Task Force shall not discuss or request information regarding specific cases of gun violence unless such data has been de-identified.
7. The Task Force shall issue two report to the administration: semi-annually, one mid-way and the final report no later than one year after the date of this Executive Order.
8. The Task Force shall automatically dissolve on the second anniversary of the date of this Executive Order unless expressly extended.

THIS EXECUTIVE ORDER does not create any legal rights on the part of any person or entity and shall not be a basis for a challenge to rules or regulations or any other action or inaction of the City.

THIS EXECUTIVE ORDER supersedes all other previous orders, proclamations or directives to the extent they are in conflict. The Executive Order shall take effect immediately.

SMARTIE Goals

Goals are a concrete way to drive results, but without an explicit equity and inclusion component, goals won't produce better outcomes for historically oppressed communities, address disparities, or support belonging.

STRATEGIC

Reflects an important dimension of what your organization seeks to accomplish (programmatic or capacity-building priorities).

MEASURABLE

Includes standards by which reasonable people can agree on whether the goal has been met (by numbers or defined qualities).

AMBITIOUS

Challenging enough that achievement would mean significant progress—a “stretch” for the organization.

REALISTIC

Not so challenging as to indicate lack of thought about resources, capacity, or execution; possible to track and worth the time and energy to do so.

TIME-BOUND

Includes a clear deadline.

INCLUSIVE

Brings traditionally disenfranchised people—particularly those most impacted—into processes, activities, and decision/policy-making in a way that shares power.

EQUITABLE

Seeks to address systemic injustice, inequity, or oppression.
