MEETING MINUTES

CALL TO ORDER

The meeting was called to order by Chair Kelsey Curran at 5:36 p.m. on January 21, 2015 with four voting Board members present: Augustine Grace, Dona Upson, Kelsey Curran, and Robert Goldstein; and one non-voting member present: Lenton Malry. Item #1 Approval of Agenda (Chair)


Chair Kelsey Curran adjourned the meeting at 6:35 p.m.
