Mr. Sanderoff's expert report and reliance documents were previously provided to all parties under N.O.I. and also is a part of the Tramway administrative record.

PETITION FOR HEARING

The Petitioners in this matter, Dempsey Powers, Andy Carrasco, and Pat Toledo, by and through undersigned counsel of record, pursuant to Section 74-2-7 NMSA 1978 and 20.11.81 NMAC, hereby petition the City of Albuquerque Environmental Health Department (EHD) and the Albuquerque-Bernalillo County Air Quality Control Board for a hearing as authorized by law with reference to Air Quality Permit No. 1677-M2 issued on April 30, 2013 to Smith's Food & Drug Centers, Inc. (Smith's), effective that date. A copy of Permit No. 1677-M2 is attached hereto as Exhibit 1. The permit modification authorized Smith's to increase the annual throughput to 5 million gallons per year at its fuel dispensing station located at 200 Tramway Blvd. SE, Albuquerque, New Mexico. In accordance with 20.11.81.14 NMAC, the Petitioners provide the following information.

II. Petitioner's participation in permitting action and how Petitioners were adversely affected by permitting action

(

Petitioner Dempsey Power lives in the neighborhood near the Smith's Tramway location. Because he lives in the vicinity of the Tramway location, the his quality of life would be adversely affected by the increased throughput of gasoline proposed by the requested permit modification. Mr. Power did not receive notice of the permitting action and was first made aware of it when he signed the attached "Petition to appeal Smith's permit for increase throughput." (Exhibit 2, attached). Mr. Power signed the Petition as a concerned citizen living in the neighborhood. If adequate notice had been provided and if a public information hearing had been held, Mr. Power would have participated and voiced his concerns about the proposed permit modification. Mr. Power was hindered in participating in the permitting process because of the City's failure to provide adequate notice of the permitting action. *Martinez v. Maggiore*, 2003-NMCA-043, ¶19, 133 N.M. 472.

On April 24, 2013, Petitioners Pat Toledo and Andy Carrasco participated in the permitting action by requesting, in writing, that a public information hearing be held regarding the Smith's Air Quality Permit No. 1677-M2 to the City of Albuquerque Environmental Health Department (EHD) Air Quality Division (AQD). (Exhibit 3, attached). The request was denied on May 14, 2013 by Mary Lou Leonard, Director of EHD. (Exhibit 4, attached). The revised permit was issued to Smith's on April 30, 2013, two weeks prior to the notice of denial of the request for a public information hearing. On May 23, 2013, Acting Deputy Director Danny Nevarez notified Mr. Toledo and Mr. Carrasco that the requested permit modification was issued "because the application was complete, the public notice requirements were met, the Department

conducted its review as required and there was no legal basis for the Department to deny the modification." (Exhibit 5, attached).

Mr. Toledo and Mr. Carrasco are adversely affected by the permitting action because they are members of the Albuquerque community who have an important interest in ensuring that the modifications to Smith's permit do not adversely affect the quality of life in Albuquerque. *Martinez v. Maggiore*, 2003-NMCA-043, ¶19, 133 N.M. 472. The Petitioners believe that the increased throughput at the Smith's Tramway location poses serious health, safety, and environmental hazards to any citizens who happen to be travelling near the facility. The various Smith's locations throughout the City of Albuquerque are managed through a common entity, the gasoline products are marketed jointly through the use of Smith's cards, and the impacts at this location are cumulative with the impacts from other locations.

III. Specific permitting action appealed from, permitting action to which Petitioners object and factual and legal basis of Petitioners' objections to the permitting action

The Petitioners are appealing the issuance of Permit 1677-M2, issued to Smith's on April 30, 2013, with notice provided to Petitioners Mr. Toledo and Mr. Carrasco on May 23, 2013. The Petitioners object to the issuance of the permit allowing for an increase in throughput from 3.9 million gallons a year to 5.0 million gallons at the Smith's location on Tramway and Central. The permit was issued without providing adequate notice and without allowing the public the opportunity to be heard at a public hearing prior to issuance of the modified permit. Permit No. 1677-M2 was issued pursuant to §20.11.41 NMAC, Authority to Construct. §20.11.41.14 requires public notice of the permitting action and requires a public hearing on permits involving a significant public interest.

Prior to reaching a final decision on the permit modification, the EHD did not take adequate measures to provide notice to individuals living in the vicinity of the Smith's Tramway facility, as evidenced by the Petition attached as Exhibit 2. The Petition states that "[t]he neighbors want a say in this decision as there was no public hearing and not adequate or proper notice." (Exhibit 2). Despite the fact that Mr. Toledo and Mr. Carrasco requested a public hearing, Mary Lou Leonard, the Director of the EHD refused to hold a hearing because she determined that "the Tramway GDF [gasoline dispensing facility] has not generated significant public interest." (Exhibit 4). Ms. Leonard states that she contacted "two neighborhood associations, three home owners' associations and one neighborhood coalition in the area surrounding the Tramway and Central SE gas station." (Exhibit 4). Because she only received "a few inquiries" from the associations, she determined that there was not significant public interest. (*Id*.).

There is no evidence that the EHD attempted to provide notice to individuals who live in the vicinity of the gas station. As shown by the Petition, there is in fact public interest in the matter. Because the EHD knew that there has been significant public interest in other similar permit modifications requested by Smith's at other Albuquerque locations, particularly in high volume, high impact retail gas stations, EHD should have taken additional measures to ensure that notice was provided to potentially interested persons. If such notice had been given, there would have been more public input, including requests for hearings and comments. Additionally, because the EHD was aware of the public interest generated by the proposals at other locations, the request for hearing made by Mr. Toledo and Mr. Carrasco should have been granted. However, because adequate notice was not provided and a hearing was not held, members of the public who are interested in proposed permit modification and who would have

participated in the process, were not provided the opportunity. *Martinez v. Maggiore*, 2003-NMCA-043, ¶19.

The purpose of regulatory provisions regarding public notice and hearings is to ensure that persons with an interest in the matter before the EHD be allowed to participate before a final decision is made. *Colonias Dev. Council v. Rhino Enviro. Services*, 2005-NMSC-024, 21, 138 N.M. 133. The New Mexico Supreme Court has recognized that "the public plays a vital role" in an administrative environmental permitting process and must be allowed a reasonable opportunity to be heard. *Id.* Administrative proceedings conducted subsequent to the failure to follow the requirements for public notice and hearing are invalid and cannot be upheld. *Martinez v. Maggiore*, 2003-NMCA-043, ¶13.

IV. Remedies sought by Petitioners, legal basis therefor, and basis for jurisdiction of Board in this matter

Based on *Martinez v. Maggiore*, 2003-NMCA-043, ¶13, and pursuant to 20.11.81 NMAC, the Petitioners request that the Permit 1677-M2, issued on April 30, 2013, be set aside and the matter remanded with directions to provide adequate notice and to hold a hearing pursuant to 20.11.41.14 NMAC.

Alternatively, also pursuant to 20.11.81 NMAC, the Petitioners request that Board set aside Permit 1677-M2 and hold a hearing on the merits of the Smith's permit application.

This letter is in response to your letter to me that is dated May 23, 2013, in which you stated you "are appealing the decision not to initiate a public hearing on the Smith's gas station request at Tramway and Central to increase there [sic] throughput from 3.9 million gallons a year to 5.0 million gallons..." As has been discussed with you several times, and as was stated by the hearing officer when you both attended the public information hearing (PIH) regarding Smith's Food & Drug Centers, Inc. (Smith's) application for an increase in gasoline throughput at the separate Smith's gas station at Carlisle and Constitution NE: a PIH is not a formal hearing on the merits. No findings or recommendations are made at the end of the PIH. The assigned City of Albuquerque (City) Environmental Health Department (Department) permit writer does not make a decision at the end of a PIH. The decision regarding whether a PIH is warranted under the circumstances is in the sole discretion of the Department Director.

The New Mexico Air Quality Control Act (Air Act), the City Joint Air Quality Control Board (Air Board) Ordinance (City Ordinance) and the applicable minor stationary source Air Board permitting regulation do not require a hearing or meeting before the permit writer makes a final decision regarding the pending application. The permitting regulation does require an application that is administratively complete, public notice published in the *Albuquerque Journal* and opportunity for public comment. The public notice must include specific information regarding the proposed permit or permit modification and must identify the manner in which comments or evidence on the application may be submitted to the Department. All legal requirements were met. The Department also included additional information in the public notice, such as the availability of the application for inspection and the deadline for public comment and requesting a public information hearing.

As you know from the May 14, 2013 letter that I sent to you, Air Board regulation 20.11.41.14.B NMAC states: "The department shall hold a public hearing if the director determines that there is significant public interest." Although the Department was not required to do so by the permitting regulation, the Department sent an email with an attached 8 $\frac{1}{2}$ " x 11" copy of the public notice to two neighborhood associations, three home owners' associations and one neighborhood coalition in the area surrounding the Tramway and Central SE gas station. As a result of the public notice and emails, the Department received a few inquiries from an officer with the Executive Hills Home Owners' Association and the President of the Four Hills Village Neighborhood Association. The Department responded to the inquiries and heard nothing more from any of the organizations that

surround the Tramway and Central SE gas station. No individual residing in the area submitted public comment or requested a PIH. As you know, the only requests for a PIH regarding the Tramway and Central SE gas station application for modification came from: Andy Carrasco, who owns a commercial property near the Smith's Carlisle and Constitution NE gas station, and Pat Toledo, who is a resident of the Summit Park NA in the area of the Carlisle and Constitution NE gas station.

Regarding your request for a PIH re the Tramway and Central SE gas station, and as I stated in the May 14 letter, I determined that the Tramway and Central SE application for modification did not generate "significant public interest". My decision in this matter is discretionary. No formal appeal process applies to the Department Director's decision not to hold a PIH. As you also know from the May 23, 2013 participant notification letter to you that was signed by Acting Deputy Director Danny Nevarez, the requested modification was issued because the application was complete, the public notice requirements were met, the Department conducted its review as required and there was no legal basis for the Department to deny the modification.

In Mr. Carrasco's challenge to the Carlisle and Constitution NE Smith's gas station application for modification, Mr. Carrasco was represented by attorney Pete V. Domenici, Jr. Mr. Domenici also submitted an extensive Inspection of Public Records Act request to the Department regarding all of the Smith's gas stations in Bernalillo County. We have received no notice that Mr. Domenici has withdrawn as Mr. Carrasco's attorney in the Carlisle and Constitution NE matter. We are sending Mr. Domenici a copy of this response letter so you can consult with him regarding the Smith's Tramway and Central SE matter, if appropriate.

Mr. Toledo and Mr. Carrasco are familiar with the permit proceedings for the permit modification at the Smith's fuel center located at 1313 Carlisle NE and will offer testimony about that proceeding. In addition, Mr. Toledo and Mr. Carrasco are familiar with Smith's overall fuel center operations in the City of Albuquerque and the permitting actions taken at additional locations within the City. They will discuss the fact that Smith's has an over-all, City-wide operation that includes the location of fuel dispensing operations at or near existing store locations. The fuel centers either re-furbish small, existing gas stations or are newly constructed fueling centers in locations where such operations did not formerly exist. Smith's cross-markets between the various fueling center locations. The creation of the fueling centers by Smith's has raised numerous issues regarding building permits, zoning codes, and traffic, as well as concerns for air quality and air quality permitting. These concerns are reflected in the exhibits which will be introduced by the Petitioners.

Expert Report

My name is Brian Sanderoff, I have been President of Research & Polling, Inc. for 27 years. Research & Polling, based in Albuquerque, specializes in market research, public opinion, and demographic analysis in New Mexico. One of our areas of focus is to advise businesses, organizations, and advertising agencies as to the best means to reach their target audience. Our clients include Intel, Presbyterian Healthcare Services, Sandia National Laboratories, Los Alamos National Laboratory, and PNM. I have served as the pollster/public policy analyst for the Albuquerque Journal for 27 years and for KOAT TV for over a decade. I have been qualified as an expert witness over 40 times since 1992 in both state and federal district court in areas of survey research, demographic analysis and redistricting. I received a BA in Political Science from the University of New Mexico and attended graduate school in the Political Science Department at UNM.

I have been hired by attorney Pete Domenici, Jr. to review and comment on the sufficiency of the City Environmental Health Department's Air Quality Division public notice to inform the general public regarding Smith's Food and Drug & Center's Air Quality Permit regarding a gasoline dispensing facility located at 200 Tramway Boulevard SE, Albuquerque, New Mexico. I have been asked to give my opinion as to whether the City's dissemination of information regarding the public notice is sufficient for the City to determine whether the permitting activity has generated sufficient public interest.

Albuquerque-Bernalillo County Air Quality Board regulation 20.11.41.14.A.(3) requires the Department to publish a public notice in a local newspaper of general circulation within 15 days

after the Department deems an application complete. The Department did publish a notice in the Albuquerque Journal's Legal Section on March 11, 2013.

Additionally, according to a May 23rd, 2013 letter from the Acting Deputy Director of the Air Quality Programs to Mr. Andy Carrasco, the Department sent copies of the public notice to surrounding neighborhood associations and communicated with, via email, "interested community members" of two neighborhood associations. However, there are large residential subdivisions immediately east of the Smith's property that are not affiliated with any neighborhood association (see exhibits 1 and 2). They are not within the boundaries of the neighborhood association, Executive Hills Village Homeowners Association, Four Hills Village Neighborhood Association, Executive Hills Homeowners Association) that received a notice from the City. These residential subdivisions in question have a population of 656 individuals (see exhibit 3). There are also a number of hotels immediately northwest of the Smith's gas station that are not located within any of the neighborhood associations contacted.

Albuquerque-Bernalillo County Air Quality Board regulation 20.11.41.14.A.(4) requires the Department to "allow **all interested persons** (emphasis added) at least forty-five but no more than sixty days from the date an application is deemed complete to submit written comments, evidence or to request a public hearing on the application."

Albuquerque-Bernalillo County Air Quality Board regulation 20.11.41.14.B. states that "The Department shall hold a public hearing if the director determines that there is significant

public interest. (emphasis added) Further, in this section it states, "At the hearing, **all interested persons** (emphasis added) shall be given a reasonable opportunity to submit data, views or arguments orally or in writing and to examine witnesses testifying at the hearing."

In a letter dated May 14th, 2013, from the Director of the City Environmental Department to Mr. Pat Toledo, the Director stated that "I have determined (emphasis added) that the Tramway GDF permitting activity has not generated sufficient public interest (emphasis added). Therefore....your request for a PIH...has been denied."

One issue that I was asked to address is whether publishing a public notice in the Legal Section of the Albuquerque Journal is sufficient to reach the general public and potentially all interested persons in this application permit.

The Legal Section of the Albuquerque Journal typically contains numerous pages of densely packed columns with a very small font size that are designed to be read by specialized professions. For example, state and local governments are required to give notice in the Legal Section when they issue a Request for Proposal for interested vendors to bid on various types of commodities and professional services. As a result, each day potential bidders such as architect and engineering firms, construction companies and other specialized businesses read the Legal Section. These legal notices increase and improve the transparency of governmental entities. Since bidders the opportunity to identify bids that are being issued by governmental entities. Since bidders are aware of how the notification system works, they are prepared to review the Legal Section in order to identify potential business with public entities.

In other instances the Legal Section is utilized by public entities and others to "go on record" and publish an item as a matter of record, as required by the law. However in the case of the Air Quality Permit requested by Smith's the bar is being set much higher by the regulations. The Director is mandated to decide whether significant public interest exists in order to determine whether a public hearing should be conducted. In order to determine whether significant public interest exists and whether the sufficient public interest has been generated, it is necessary to ask whether the Legal Section alone is a good mass media tool to inform the general populace of the permit application.

In Martinez v. Maggiore, 64P.3d 499, 133 NM 472,2003 NMCA 43 (NM App., 2002) the New Mexico Court of Appeals commented that, "We think that the Legislature (emphasis added), in enacting Subsection 74-9-22(C), recognized that most members of the general public do not routinely read the legal or classified advertisement sections of the newspaper, (emphasis and Store Clarker added) Mullane v. Central Hanover Bank & Trust Co., 339 U.S. 306, 315, 70 S.Ct. 652, 94 L.Ed. 865 (1950) (noting that "[c]hance alone brings to the attention of even a local resident an advertisement in small type inserted in the back pages of a newspaper"), and that publication of a notice of application for a landfill permit would reach more members of the general public, if, (emphasis added) in addition to publication in the legal or classifieds advertisements, the notice were to be published "at one other place in the newspaper calculated to give the general public the most effective notice (emphasis added)." The Court of Appeals opinion further states that other broader statutes that require additional advertising for public notice, besides the Legal Section, clearly contemplated the "small type in the back pages of the newspaper" as a "purely constructive form of notice" (emphasis added).

. . .

I concur with the observation of the NM Court of Appeals that most members of the general public do not routinely read the legal section of a newspaper. Further, I believe that the very small font size of the Legal Section and the location of the Legal Section within the newspaper further discourages readership. Within the Albuquerque Journal, the Legal Section shifts from Section C, D and G, depending upon the day of the week, further creating reader confusion. Although publishing in the Legal Section satisfies the narrow legal requirement of the City, it does not, in my opinion, provide enough dissemination of information or public notice for the Department Director to determine whether **significant public interest** exists to determine whether or not to conduct a public hearing. How can the Director determine whether significant public interest exists if they relied primarily on a one day publication of the notice in the Legal Section of the Albuquerque Journal?

Additionally, the county regulations quoted above state that "all interested persons (emphasis added) should be given a reasonable opportunity to submit data, views or arguments orally or in writing and to examine witnesses testifying at the hearing." The question arises whether all interested persons were even aware of the permit application, given that the only mass media notice was a single day insertion in the Legal Section of the newspaper of general circulation.

Also, an industry wide trend has been negatively impacting circulation of newspapers throughout the nation. The Albuquerque Journal has not been immune to this phenomenon. Despite the population growth of Albuquerque Metro area, paid circulation for the Sunday Journal has declined by 31% since 2006 (See exhibits 4 and 5).

According to US Census data compiled by Research & Polling, the total adult population within the geographic boundaries of the East Gateway Coalition is estimated to be 45,805 (see exhibit 3). The entire statewide circulation of the Sunday Albuquerque Journal is 103,692 (see exhibit 5). Thus market penetration of the Albuquerque Journal is not comprehensive enough to rely on in order to identify "all interested persons" within the East Gateway area. And, if one wanted to rely on a single media source to inform a large segment of the affected area, it would have been necessary to place, for example, a quarter page advertisement in a more frequently read section of the newspaper, such as in Section A.

There are many inexpensive methods that the City could utilize to increase public awareness of Air Quality Permit applications in the neighboring areas that would be potentially impacted. These would include:

 Posting notices in all city and county libraries, community centers and police substations within a certain radius of the applicant's location,


- 2) Mailing a postcard containing the public notice to all neighboring businesses and residential areas utilizing carrier route information available from the post office,
- Asking Smith's to circulate flyers in their Tramway grocery store and gas station to all interested customers,
- Inserting a second advertisement in the Albuquerque Journal outside of the Legal Section to supplement the initial posting, and
- Renting a billboard or pony panel in the neighborhoods immediately adjacent to the Smith's property.

Summary Opinion

Legal notices published in the Legal Section of the newspaper of general circulation serves various purposes. Primarily, they are utilized for government entities to "go on record" or to communicate with specialized groups of vendors. However, public notices published in the Legal Section should not be relied on by city officials to determine whether sufficient public interest exists to decide whether or not to call a public hearing. It is not possible to determine whether sufficient public interest exists by primarily relying on this approach. Significant public interest cannot be measured in this manner since the general public does not read the Legal Section, in my opinion and in the opinion of the Court of Appeals. In order for the city to be more transparent and to measure true public interest among the general public they should do more, especially in circumstances in which government officials then have the statutory responsibility to make determinations about whether to hold a public hearing based upon this inadequate dissemination of information.

There is a Valero and a Giant station at Eubank and Central. The Valero recently modified its permit to increase its gasoline throughput to 3,000,000 gallons per year and is now permitted to emit 20 tons of VOC per year. The Giant is permitted for 2,400,000 gallons per year throughput and is permitted to emit 15.6 tons of VOC per year.

You submitted to the Air Quality Division (Air Division) of the City of Albuquerque (City) Environmental Health Department (Department) written comment regarding Smith's application for modification of Authority-to-Construct Permit No. 1677-M1 on Wednesday, April 24, 2013. The application requested a permit modification that would authorize Smith's to increase the annual throughput of gasoline from 3,900,000 gallons per year to 5,000,000 gallons per year for the fuel dispensing (gas) station located at 200 Tramway Blvd SE (Facility).

An air quality stationary source permit can address only air pollution issues and only to the extent authorized by the federal Clean Air Act (CAA), the New Mexico Air Quality Control Act (NM Air Act), the City Joint Air Quality Control Board Ordinance (Ordinance), and applicable Albuquerque - Bernalillo County Air Quality Control Board (Air Board) regulations. An air quality stationary source permit cannot address congestion and public safety issues included in your written request.

The primary regulated air pollutants emitted at gas stations are volatile organic compounds (VOCs). The Clean Air Act and 40 CFR 50 do not establish ambient concentration standards for VOCs. VOCs are not controlled in the same manner as pollutants that are subject to the national ambient air quality standards (NAAQS). Therefore, a VOC emission standard cannot be "exceeded" in the same manner as a NAAQS standard. Air dispersion modeling is not required by the federal Environmental Protection Agency (EPA) when an application for a gas station air quality Authority-to-Construct Permit or modification is submitted to the Air Division. Unlike NAAQS, there are no enforceable ambient VOC emission standards that can be the basis for denying a VOC permit or an application for modification of an existing gas station VOC permit. For purposes of air quality gas station permits issued by the Department, VOC emissions from gas stations are controlled by using federallyrequired "performance based" standards, which are found at 40 CFR 63, Subpart CCCCCC and locally-required 20.11.65 NMAC and 20.11.64 NMAC. Performance based standards for a gas station like the Smith's station on Tramway include fuel throughput maximums, vapor recovery systems, and work practice standards. The

VOC tons-per-year numbers in gas station air quality permits are used for calculating annual emission fees. The VOC tons-per-year numbers in the permits are not emission maximums. Again, federally and locally-required controls for VOCs emitted by gas stations like Smith's are "performance based" requirements.

The decision of the Department regarding Smith's application for a permit modification is based on the requirements of the CAA, the NM Air Act, the Ordinance, and applicable Air Board regulations, including 20.11.41 NMAC, which is the Air Board "Authority to Construct" permit regulation, also known as "Part 41".

Before the Department made a decision regarding the application, the Department considered whether the application complied with the technical requirements of the CAA, of the NM Air Act, the Ordinance and applicable Air Board regulations.

As a part of the application review process, the Air Division established an "administrative record" regarding the permit modification application. The administrative record includes the application, evidence submitted by the applicant and all written comments and evidence received by the Air Division.

Before the Department made a decision, Air Division staff reviewed the administrative record. Additionally, the Air Division communicated with interested community members representing the Four Hills Village Neighborhood Association and the Executive Hills Home Owners Association via emails.



MEMORANDUM OPINION

7 FRY, Judge.

8 This case is an administrative appeal from the Albuquerque-Bernalillo County {1} Air Quality Control Board's (the Board) dismissal of Petitioners' petition for a 9 10 hearing based on lack of standing. Petitioners were challenging Smith's Food and 11 Drug Centers, Inc.'s permit modification request that would allow it to increase the amount of fuel it dispensed at a filling station located near the intersection of Central 12 13 and Tramway in Albuquerque, N.M. Petitioners argue that the Board erred in 14 dismissing their petition because, in regard to Petitioners Toledo and Carrasco, they 15 were adversely affected by the City of Albuquerque Environmental Health 16 Department's (EHD) refusal to hold a public hearing, and, in regard to Petitioner 17 Power, his failure to participate in the permitting action was due to inadequate notice. We conclude that the Board properly determined that Petitioner Power did not have 18 standing to appeal the issuance of the permit because he failed to show that his failure 19 to participate in the permitting action was due to legally insufficient notice. 20 However, we conclude that the Board erred in determining that Petitioners Toledo 21

and Carrasco did not have standing to appeal the EHD's refusal to hold a public
 hearing. Accordingly, we reverse in regard to Petitioners Toledo and Carrasco and
 affirm in regard to Petitioner Power.

4 BACKGROUND

5 [2] Smith's submitted an application to the EHD to modify an existing air quality 6 permit to allow it to increase the amount of fuel it dispensed at the filling station at 7 issue. The EHD published notice of the permit modification request in the legal 8 section of the Albuquerque Journal and also sent notice to local neighborhood 9 associations in the area surrounding the filling station. The notice provided that the 10 public had the opportunity to comment on the requested modification until April 24, 11 2013.

12 [3] Petitioners Toledo and Carrasco became aware of Smith's permit modification
13 request and submitted written objections to the modification. They also requested
14 that a public hearing be held on the permit modification. In addition to Petitioners
15 Toledo and Carrasco's comments, the EHD received a few questions from the local
16 neighborhood associations. The EHD answered these questions, and no more action
17 was taken by these groups. Following the end of the comment period, the EHD
18 determined that there was not significant public interest in Smith's permit

modification request and denied Petitioners Toledo and Carrasco's request for a
 public hearing. The EHD granted Smith's permit modification request.

The EHD notified Petitioners Toledo and Carrasco that because they 3 *{*4*}* participated in the permitting action, they were entitled to petition for a hearing before 4 the Board to review the EHD's decision to grant the permit modification. Petitioners 5 filed a petition-including Petitioner Power, who did not participate in the initial 6 permitting action, as a petitioner-and alleged that the permit modification was 7 issued "without providing adequate notice and without allowing the public the 8 opportunity to be heard at a public hearing prior to [its] issuance." Petitioners Toledo 9 and Carrasco further alleged that they were "adversely affected by the permitting 10 action because they are members of the Albuquerque community who have an 11 important interest in ensuring that the modifications to Smith's permit do not 12 adversely affect the quality of life in Albuquerque." Petitioner Power alleged that he 13 was prevented from participating in the permitting action due to inadequate notice. 14 Petitioners requested that the Board set aside the permit modification due to the 15 EHD's failure to provide adequate notice and hold a public hearing. 16

The Board set a hearing on the merits of Petitioners' petition. Petitioners filed
notice with the Board limiting the issues to be heard to whether the EHD provided
adequate notice and whether it erred in refusing to hold a public hearing. Prior to the

hearing, Smith's filed a motion to dismiss, arguing that the Petitioners lacked
 standing to challenge EHD's grant of the permit modification. The Board held a
 hearing on Smith's motion to dismiss nearly two weeks before the hearing scheduled
 for the merits of the petition. The Board ultimately determined that Petitioners lacked
 standing because Petitioner Power did not participate in the permitting action and
 Petitioners Toledo and Carrasco did not show that they were adversely affected by the
 EHD's actions. Petitioners now appeal.

8 DISCUSSION

9 Standard of Review

10 [6] This Court will set aside the Board's action if the action is found to be "(1)
11 arbitrary, capricious, or an abuse of discretion; (2) not supported by substantial
12 evidence . . .; or (3) otherwise not in accordance with law." NMSA 1978, § 74-213 9(C) (1992). In this case, Petitioners argue that the Board incorrectly applied the law
14 of standing to dismiss their administrative appeal. We review whether a party has
15 standing de novo. *Prot. & Advocacy Sys. v. City of Albuquerque*, 2008-NMCA-149,
16 ¶ 17, 145 N.M. 156, 195 P.3d 1.

17 {7} "Standing is a judicially created doctrine designed to insure that only those
18 with a genuine and legitimate interest can participate in a proceeding." *Id.* ¶ 18
19 (internal quotation marks and citation omitted). Generally, to establish standing,

litigants must "allege three elements: (1) they are directly injured as a result of the
 action they seek to challenge; (2) there is a causal relationship between the injury and
 the challenged conduct; and (3) the injury is likely to be redressed by a favorable
 decision." ACLU of N.M. v. City of Albuquerque, 2008-NMSC-045, ¶ 1, 144 N.M.
 471, 188 P.3d 1222.

6 [8] We accept the material allegations of the petition as true and construe the
7 petition in favor of the complaining party. *Prot. & Advocacy Sys.*, 2008-NMCA-149,
8 ¶ 17. However, we are not limited to the allegations of the petition and may review
9 any supplementation to the petition by the petitioner with affidavits or particularized
10 allegations of fact in order to determine whether standing exists. *Id.* If, after a review
11 of all materials of record, standing is not established, the petition must be dismissed.
12 *Id.*

13 Standing Under the Air Quality Control Act

14 [9] NMSA 1978, Section 74-2-7(H) (2003), provides that "[a] person who
15 participated in a permitting action before the department or the local agency and who
16 is adversely affected by such permitting action may file a petition for hearing before
17 the environmental improvement board or the local board." The statute therefore
18 contains two prerequisites for seeking review by the Board. First, the person must
19 have participated in the permitting action. *Id.* Second, the person must have been

adversely affected by the action. *Id.* We review Petitioners' arguments according to
 these two requirements. We begin with Petitioner Power's argument that inadequate
 notice prevented him from participating in the permitting action. We then consider
 Petitioners Toledo and Carrasco's argument that they were adversely affected by the
 action.

6 Petitioner Power

Petitioner Power argues that he was prevented from participating in the 7 {10} permitting action because he did not receive notice of the permitting action. 8 Petitioner Power does not argue that the EHD's notice of the permitting action was 9 10 legally insufficient under the then-applicable regulation pertaining to the provision of public notice. See 20.11.41.14(A)(3) NMAC (10/1/02) (requiring that notice be 11 published "in a local newspaper of general circulation" and include "the name and 12 address of the applicant, location of the source, a brief description of the proposed 13 construction or modification, a summary of the estimated emissions and shall identify 14 the manner in which comments or evidence on the application may be submitted to 15 the Department"). In fact, Petitioners conceded below in their answers to requests for 16 admissions that EHD's notice complied with the regulation. Instead, Petitioner Power 17 18 argues that preventing people who did not receive notice from participating in an

appeal forecloses any opportunity to challenge the method in which notice was
 provided.

We are unpersuaded by Petitioner Power's argument. Participation in the 3 {11} permitting action is a statutory prerequisite to appealing to the Board. Section 74-2-4 7(H). The EHD is not tasked with ensuring that every person who might be affected 5 6 by the permitting action actually receive notice. And allowing every person who does not actually receive notice to appeal to the Board would obviate the statutory 7 requirement that the petitioner participated in the permitting action. Furthermore, it 8 was undisputed here that EHD complied with its regulation in providing notice to the 9 10 public. Accordingly, because Petitioner Power did not participate in the permitting action, the Board correctly determined that he did not have standing to challenge the 11 12 permit modification.

13 Petitioners Toledo and Carrasco

14 [12] Petitioners Toledo and Carrasco, who actually participated in the permitting
action, argue that they were adversely affected by the permitting action due to the
EHD's failure to provide adequate public notice and hold a hearing prior to the
issuance of the permit modification. We have already decided that there is no viable
dispute regarding public notice. In regard to the EHD's refusal to hold a public

hearing, Petitioners argue that the EHD's action prevented them from presenting
 comments and evidence on the proposed permit modification.

In order to establish that one is adversely affected, the person must show that 3 {13} the injury complained of is within the zone of interests sought to be protected by the 4 statute at issue. N.M. Cattle Growers' Ass'n v. N.M. Water Quality Control Comm'n, 5 6 2013-NMCA-046, ¶ 10, 299 P.3d 436, cert. quashed 2013-NMCERT-010, 313 P.3d 251. Thus, Petitioners' argument implicates the first element of standing: whether 7 Petitioners have alleged an injury in fact. For this element, it has always been a 8 requirement that the litigant allege a direct injury, even if the extent of that injury is slight. ACLU, 2008-NMSC-045, ¶ 11. The injury must be actual or imminent. Id. 10 ("Rather, the litigant need only show that he is imminently threatened with injury, or 11 ... that he is faced with a real risk of future injury, as a result of the challenged action 12 or statute." (internal quotation marks and citations omitted)). 13 A "general, undifferentiated threat of a hypothetical harm" will not suffice. Id. ¶ 18. A plaintiff 14 has standing to protect himself or herself against "injury as a result of unlawful 15 governmental action." De Vargas Sav. & Loan Ass'n of Santa Fe v. Campbell, 1975-16 NMSC-026, ¶ 13, 87 N.M. 469, 535 P.2d 1320. 17

18 {14} As stated above, Petitioners argue that their injury was the denial by the EHD
19 of their request for a hearing. Respondents, on the other hand, argue that Petitioners

cannot establish standing because they cannot show that an increase in throughput 1 (the amount of fuel dispensed) would directly and concretely injure them. 2 Respondents further argue that Petitioners' alleged injury is insufficient to establish 3 standing because the EHD properly exercised its discretion in denying their request 4 for a hearing. See 20.11.41.14(B) NMAC (10/1/02) (stating that the EHD "shall hold 5 a public hearing if the director determines that there is significant public interest"). 6 Stated another way, Respondents argue that because the decision to grant a hearing 7 is discretionary, the denial of a request for such a hearing cannot, as a matter of law, 8 establish an invasion of a legally protected interest. 9

We disagree with Respondents. Given that Petitioners are only requesting the 10 {15} Board to review whether the EHD's refusal to hold a hearing was proper, the issue 11 of standing in regard to these Petitioners presents a relatively succinct procedural 12 issue: whether Petitioners were adversely affected by the denial of their request for 13 a hearing. The determination of this issue does not require this Court to review 14 whether Petitioners would be adversely affected by any alleged environmental 15 impacts of the permit modification or whether the EHD properly exercised its 16 discretion, the latter being the exact issue Petitioners appealed to the Board. 17

18 {16} We therefore conclude that Petitioners had standing to request the Board to 19 review whether the EHD properly refused Petitioners' request to holding a public

hearing. It would be anomalous to conclude that members of the public whose 1 request for a hearing was denied by the EHD were not "adversely affected" by that 21 decision. The Petitioners are members of the public that live within the EHD's 3 jurisdiction. They were not barred from requesting such a hearing, and the regulations 4 in effect at the time did not limit those who could request a public hearing to only 5 6 members of the public who could establish that they would experience an adverse impact from the permit modification. 20.11.41.14 NMAC (10/1/02). Instead, such 7 a hearing, if granted, could conceivably give a member of the public the opportunity 8 to present comment or evidence on what would otherwise seem to be an attenuated 9 harm from a proposed permit. Thus, because Petitioners are members of the public 10 living within the EHD's jurisdiction and requested a hearing, they had standing to 11 appeal this narrow procedural issue that arose due to the EHD's denial of their request 12 for a hearing. Concluding otherwise would give unfettered discretion to the EHD in 13 the determination of when significant public interest exist to hold a public hearing 14 because, as Respondents conceded at oral argument, it would foreclose the 15 opportunity for review of the EHD's determination by the Board based on factors 16 unrelated to this specific issue. 17

18 {17} To clarify, we conclude only that Petitioners Toledo and Carrasco made a
 19 sufficient showing that they have standing to allow them to argue their case before

the Board on its merits. We have thus only considered whether these Petitioners were 1 adversely affected by the EHD's actions, not whether the EHD properly denied their 2 request for a public hearing. Petitioners Toledo and Carrasco limited the issues 3 before the Board to public notice and the refusal to hold a public hearing. We 4 conclude above that there is no viable dispute regarding public notice. Therefore, on 5 remand, the Board should determine whether Petitioners Toledo and Carrasco's 6 request for a public hearing, together with the emailed questions received by the EHD 7 from the local neighborhood associations, constituted "significant public interest" to 8 necessitate a public hearing. 9

10 CONCLUSION

11 {18} For the foregoing reasons, we remand to the Board to hold a hearing on the
12 merits of whether the EHD improperly refused to hold a public hearing.

13 {19} IT IS SO ORDERED.

ORDER SCHEDULING REMAND HEARING

Following receipt of the Mandate to the Air Quality Control Board from the New Mexico Court of Appeals, dated April 9, 2015, the Hearing Officer conferred with Counsel for all parties, Mr. Toledo and City staff on April 30, 2015.

All were agreed that a hearing on the merits would be scheduled for July 8, 2015, in connection with the Board's regularly scheduled meeting beginning at 5:30 p.m. Pursuant to paragraph 17 of the Court's Memorandum Opinion of November 26, 2014, the scope of the Board's inquiry at the hearing is limited to "whether Petitioners Toledo and Carrasco's request for a public hearing, together with the emailed questions received by the EHD from the local neighborhood associations, constituted 'significant public interest' to necessitate a public hearing." Accordingly, the evidence and testimony presented at the hearing shall be limited to that which is relevant to this specific question.

In order to provide the Board with the evidence the Parties will be presenting in time for their review prior to the hearing, and to provide the parties with notice of, and an opportunity to object to, each other's anticipated witnesses and exhibits, the following deadlines are set for witness and exhibit lists: Petitioners shall submit their witness and exhibit list by close of business June 10, 2015. Written objections to Petitioners' witness and exhibit list shall be filed by close of business June 17, 2015. The City and Smith's shall submit their witness and exhibit lists and exhibit lists by close of business June 24, 2015. Written objections to the City's or Smith's witness and exhibit lists shall be filed by close of business June 24, 2015. The Hearing Officer will hold a telephonic hearing on July 2, 2015 at 1 p.m. to hear argument and rule upon any timely submitted pre-hearing objections.

Witness and exhibit lists shall include the names and narrative testimony of all proposed witnesses presenting testimony, and all proposed exhibits intended to be offered shall be attached.

The City shall timely publish and mail notice of the July 8, 2015 hearing.

To the extent not otherwise addressed in this Order, the July 8, 2015 hearing shall be governed by the Board's adjudicatory procedures set forth in 20.11.81 NMAC.
