MINUTES – June 30, 2025

This Albuquerque-Bernalillo County Air Quality Control Board (“Board”) special meeting was conducted in a virtual format via Zoom video conference.

I. CALL TO ORDER

Approval of the June 30, 2025 Meeting Agenda

After a bit of discussion, he amended the motion to include the caveat that the map doesn’t exclude any of the currently existing overburdened area tracts. Member Galewsky seconded. The motion passed by the following vote:
