PETITION TO AMEND 20.11.46 NMAC

- Western Backstop ("WEB") SO₂ Trading Program
- Regional Haze Rule, 40 CFR § 51.309
- Regional Haze SIP
- Regional SO₂ milestones, emissions tracking requirements and backstop regional cap-and-trade program

PETITION TO AMEND 20.11.46 NMAC

- ~20.11.46 NMAC incorporates Regional Haze Rule requirements
 - Emissions inventory requirements for tracking compliance with the SO₂ milestones
 - Requirements that apply to major sources of SO₂ emissions as a "backstop" regulatory program if specified milestones exceeded
 - Trigger for the procedures and compliance requirements for sources in the trading program

Reasons for Proposed Amendments to 20.11.46 NMAC

- Compliance with 40 CFR § 51.309
- National goal for visibility protection
- 2003 & 2008 amendments have not been approved by EPA
- Backstop trading rules must be consistent across all remaining "309 states"

Proposed Amendments to 20.11.46 NMAC

Remove definitions

- "Allowance Tracking System"
- "Allowance Tracking System Account"
- "Emissions Tracking Database"

∼Add definitions

- "WEB Emissions and Allowance Tracking System" / "WEB EATS"
- "WEB EATS Account";
- Clarifying that "retirement" of a source must be "permanent"

Proposed Amendments to 20.11.46 NMAC

- Align with Utah's trading rule
 - Allowance Allocations
 - F Establishment of Accounts
 - Monitoring, Record Keeping and Reporting
 - ** Use Of Allowances From A Previous Year
 - Provisions For Year 2018 Milestone
- Align with Wyoming's trading rule
 - ** SO₂ Monitoring of Fuel Gas Combustion Devices
 - Predictive Flow Monitoring Systems For Kilns With Positive Pressure Fabric Filter

PETITION TO AMEND 20.11.46 NMAC

- Amend 20.11.46 NMAC, Sulfur Dioxide Emissions Inventory Requirements; Western Backstop Sulfur Dioxide Trading Program, and incorporate amendments into the SIP
 - Legally noticed
 - **Responded to comments
 - Amend 20.11.46 NMAC, and incorporate an amended 20.11.46 NMAC into the SIP
