3. EHD shall file a reply in support of its motion for discovery by January 15, 2016.
4. SWOP shall file its amended Notice of Intent to Present Technical Testimony (NOI) by January 29, 2016.
5. EHD shall file its amended NOI by February 19, 2016.
6. The deadline to file motions in limine is March 18, 2016. Responses to motions in limine shall be filed by April 1, 2016, and replies may be filed until April 14, 2016.

9. The City shall timely publish and mail notice of the change in hearing date.
10. Provisions from earlier Prehearing Orders not revised above remain in effect.
