I like the "if required by the department" proposed change from "annual" GHG reporting requirement in 20.11.47 NMAC.

At a stakeholder meeting on the initial version of this regulation, I remember asking if AQD had a plan to roll out/explain to the regulated community AQD's regulatory intent, AQD's expectation of regulated sources, and answer questions from the regulated community. The answer at that time was "yes, we'll certainly do that". However, I don't remember seeing any AQD notice for such a roll out meeting since then.
