

#### **DRAFT MEETING MINUTES**

#### **CALL TO ORDER**

Chair Miano called the meeting to order at 5:31 p.m. on May 9, 2018.

#### Item #1 Approval of Agenda (Chair)

Member Everson moved to approve the agenda and Member Wiley seconded. The motion passed by a vote of 6-0.

#### Item #2 Approval of April 11, 2018 Meeting Minutes (Chair)

Member Wylie moved to approve the April 11, 2018 meeting minutes and Vice Chair Mack seconded. The motion passed by a vote of 5-0, with Member Everson abstaining.

#### **PUBLIC COMMENT**

Following public comment, Member Buffett requested that Board attorney Orth report back to the Board on conduct of Public Information Hearings for air quality permit applications under 20.11.41 NMAC, *Construction Permits*.

Member Buffett moved to accept additional public comment specifically related to agenda item # 3, immediately following Dr. Kelly's presentation. Vice Chair Mack seconded. The motion passed 6-0.

#### Item #6

Presentation by Kathryn Kelly, Dr.P.H., President, Delta Toxicology, Inc. – Introduction to the EPA's National Air Toxics Assessment ("NATA") Database and Other Tools to Examine Cumulative Impacts: What Do We Know, What Do We Want to Know

Dr. Kelly presented an overview of NATA as a tool for examining cumulative impacts from air contaminants. Following her presentation, Dr. Kelly, Mr. Nevarez, and Department attorney Ms. Carol Parker responded to questions from the Board.

Chair Miano asked Department staff to provide Board members with a digital copy of two documents referenced in Dr. Kelly's presentation: the 2010 Community Scale Air Toxics Monitoring study and a 2015 article summarizing results of the 2010 study.

Members of the public then commented on the presentation. The commenters were: Ms. Marla Painter; Ms. Kitty Richards; Ms. Nora Garcia; Mr. Steven Abeyta; Ms. Esther Abeyta.

#### **OTHER BUSINESS**

Chair Miano asked Board members what kind of follow up they would like to see regarding Dr. Kelly's presentation.

The Board members agreed that Dr. Kelly should appear at a future meeting to present detailed NATA data on Albuquerque and Bernalillo County.

Member Buffett requested that the agenda for this future meeting include an opportunity for Board members to ask follow up questions about Dr. Kelly's presentation at the May 9 meeting.

Mr. Nevarez informed Chair Miano of a request from Ms. Marla Painter. Ms. Painter requested inclusion of an additional presenter on the agenda of the future meeting at which Dr. Kelly will appear. The additional presenter would address the topics discussed during and after Dr. Kelly's May 9 presentation. Mr. Nevarez indicated that Ms. Painter and the Department would be in contact to identify an additional presenter.
