

PUBLIC NOTICE
Air Quality Construction Permit for
U.S. Air Force - Kirtland Air Force Base (AFB)

U.S. Air Force - Kirtland Air Force Base (AFB) submitted an application to modify an air quality construction permit to the Air Quality Program (Program) of the City of Albuquerque Environmental Health Department. The Program received the application on July 13, 2026. The owner of the facility is U.S. Air Force - Kirtland Air Force Base (AFB), 377 MSG/CEIEC, 2050 Wyoming Blvd. SE, Suite A-112, Kirtland AFB, NM 87117. The facility, 898th Munitions Squadron, is located at 7500 Prairie Road, Bldg. 27497 Kirtland AFB, NM 87117. This application file has been assigned Permit Application #3470-M1. The Program has made an affirmative administrative completeness determination and is providing this notice pursuant to 20.11.41.14 NMAC.

The applicant is requesting a modification to Permit #3470. The applicant is requesting the following.

- *To consolidate permitted equipment and operational limits under Permit 3470 by incorporating gasoline dispensing operations originally authorized under Permit #3101-2AR.*
- *Permit #3101-2AR currently authorizes gasoline dispensing equipment and a boiler that has since been permanently removed from service. The removed boiler has been replaced with two comfort heat boilers that are exempt from permitting requirements and are identified in application forms.*
- *To reduce operating limits for the existing emergency generator authorized under Permit #3470 from 200 hours per year to 100 hours per year.*
- *Increase in the annual throughput for gasoline dispensing operations from 20,000 gallons per year to 30,000 gallons per year.*

The public will have no fewer than 30 days to submit written comments and evidence, request a public information hearing, or both on the permit application to the Program. Comments will be accepted and considered if postmarked by the end of the public comment period. Formal action on the application will be reserved pending receipt and analysis of any additional details or information developed during the public comment period. Any person who does not participate in the permitting action will not receive notification of the Program's decision regarding the proposed permit, unless the person has delivered a written request for notice to the department. The application, all supporting documentation, and the public notice are available online at <https://www.cabq.gov/airquality/air-quality-permits>.

The Program shall hold a Public Information Hearing pursuant to 20.11.41.15 NMAC if the Director determines there is significant public interest and a significant air quality issue is involved.

The Program expects to issue, issue subject to conditions, or deny this application before December 03, 2026. The Program will not issue any air quality permit with or without conditions unless an air quality ambient impact dispersion modeling study, if deemed necessary by the Program, shows that the facility would not cause or contribute to a potential violation of air quality standards. If the Program issues the permit with conditions, the conditions will include those that limit the emissions, and conditions that will require recordkeeping and reporting to the Program to ensure compliance with federal and local air regulations.
