PUBLIC NOTICE Air Quality Construction Permit For NuStar Energy, L.P.

NuStar Energy, L.P. submitted an application to modify an air quality construction permit to the Air Quality Program (Program) of the City of Albuquerque Environmental Health Department. The Program received the application on May 5, 2023. The owner of the facility is NuStar Energy, L.P., 19003 IH-10 West. The facility, NuStar Energy, L.P., is located at 6348 Desert Rd SE. This application file has been assigned Permit Application No. 0500-M4. The Program has made an affirmative administrative completeness determination and is providing this notice pursuant to 20.11.41.14 NMAC.

The applicant is requesting a modification to Permit #0500-M3-3AR. The proposed changes are associated with the New Mexico Biodiesel Blend Mandate, which will require all diesel fuel sold for use in on-road motor vehicles to state agencies, political subdivisions of the state and public schools to contain at least 5% biodiesel (B5)

The permit will be updated to include the following changes to product storage and loadout:

- Tank 3M1 will be converted to store pure biodiesel (B100).
- Tank 10M2 will be converted to a slop tank.
- Approximately 18 fugitive components will be added, all in light liquid service, to complete the following:
 - Extend the two slop lines from 3M1 to 10M2;
 - Build a fill and load line from the offloading skid;
 - Install new lines from 3M1 to the diesel loadout arms at the truck rack; and
 - Build new ethanol and B100 offloading skids.

The public will have no fewer than 30 days to submit written comments and evidence, request a public information hearing, or both on the permit application to the Program. Comments will be accepted and considered if postmarked by the end of the public comment period. Formal action on the application will be reserved pending receipt and analysis of any additional details or information developed during the public comment period. Any person who does not participate in the permitting action will not receive notification of the Program's decision regarding the proposed permit, unless the person has delivered a written request for notice to the department. The application, all supporting documentation, and the public notice are available online at http://www.cabq.gov/airquality/air-quality-permits.

The Program shall hold a Public Information Hearing pursuant to 20.11.41.15 NMAC if the Director determines there is significant public interest and a significant air quality issue is involved.

The Program expects to issue, issue subject to conditions, or deny this application before September 3, 2023. The Program will not issue any air quality permit with or without conditions unless an air quality ambient impact dispersion modeling study, if deemed necessary by the Program, shows that the facility would not cause or contribute to a potential violation of air quality standards. If the Program issues the permit with conditions, the conditions will include those that limit the emissions, and conditions that will require recordkeeping and reporting to the Program to ensure compliance with federal and local air regulations.
