## The ALBUQUERQUE - BERNALILLO COUNTY AIR QUALITY CONTROL BOARD 1 **RESOLUTION NO. #2021-1** 2 DETERMINING REASONABLE NOTICE OF PUBLIC MEETINGS OF THE 3 ALBUQUERQUE-BERNALILLO COUNTY AIR QUALITY CONTROL BOARD 4 5 WHEREAS, the Albuquerque-Bernalillo County Air Quality Control Board met in 6 7 regular session conducted by Zoom conference call, on November 10, 2021, at 5:30 PM as required by law and with notice as specified in AQCB Resolution No. #2021-1; and 8 9 WHEREAS, Section 10-15-1(B) of the Open Meetings Act (NMSA 1978, Sections 10-15-1 to -4) states that, except as may be otherwise provided in the Constitution of New Mexico 10 or the provisions of the Open Meetings Act, all meetings of a quorum of members of any board, 11 12 council, commission, administrative adjudicatory body or other policymaking body of any state or local public agency held for the purpose of formulating public policy, discussing public 13 14 business or for the purpose of taking any action within the authority of or the delegated authority 15 of such body, are declared to be public meetings open to the public at all times; and WHEREAS, any meetings subject to the Open Meetings Act at which the discussion or 16 17 adoption of any proposed resolution, rule, regulation or formal action occurs shall be held only after reasonable notice to the public; and 18 WHEREAS, Section 10-15-1(D) of the Open Meetings Act requires the Albuquerque-19 Bernalillo County Air Quality Control Board to determine at least annually what constitutes 20 reasonable notice of its public meetings; and 21 WHEREAS, the Public Boards, Commissions and Committees Ordinance, Chapter 2, 22 23 Article 6, Part 1-4, (B)(2) Revised Ordinances of Albuquerque, New Mexico 1994 (ROA 1994) requires that: "Reasonable notice shall be given to the public prior to any meeting of any public 24 25 board, commission or committee. At least once a year, each public board, commission or

committee shall determine what is reasonable notice to the public; provided that in no event shall
 notice be less than the notice required for Council (i.e. Albuquerque City Council) meetings.";
 and

WHEREAS, the Joint Air Quality Control Board Ordinance, Chapter 9, Article 5, 4 Section 1-3, (C) ROA 1994 and Bernalillo County Ordinances, Section 30-32(c), require that: 5 6 "The Board shall meet in public facilities with public seating available. The Board shall meet monthly if a quorum is available unless a meeting is unnecessary or delayed for good reason. 7 The Board shall hold a minimum of six monthly meetings a year. Special additional meetings 8 9 may be held as needed. Notice of time, place and agenda of meetings shall be published according to the requirements of law. Meetings, work sessions and hearings shall be open to the 10 public." 11

WHEREAS, the requirement that the Board shall meet in public facilities with public 12 seating available has been temporarily revised pursuant to the Governor's declaration of a Public 13 Health Emergency on March 11, 2020, and all public health orders and declarations comprised of 14 local orders entered thereafter, as set forth in the City of Albuquerque, Office of the Mayor 15 Timothy M. Keller's Twenty Fourth Declaration of Local Emergency Due to Novel Coronavirus 16 17 COVID-19, signed on October 22, 2021, including but not limited to paragraph 7, stating that all public boards "are hereby authorized to conduct virtual meetings via teleconference or video 18 conference for the duration of this order, should they choose." 19

NOW, THEREFORE, BE IT RESOLVED THAT THE AIR QUALITY CONTROL
BOARD HEREBY ADOPTS THESE PUBLIC NOTICE REQUIREMENTS WHICH ARE
CONSISTENT WITH THOSE OF THE ALBUQUERQUE CITY COUNCIL AS
ADOPTED ON OCTOBER 4, 2021 BY THE COUNCIL IN RESOLUTION R-21-196,

Section 4. Special Meetings. Special meetings may be called by the Chair of the
Albuquerque-Bernalillo County Air Quality Control Board or a majority of the members upon
seventy-two hours' notice. The notice for a special meeting shall include an agenda for the

8 meeting or information on how a copy of the agenda may be obtained. The agenda shall be

9 available at least seventy-two hours before the meeting and posted on the Albuquerque-

Bernalillo County Air Quality Control Board's website at <u>https://www.cabq.gov/airquality/air-</u>
 quality-control-board.

Section 5. Emergency Meetings. Emergency meetings will be called only under 12 unforeseen circumstances that demand immediate action to protect the health, safety and 13 14 property of citizens or to protect the public body from substantial financial loss. The Albuquerque-Bernalillo County Air Quality Control Board will avoid emergency meetings 15 whenever possible. Emergency meetings may be called by the Chair of the Albuquerque-16 17 Bernalillo County Air Quality Control Board or a majority of the members with twenty-four hours' prior notice, unless threat of personal injury or property damage requires less notice. The 18 notice for all emergency meetings shall include an agenda for the meeting or information on how 19 20 the public may obtain a copy of the agenda. Within ten days of taking action on an emergency matter, the Albuquerque-Bernalillo County Air Quality Control Board will notify the New 21 Mexico Attorney General's Office. 22
