#### 6. New Business

a. AHA Resolution 2013-1 – Naming the AHA Office Building the Carnis Salisbury Building

Executive Director Linda Bridge provided a brief summary of Ms. Carnis Salisbury's contribution with civil rights and fair housing in Albuquerque. Additionally, the Board viewed a presentation that Ms. Salisbury offered during the Human Rights Office, Fair Housing Law Training, which explained her struggles and involvement in the process of changing laws in Albuquerque for equal opportunity for fair housing.

Dr. Harold Bailey expressed that he supported "AHA Resolution 2013-1 — Naming the AHA Office Building the Carnis Salisbury Building", and further explained the environment before the adoption of civil rights legislation.

Member Chavez moved to adopt "AHA Resolution 2013-1 – Naming the AHA Office Building the Carnis Salisbury Building". The motion was seconded by Chairperson McHard and carried by a vote of 4-0.
