Member Clarke moved to approve the minutes; seconded by Member Chavez. The motion carried by a vote of 3-0-1 (For: Clarke, Chavez, McHard; Abstain: Rivera-Wiest).

#### 6. Resolutions and Communications

a) Report of the Secretary – (Executive Director Linda Bridge, Associate Director Andrew Estocin, & Capitol Project Coordinator James Tacosa)

Ms. Bridge and Mr. Estocin presented the AHA Update February/March 2014 Report of the Secretary and the Albuquerque Housing Authority Production Snapshot Report, Mr. Tacosa presented the Capital Funds Report, all three addressed questions from Members of the Board. Please see the attached Report.

Family Self-Sufficiency Coordinator Rebecca Mayeaux introduced Ms. Julie Moran, Family Self-Sufficiency Program Graduate.

Mr. Estocin requested the assistance of two Board members to sit on the AHA Annual Plan Board Sub Committee. Member Clarke and Member Chavez volunteered.

Member Rivera-Wiest requested a comparison of nuisance calls between AHA Public Housing neighborhoods and non-public housing neighborhoods.

Member Clarke moved to accept receipt of the Report; seconded by Member Chavez. The motion was carried by a 4-0 vote.

There were no Old Business items.

## 8. New Business

a) The Board met in Closed Session under §10-15-1 (H)(2) NMSA 1978 to discuss a limited personnel matter, annual job performance evaluation of Executive Director Linda Bridge.

Member Clarke moved to meet in Closed Session under §10-15-1 (H)(2) NMSA 1978 at 12:25 p.m. to discuss a limited personnel matter, annual job performance evaluation of Executive Director Linda Bridge. The motion was seconded by Member Rivera-Wiest and carried by a 4-0 roll call vote. All Board members present recessed to discuss this matter.

b) Re-Convene in Open Session; to vote in public on action items, if any.

The Board re-convened in open session at 1:06 p.m. Chairperson McHard announced there were no votes taken during the Closed Session and the only business discussed in Closed Session was annual job performance evaluation of Executive Director Linda Bridge. No motions were made by any members during the closed session.

Member Clarke announced that the Board is in unanimous agreement that they are very pleased with Ms. Bridge's job performance. Member Clarke then moved to formally approve the 1% cost of living increase in wages that all non-union member City Of Albuquerque employees at AHA received on July 1, 2013. The Board also requested that a formal written amendment to Ms. Bridge's employment contact be drafted to approve her also receiving the same 1% cost of living increase in wages effective July 1, 2013. The motion was seconded by Member Chavez and carried by a 4-0 vote.

#### 9. Other Business

Chairperson McHard announced that the AHA 2013 Fiscal Audit went through the NM State Auditor's office and it can now be released to the public, as a public record. The Auditors will present the annual audit report at the Board Meeting on April 16, 2014.

Chairperson McHard announced that the Board currently only controls the pay rate of Ms. Bridge. The Board requested Mr. Estocin and Ms. Bridge's assistance in future consideration of raises to all AHA employees, after July 1, 2014

The next Regular Meeting of the Board will be on Wednesday, April 16, 2014 at 12 noon in the Manuel Cordova Conference Room, at the Albuquerque Housing Authority Administration Office, in the Carnis Salisbury Building, 1840 University Blvd SE, Albuquerque, NM.
