WHEREAS, the Albuquerque Housing Authority ("AHA") Board of Housing Commissioners ("Board") met in regular session at the Manuel Cordova Conference Room in the AHA Administrative Office Building at 1840 University Blvd SE, Albuquerque, NM 87106 on Wednesday, December 19, 2012 at 12:00 p.m. (noon); and

WHEREAS, Mr. Thomas D. Growney was appointed by Mayor Richard J. Berry in 2011 to serve the people of the City of Albuquerque, New Mexico by serving as a unpaid volunteer member of the newly formed Albuquerque Housing Authority Board of Housing Commissioners; and

WHEREAS, Housing Commissioner Tom Growney was elected Vice-Chairperson of the Board in 2011, and he has served honorably since then by attending nearly every Regular and Special Meeting of the Board, and presided over Board meetings when the Chairperson was absent; and

WHEREAS, Housing Commissioner Tom Growney has provided thoughtful leadership to adopt reforms at AHA, to lead the agency from a troubled past toward an exciting and more productive future, and he was instrumental in helping AHA overcome a serious administrative staff leadership crisis in 2012; and

WHEREAS, Housing Commissioner Tom Growney has placed the interests of the common good of the community of Albuquerque, ahead of nurturing his own personal family business, by volunteering to spend his own limited free time to prepare for and attend Housing Authority Board meetings every month; and

WHEREAS, Mr. Tom Growney's term of public office as a Housing Commissioner expired on November 30, 2012, thus he will no longer attend any Regular Meetings of the AHA Board as a member of the AHA Board of Housing Commissioners;

NOW, THEREFORE, BE IT RESOLVED BY THE AHA BOARD OF HOUSING COMMISSIONERS, the Governing Body of the Albuquerque Housing Authority (AHA), that:

The deep gratitude of the Albuquerque Housing Authority be expressed to Commissioner Tom Growney for his dedicated volunteer service to the people of the City of Albuquerque by giving him a copy of this Memorial; and

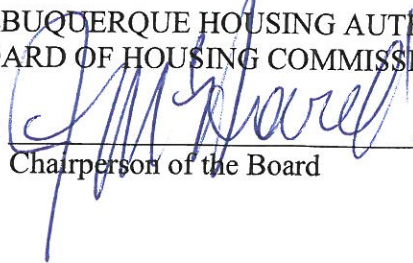
