1 BOARD OF HOUSING COMMISSIONERS 2 RESOLUTION NO. 2013-1 3 4 NAMING THE AHA ADMINISTRATIVE OFFICE BUILDING 5 THE CARNIS SALSIBURY BUILDING 6 7 WHEREAS, the Albuquerque Housing Authority ("AHA") Board of Housing 8 Commissioners ("Board") met in regular session in the Manuel Cordova Conference Room in 9 the AHA Administrative Office Building at 1840 University Blvd SE, Albuquerque, NM 87106 10 on January 16, 2013 to consider this Resolution; and 11 WHEREAS, the City of Albuquerque as a community has a well-documented history of 12 discrimination directed against certain racial and ethnic groups, including denial of access to 13 houses for sale and for rent; and 14 WHEREAS, historically, certain racial groups were forced by law to adhere to restrictive 15 real estate covenants that prohibited the sale of new and existing homes in many Albuquerque 16 subdivisions to people of color, excluding many people from purchasing and living in the newest 17 homes or the most popular neighborhoods; and 18 WHEREAS, restrictive covenants intentionally created racially and/or ethnically 19 segregated neighborhoods and communities located within the City of Albuquerque; and 20 WHEREAS, Mrs. Carnis Salisbury, along with her husband, Mr. Oliver Salisbury, 21 worked in the 1960's to organize diverse groups locally to strike down restrictive covenant laws 22 based on race or national origin that prohibited the sale of new and existing homes in many 23 Albuquerque subdivisions to people of color. They both worked tirelessly to promote individual

civil rights in Albuquerque and across New Mexico; and

| 1 | WHEREAS, Carnis Salisbury courageously worked with a team of local civil rights |

| 2 | organizers to bravely convince the Albuquerque City Commission on June 18, 1963 to |
| 3 | unanimously adopt, on an emergency basis, a groundbreaking City Ordinance to ban |
| 4 | discrimination on the basis of race or national origin in the sale and rental of houses and |
| 5 | apartments city wide. Carnis Salisbury was a key part of the 1963 effort that led the City of |
| 6 | Albuquerque to adopt a Fair Housing laws over the organized public opposition of some real |
| 7 | estate industry groups; and |
| 8 | WHEREAS, civil rights pioneers like Carnis Salisbury made it possible for the |
| 9 | people of Albuquerque today to have the freedom to live and buy homes where they could freely |
| 10 | choose; and |
| 11 | WHEREAS, in 1990 the City of Albuquerque Human Rights Office awarded Carnis |
| 12 | Salisbury its Human Rights Award for promoting human rights, human dignity, equal access and |
| 13 | the elimination of discrimination; and |
| 14 | WHEREAS, Mrs. Carnis H. Sailbury died on December 23, 2011 at the age of 97; and |
| 15 | WHEREAS, the AHA Board recognizes the outstanding lifelong contributions that Mrs. |
| 16 | Carnis Salisbury made to rectifying past housing discrimination and promote civil rights within |
| 17 | Albuquerque. |
| 18 19 20 | NOW, THEREFORE, BE IT RESOLVED BY THE AHA BOARD OF HOUSING COMMISSIONERS, the Governing Body of the Albuquerque Housing Authority (AHA), that: |
| 21 22 | Section 1. AHA Administrative Office Building at 1840 University Blvd SE, |
| 23 | Albuquerque, NM 87106 shall now be known as the Carnis Salisbury Building. |
