V Update and Approval of Board of Trustee Policies

Beverly Bendicksen:

- Policy Document Working Group comprised of Trustees and Key Museum Staff members is working on revising these policies; Articles I through VII and IX were significantly modified
- Article VIII Ethics section has not been changed and is being reviewed with revisions expected in the future

A motion to approve revised policies was made by Joni Pierce, Paul Mondragon provided a second.

 Joni requests that in Article I, 1.6 the Museum Foundation be changed to Albuquerque Museum Foundation Inc. and referred to thereafter as Foundation

Board approved unanimously.

Andrew Connors:

Next year's Review for Re-Accreditation by the American Alliance of Museums will benefit from these and other document updates that are occurring and are being spearheaded by Josie Lopez. First accreditation was in 1980. The City of Albuquerque is also undergoing similar document reviews. The agreement between the City of Albuquerque and the Albuquerque Museum Foundation is currently under review.

VI Museum Director Report

Andrew Connors Reports:

- Thanked Museum front of house and back of house staff for the success of the Frida Kahlo, Diego Rivera and Mexican Modernism Exhibit's success.
- COVID capacity limitations along with timed ticketing helped in keep the museum safe for attendees and working staff
- New initiatives to reach new audiences included advertising in the Spanish language which allowed us to serve more of our community
- We are still in the COVID Yellow Status for NM. Yellow allows (10) people per gathering, Green will allow (20) people per gathering and Turquoise will allow (150) people per gathering
- We have been encouraged to help our Performing Arts Community re-engage with their audiences. Following the Frida Kahlo Exhibit we will have a drop-in opportunity in our outdoor Amphitheater for visitors of the museum to experience a performance by Opera Southwest. We will have a similar program on Sunday mornings with Chatter in our outdoor Amphitheater.
- Event Rentals are currently on hold. We are working with summer Performing Arts groups to reschedule their events to the autumn and fall. Our large Educational programs and events are also holding off until autumn before they return on a regular basis.
- Thanked City Council working with Helen Maestas and the Mayor's office to have moved forward with augmenting our Board with Sherri Burr, Paul Mondragon and Chris Baca as new Board members and look forward to welcoming more appointed Board members in the future.

- New advisory committee meeting members Jacob Sisneros and Ray Dewey joined our recent meeting. They were both very engaged and are broader community voices on this committee.
- Shared a PowerPoint of items that were accepted by the committee.
