H-1 HISTORIC OLD TOWN ZONE

Application for mid-year: January 1, 2016-June 30, 2016

A solicitations permit application must be completed, signed and submitted to the City of Albuquerque Treasurer's Office (Plaza Del Sol, 600 2nd St. NW) to be eligible to participate in the procedures governing the issuance of permits for the H-1 Historic Old Town Zone. A \$25 non-refundable application fee will be due at the time application is submitted.

Applications for January-June 2016 are based on space availability. Should you require assistance with this application, please call 505-768-3561.

Within 6 (six) days of acceptance into the Portal Market program, prospective Vendors must pay their \$100.00 Permit Fee, supply 2 <u>Passport-Style</u> Photos for each vendor in the Craft Unit, and provide a current copy of a City of Albuquerque Business Registration for each vendor in the Craft Unit at the Treasurer's Office.
