**1. Call to Order**

- a. Lorenzo Otero called the meeting to order at 3:13 p.m.

**2. Review & Approve Minutes from September Meeting**

- a. Twyla moved to approve the minutes of the last meeting. Councilor Peña seconded the motion. Minutes were unanimously approved.

**3. Updates**

- a. 2026 Exhibits - Shelle explained that the contractors are finishing the proposed designs for the main hallway along with two rotating exhibits for the museum space which includes a proposed photography exhibit. Installation will start in December for the main hallway. Proposals for the photography exhibit are being reviewed and contracted.
- b. Sign Park - Shelle gave an update that the signs have been identified with some currently getting refurbished. We are waiting on permitting to move towards installation.
- c. Master Plan - Diego gave the update that the City has received a proposal from an architect and are in the process of reviewing that proposal.
- d. Maintenance and Repair Updates - Marc gave an update on the elevators being operable and passed all inspections. The upstairs lighting has been fixed. The theater and audio systems have been updated. The deficiencies from building and fire inspections have been corrected.
- e. Staffing Updates - Shelle gave an update that a position will be advertised in the coming weeks, along with a third position that is being worked on internally.

- a. Recommendation to support the relocation of Little House Diner to the Route 66 Visitor Center. Twyla motioned to table the discussion to the next meeting when all voting parties are present. Councilor Peña seconded the motion.
