A. FY22-23 Funding Resolution – City Council Updates: S. Allen read S. Brueggemann's May 20, 2021 email:

"The FY22-23 Funding Resolution will be introduced at City Council on Monday June 7th, with a hearing of the Finance and Government Operations Committee the week of the 14th, then back to the full City Council for immediate action on June 21st. As soon as the City Council staff posts the Monday meeting agenda, usually on the Friday afternoon prior (so Friday June 4th), we will announce the awardees to all of the applicants."

B. Adoption of Residency Application Draft - Call for Organizations as Fiscal

Sponsors: S. Allen reviewed the residency application draft with the board. He requested the committee's approval for the subcommittee to continue with their work, release the call to non-profit organizations, and send to administration for approval. N. Zastudil asked for clarification on the requirements from the individual artist overseen by the non-profits. S. Allen clarified this adoption of the non-profit originations will be part one. The committee will continue working on part two, which will be the application and the requirements for individual artists.

Brueggemann informed him that the Department of Arts and Culture's Director, S. Sanchez, and Deputy Director, H. Bellamy, wanted to move forward in partnership with the DEIA subcommittee which consists of A. Lipman, J. Youngs, M. Salazar, and G. Uballez. He added that S. Brueggemann and I. Zamora would be there to represent staff. He requested that I. Zamora speak to the administration about possible dates and schedule a Doodle poll for a meeting within the next couple weeks to discuss moving the DEIA Statement and Ordinance forward.
