#### CALL TO ORDER:

Chairperson Carey stated that the CISC Committee has the Final Draft of the CISC Report.

The Chairperson Carey asked for a vote for the draft which is essentially a 4-1 vote to approve, no raises.

Let the record reflect there is unanimous vote to approve the report and recommendations. Carmen prepared a cover memo that will require the signature of Chairperson John Carey. Carmen will deliver the final report to the City Clerk's Office.

After some discussion from the CISC Members, Chairperson John Carey called for a vote to approve the report for publication. The motion passed unanimously with a 5-0 vote.

Carmen announced to the CISC members that she would retire from the City of Albuquerque in June 2013.
