If the registered owner is in default for two (2) or more ASE system fines, the registered owner may be subject to enforceable penalties including but not limited to a parking citation, immobilization, and/or impoundment of their vehicle if their vehicle is found to be parked on any street or roadway within the City of Albuquerque; on or in any City-owned parking facility; on or in any City-managed parking facility; or on any other City-owned real property within the City of Albuquerque limits.
