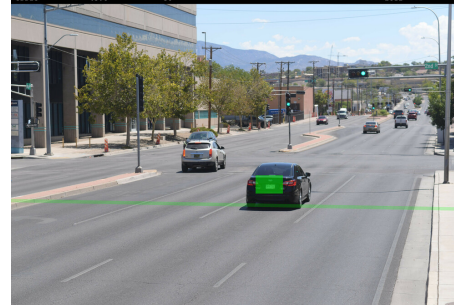

As the vehicle's registered owner/lessee you are liable for the violation. The civil penalty is \$100.00 (payment instructions below). Payment is deemed an admission and waiver of your right to appeal. You have thirty days from issuance of this notice to pay the fine, request a hearing, submit an owner's affidavit or request community service. Failure to pay may result in this case being forwarded to a collection company.

PAYMENT OF THE PENALTY AMOUNT FOR THE VIOLATION WILL NOT RESULT IN POINTS ADDED TO YOUR DRIVING RECORD.

Consequences of non-payment and having more than one Automated Speed Enforcement (ASE) system fine in default :

If the registered owner is in default for two (2) or more ASE system fines, the registered owner may be subject to enforceable penalties including but not limited to a parking citation, immobilization, and/or impoundment of their vehicle if their vehicle is found to be parked on any street or roadway within the City of Albuquerque; on or in any City-owned parking facility; on or in any City-managed parking facility; or on any other City-owned real property within the City of Albuquerque limits. WHAT IF I WASN'T DRIVING MY VEHICLE AT THE TIME OF THE INFRACTION?

You may submit an Owner's Affidavit identifying the driver so that an Automated Speed Enforcement System (ASE) Fine Notice may be sent to the driver. The Owner's Affidavit must be notarized. Only the registered owner who receives the initial system fine notice may submit an owner's affidavit nominating another person. A nominee may not nominate another person as the driver. No further nomination is allowed. The only way for a nominee to contest infraction is by timely requesting a hearing. (see below) You will find the return mailing address on the bottom of the Owner's Affidavit form and you can find the form on the internet at: www.ZeroFatality.com

ARE THERE ANY OTHER VALID DEFENSES TO THIS SYSTEM FINE NOTICE?

Yes. To challenge this infraction, you may request a hearing before the due date specified on your Notice. If you do not request a hearing by the due date set forth on your Notice you lose the right to appeal. If the infraction is not dismissed after your hearing, you **must pay your fine**.

Submission of a false affidavit is a fourth degree felony, punishable under New Mexico Stat. § 30-25-1.

WHAT IF I DO NOT PAY THE FINE?

If your fine is not paid or contested by the due date, or if you don't complete 4 hours of community service within 90 days, or your Owner's Affidavit or hearing are not resolved in your favor, the \$100 fine will be your responsibility. If you **do not pay all amounts due**, your debt may be forward to a collection agency, or the City may pursue all other available remedies.

HOW DOES IT WORK?

The photo enforcement system measures your speed and position with a multi-tracking radar. If you are exceeding the posted speed limit, it captures digital photographs of your vehicle. The system also captures a motion video that you can review online. The Albuquerque Police Department reviews every single violation.

HOW DO I CONTEST A NOTICE OF VIOLATION?

You may request a hearing before the due date specified on your Notice. You will find the Hearing request form online at: www.ZeroFatality.com

At your hearing: New Mexico rules of evidence, New Mexico Rules of Civil Procedure, and the Albuquerque Independent Office of Hearings Ordinances will apply.

CAN I PERFORM COMMUNITY SERVICE IN LIEU OF PAYING THE FINE?

Yes, you may choose to perform 4 hours of community service instead of paying the \$100 fine. You must state your intent to complete community service by the due date on the Notice, which is 30 days from the date of issuance of the system fine notice. Please be advised you must complete **all** 4 hours of community service within 90 days of issuance of the system fine notice, to have your debt be considered paid in full. CONSEQUENCES OF NON-PAYMENT AND HAVING MORE THAN ONE AUTOMATED SPEED ENFORCEMENT (ASE) SYSTEM FINE IN DEFAULT:

If the registered owner is in default for two (2) or more ASE system fines, the registered owner may be subject to enforceable penalties including but not limited to a parking citation, immobilization, and/or impoundment of their vehicle if their vehicle is found to be parked on any street or roadway within the City of Albuquerque; on or in any City-owned parking facility; on or in any City-managed parking facility; or on any other City-owned real property within the City of Albuquerque limits (8-5-1-43 ROA 1994).
