ITEM 1: APPROVAL OF MINUTES.

ITEM 3: UPDATES AND DISCUSSION.

(a) Public Access and Local Origination Channels

Brian White asked Staff to obtain a copy of the public access and local origination organizational flow chart prepared by the Cultural Services Department. Staff provided members with copies of the 2019 inventory report prepared by Asset Services (a City contractor); and public access operational procedures from Rialto, California and Meridian, Michigan. The city governments of Rialto and Meridian operate their public access channels without a contractor from the private sector.

- **(b) Enhancing and improving local news programming** was deferred until the January 28, 2020 meeting
- (c) Comcast franchise implementation and recent consumer complaints.

Staff presented an update regarding a grant from Comcast for streaming equipment.

ITEM 5: ACTION ITEMS.

The Board deferred action on actions items, that is, (1) recommendations on amendments to Cable Franchise and Hearing Board ordinance; and (2) adoption of the meeting schedule for 2020. The Board deferred action on these items until its January 28, 2020 meeting.
