#### **CALL TO ORDER:**

The meeting was called to order at approximately 5:30 p.m. with two members present.

### ITEM 1: APPROVAL OF MINUTES.

Members Michael V. Marcotte and Brian White approved the minutes of the November 26, 2019 meeting by a vote of 2-0.

## ITEM 2: UPDATES AND DISCUSSION.

#### (a) Public Access and Local Origination Channels

Hakim Bellamy, Deputy Director of the Cultural Services Department, provided the Board an update on the status of the PEG channels. CSD has contracted with Quote-Unquote to provide educational access services on Channel 96 and with ProView to provide local origination programs on Channel 26. CSD is in the process of developing a contract related to the provision of public access programs on Channel 27. CSD will continue to operate GOV-TV, Channel 16, the government access channel. Brian White asked Staff to obtain a copy of the public access and local origination organizational flow chart prepared by the Cultural Services Department.

- **(b) Topic: Enhancing and improving local news programming** was deferred until the February 25, 2020 meeting.
- (c) Topic: Comcast franchise implementation and recent consumer complaints was deferred until the February 25, 2020 meeting.

### **ITEM 5: ACTION ITEMS.**
