**VII. LB 17-03, FIRST AMENDED PROHIBITED PRACTICE COMPLAINT AND CITY'S MOTION TO DISMISS FOR FAILURE TO COMPLY WITH ORDER OF SEPTEMBER 5, 2017 ON DEADLINE TO AMEND.**

Ian Stoker, Assistant City Attorney appeared on behalf of the City. Johanna Cox, Council for Petitioner was not present. Mr. Stoker stated that Ms. Cox submitted an email to the administrative hearing office requesting a continuance for today. She was then directed by the Board to file a formal Motion to Continue and a Stipulated Order but did not do so and has not made any form of communication with him. Jessica Enriquez read into the record the email that Ms. Cox submitted to the Board on November 13, 2017 requesting to continue because she was not available. She also read her response email to Ms. Cox that was dated November 15, 2017 and it stated that the Chairman was requiring that Ms. Cox submit a formal Motion to Continue and a Stipulated Order. She stated that since her November 15<sup>th</sup> email, she had not received any form of response from Ms. Cox. Mr. Wartell moved to grant the City's Motion to Dismiss. Mr. Montoya seconded. Voted and passed unanimously 3-0.

Assistant City Attorney Melissa Kountz filed a Motion to Vacate and Reset. Rocky Gutierrez appeared on behalf of AFSCME and stated that they Union does not oppose the City's Motion to Vacate and Reset. Mr. Wartell moved to grant the Motion to Continuance and Reset. Mr. Montoya seconded. Voted and passed 3-0.
- **LB 12-28, CITY'S MOTION FOR SUMMARY JUDGEMENT AND AFSCME 624's RESPONSE TO CITY'S MOTION FOR SUMMARY JUDGEMENT. (STEPHEN CURTICE, YOUTZ & VALDEZ)**  
The City filed a Motion to Withdraw and Assistant City Attorney Ian Stoker appeared to present the Motion. He stated that the City has withdrawn their Motion for Summary Judgment and this matter can go forward with scheduling a hearing.
