AP 5200 2ND STREET LLC (RANDY CHRISTIE, AGENT) request(s) a special exception to Section 14-16-2-18(B)(1) and 14-16-2-17(B)(3): a CONDITIONAL USE to allow for a proposed church in a C-3 zone on all or a portion of Lot(s) 42 & 43, EASTVALE ADDN zoned C-3, located at 5202 2ND ST NW (F15)

STATEMENT OF FACTS: The applicant, AP 5200 2<sup>nd</sup> Street LLC, requests a conditional use to allow for a proposed church in a C-3 zone. Randy Christie, Pastor and agent for the applicant, testified that he has been a Pastor for approximately 29 years. He indicated that if approved, services would be held on Sunday's at 9:30 a.m. There is plenty of on-site parking for members of the church. Evangeline Pavlakos testified in support of this request indicating that the use in consistent with the neighborhood. There are e-mails from members of the Greater Gardner Neighborhood Association and the North Fourth Camino Real Merchants Association indicating that they support this request. The yellow sign was posted. There was no opposition to this request at the hearing, nor is there any opposition noted in the file.

Based on all of the testimony and a review of the entire file, it is determined there is substantial evidence to make the following findings and conclusions:

FINDINGS AND CONCLUSIONS: I find that this request complies with Section 14. 16. 4. 2. (C). 1., for the granting of a conditional use upon a finding that the proposed use will not cause injury to the neighborhood, adjacent property or the community, nor will it be damaged by surrounding structures. For reasons stated above, this request is approved.

**<u>DECISION:</u>** Approved with condition(s).

**CONDITION(S):** This approval is for three years only. At the end of the three year period and prior to December 1, 2012 Mr. Christie must contact the Office of the Zoning Hearing Examiner (505.924.3918) to ensure that this matter is included on the January 2013 agenda and that a review of this approval is conducted. Any filing fees will be waived.

The approval is subject to the submitted site plan, as required. Any substantial changes to the site plan, as determined by the Zoning Enforcement Division, shall require the scheduling of an additional Public Hearing.

If you wish to appeal this decision, you may do so by 5:00 p.m., on February 12, 2010 in the manner described below:

Appeal is to the Board of Appeals within 15 days of the decision. A filing fee of \$105.00 shall accompany each appeal application, as well as a written explanation outlining the reason for appeal and a copy of the ZHE decision. Appeals are taken at 600 2nd Street, Plaza Del Sol Building, Ground Level, Planning Application Counter located on the west side of the lobby. **Please present this letter of notification when filing an appeal.** When an application is withdrawn, the fee shall not be refunded.

An appeal shall be heard by the Board of Appeals within 45 days of the appeal period and concluded within 75 days of the appeal period. The Planning Division shall give written notice of an appeal, together with a notice of the date, time and place of the hearing to the applicant, a representative of the opponents, if any are known, and the appellant.

Please note that pursuant to Section 14. 16. 4. 4. (B)., of the City of Albuquerque Comprehensive Zoning Code, you must demonstrate that you have legal standing to file an appeal as defined.

You will receive notice if any other person files an appeal. If there is no appeal, you can receive building permits any time after the appeal deadline quoted above, provided all conditions imposed at the time of approval have been met. However, the Zoning Hearing Examiner may allow issuance of building permits if the public hearing produces no objection of any kind to the approval of an application. To receive this approval, the applicant agrees in writing to return the building permit or occupation tax number.

Successful applicants are reminded that other regulations of the City must be complied with, even after approval of a special exception is secured. This decision does not constitute approval of plans for a building permit. If your application is approved, bring this decision with you when you apply for any related building permit or occupation tax number. Approval of a conditional use or a variance application is void after one year from date of approval if the rights and privileges are granted, thereby have not been executed or utilized.
