Section 7-2-1-2 is hereby amended as follows and a new Section 7-2-1-3 is created: 8 9 **"§ 7-2-1-2:** 10 (1) The Fares designated in § 7-2-1-1, shall be suspended during the <del>Bracketed/Strikethrough Material</del>] - Deletion 11 implementation of a twelve calendar month "Zero Fare" Pilot, Bracketed/Underscored Material] - New 12 (2) The Zero Fare Pilot is to commence no later than January 1st 2022. 13 § 7-2-1-3 VIOLATION. 14 It shall be a violation of § 7-2-1-1 for any person using the transit system to 15 fail to pay the applicable fare. Any person in violation of § 7-2-1-1 is guilty of a 16 misdemeanor and subject to the penalty provisions set forth in § 1-1-99 ROA 17 1994. Enforcement of § 7-2-1-3 is suspended during the implementation 18 of a twelve calendar month Zero Fare Pilot." SEVERABILITY CLAUSE. If any section, paragraph, sentence, 19 Section 2. clause, word or phrase of this ordinance is for any reason held to be invalid or 20 21 unenforceable by any court of competent jurisdiction, such decision shall not 22 affect the validity of the remaining provisions of this ordinance. The Council hereby declares that it would have passed this ordinance and each section, 23 24 paragraph, sentence, clause, word or phrase thereof irrespective of any

provision being declared unconstitutional or otherwise invalid.
