

## Statement of Allegations

The Keller campaign has engaged in a pattern of unlawful behavior by submitting as many as (or more than) 150 Qualifying Contributions in violation of § 1-19-34.3(A) NMSA 1978, and Part I(1) and Part C (6) Regulations for the Open and Ethical Elections Code.

I am not able to attach all possible evidence of violations, only a portion of the documents submitted by the Keller Campaign.

Exhibit 1: sworn declaration concerning how Keller supporters did not collect the \$5 donation from as many as 150 people who signed the Qualifying Contributions receipts.

Exhibit 2: samples of the 150 Qualifying Contributions receipts with the Albuquerque Fire Department's Union President's signature.

Exhibit 3: fraudulent Qualifying Contributions receipts signed by Neri Holguin, Keller's campaign manager and person filing the complaint against Manny Gonzales. Signing blank forms that a contribution has been received, is false and creates the opportunity for false statements and fraudulent practices.

Exhibit 4: fraudulent or clearly questionable signatures on petitions and the Qualifying Contribution forms that the City Clerk is obligated to check and match but did not do so.

*This<sup>1</sup> evidence attached reflects that the Keller Campaign has engaged in a pattern of fraud in its efforts to obtain over \$650,000 in taxpayer money. In preparing and submitting these receipts, the Keller Campaign committed numerous acts of criminal forgery, in violation of NMSA 1978 § 30-19-10. In addition, the submission of these receipts violated the 2021 Regulations of the Albuquerque City Clerk for Open and Ethical Elections Code Part C(6), which provides “the contributor himself or herself must sign the receipt.”*

*It is also likely that the Keller Campaign violated the law by submitting these forged receipts without collecting \$5 contributions from these voters. If that is the case, the Keller Campaign*

<sup>1</sup> I am requesting that the Keller Campaign be held to the exact same standards as demanded in the complaint filed against Manny Gonzales. To that end, I have substituted “Keller Campaign” for “Gonzales Campaign” from the Keller/Neri Olguin Compliant filed against the Gonzales Complaint, and *italicized* portions are directly from the Keller complaint against Manny Gonzales.

*violated NMSA 1978, § 1-19-34.3(A), which provides that “[i]t is unlawful for a person to make a contribution in the name of another person, and no person shall knowingly accept a contribution made by any person in the name of another person. This conduct would also violate the 2021 Regulations of the Albuquerque City Clerk for the Open and Ethical Elections Code Part I(1), which provides that “[n]o person may make a Contribution in the name of another person . . . The Contributor identified in reports to . . . the City Clerk must be the actual source of the funds for the Contribution.” It further violates Part C(6), which provides that “[a]ll qualifying contributions must be paid by the contributor; if the funds are provided by any person other than the contributor who is listed on the receipt, the Qualify Contribution will be deemed fraudulent.”*

*These criminal and fraudulent actions by the Keller Campaign justify the denial of the Certification pursuant to Part C(15) of the Regulations of the Albuquerque City Clerk for the Open and Ethical Elections Code, which provides that the City Clerk shall determine whether an Applicant Candidate has “been found to have made a materially false statement in ta report or other document submitted to the City Clerk” or “been found to have submitted any fraudulent Qualifying contributions or any falsified acknowledgment forms for the Qualifying Contributions . . . , where the Applicant Candidate knew or should have known of the fraudulence or falsification.” In the alternative, it is grounds for revocation of certification pursuant to Part C(17)(c), which provides that “the certification of a Participating Candidate may be revoked at any time if the City Clerk determines that the candidate or an agent of the candidate . . . [s]ubmitted any fraudulent Qualifying Contributions . . . and the Participating Candidates knew or should have known of the fraudulence.” It is also grounds for revocation of certification pursuant to Part (C)(17)(f), which provides that “the certification of a Participating Candidate may be revoked at any time if the City Clerk determines that the candidate or an agent of the candidate . . . [k]nowingly made a false statement or material misrepresentation in any report or any other document required to be filed under the OEEC or the EC.”*

*The Open and Ethical Elections Code was approved in 2005 with 69% of the public vote. Its integrity and its future are dependent on candidates earning the right to spend hundreds of thousands of taxpayer dollars for their campaigns, in exchange for the honest and diligent satisfaction of the robust requirements to access these dollars. When a candidate commits fraud in an attempt to circumvent this public trust and clear requirements of this law, that candidate should be disqualified from the benefits of public financing for violating the intent, and trust, of the overwhelming majority of the City’s voters.*

Whether the Keller Campaign will be held to the same standards presents a serious question and may have a huge impact on the public’s perception of the entire process. The decision to provide public funding for the Keller Campaign and deny same to the Gonzales Campaign will harm not just the Gonzales Campaign but all the voters in Albuquerque.

## DECLARATION OF SHAWN McDONALD

Shawn McDonald makes this Declaration under penalty of perjury of the laws of the State of New Mexico and states:

1. My name is Shawn McDonald. I am over the age of eighteen (18) years and competent to testify to the matters stated in this Declaration.
2. While on duty with the Albuquerque Fire Department on June 1, 2021, the Albuquerque Fire Rescue Union President (IAFF Local 244) visited the station and discussed contract matters, negotiations, and the mayoral election.
3. The Union President asked people to sign Keller's \$5 donation cards. One of the members asked him, "What is this \$5 deal? You didn't say anything about five bucks."
7. In response, the Union President told everybody at the meeting, "I got that, don't worry about it. It's too hard for me to go around and ask people to sign this and donate five dollars. I only have three books. It's a hundred and fifty bucks, and I'm going to cover it for all the guys who want to sign it."
8. I spoke up and told him and everyone present that "You're not allowed to do that."
9. The room went silent for a bit, but members then continued to review the donation cards.
10. I was talking to some members and could not see how many cards were signed, as I was distant from the table and the cards.
11. This is my complete statement.
