### COMPLAINT FOR VIOLATIONS OF THE CITY OF ALBUQUERQUE ETHICS CODE, OPEN AND ETHICAL ELECTIONS CODE, AND 2021 REGULATIONS OF THE CITY CLERK

### Count I - Misuse of City Employees and City Property in Campaigns

Tim Keller has done what no elected official should ever do, a practice that has been condemned in this country for more than 100 years. He is using his position as a public official and a chief executive officer of the City to have City employees solicit contributions and support from other City employees during work time and on City property. A Union President beholden to the mayor for union salary and benefit issues openly acted as Keller's agent. He promoted Keller as a candidate and urged other City employees to sign the qualifying contributions at city fire stations during work hours. Not only that, he asked for those contributions in his campaign speech for Keller to the city firefighters and combined that advocacy with reference to the union's contract with the city and negotiations. Linking the suggested support for Keller to favorable union contract negotiations is classic quid pro quo corruption. Promising the city employees that they would not have to actually pay the \$5 contributions allowed Keller to obtain more than \$660,000 in public funds.

Keller's conduct is the type of conduct that the City's ethics provisions have tried to make a thing of the past by including prohibitions in multiple sections of the City's Charter and Ethics provisions. It warrants his removal from office and the return of all public funding for his campaign. In addition to these violations, Keller has committed the very same offenses he accused his opponent of, and if the rule of law means anything, he must receive the same punishment: the withholding of all public funding. And he should also be removed from office.

### Factual Allegations

On July 14, 2021, Shawn McDonald, a firefighter with the City of Albuquerque submitted an affidavit, which is attached below as Exhibit 1, to the Albuquerque City Clerk. In that affidavit, Firefighter McDonald stated that the Albuquerque Fire Rescue Union President (Justin Cheney) had visited the fire station on June 1 and discussed "contract matters, negotiations and the mayoral election." Firefighter McDonald then states, "The Union President asked people to sign Keller's \$5 donation cards."

The attached Exhibit 2 shows twenty-four (24) \$5 Qualifying Contribution receipts signed by Justin Cheney as the representative of the Keller campaign collecting the contributions. Acting on behalf of Mayor Keller directly, it remains undisputed that Justin Cheney appeared (1) during working hours (2) at a city workplace (3) to promote Keller's candidacy and (4) while acting in the scope of his employment, in which he discussed contracts and negotiations in conjunction with campaigning and collecting qualifying contributions for Mayor Keller. While violating all four of those prohibitions Justin Cheney both solicited political contributions for the Keller Campaign and accepted them on the campaign's behalf. All twenty-four (24) Qualifying Contributions are the illicit product of Mr. Keller's violations of multiple prohibitions against campaigning on City property on City time and all twenty-four (24) must be rejected as false and fraudulent.

### Code Provisions Violated by Keller's Outrageous Conduct

Keller's conduct violates numerous provisions of the Albuquerque Charters and Codes and related rules.

Sections of the City's Ethic's Code Violated—Misuse of City Employees in Campaigns and
Misuse of City Property

Keller violated Section 7 of the City Ethics Code found in Article VII of the City Charter. It states:

### Section 7. MISUSE OF CITY EMPLOYEES IN CAMPAIGNS.

No official shall participate in the following types of political activity:

- (A) Using his or her position or employment with the city to influence support of employees of the city for or against any candidate, issue or Measure Finance Committee or other similar organization in any election or pre-election activity; provided, however, that nothing herein shall deny the right of an official of the city to express his or her views on any issue.
- (B) Accepting and/or soliciting campaign contributions for any candidate or Measure Finance Committee or other similar organization in any election or pre-election activity, during working hours, at a city workplace or in the scope of their city employment.
- (C) Accepting and/or soliciting contributions for the benefit of a city employee or official for political purposes during working hours, at a city workplace or in the scope of his or her city employment.

Keller also violated Section 6 of the City Ethic's Code, which provides:

Ethics Code, Section 6. USE OF PUBLIC PROPERTY.

No official of the city shall use property, owned by any governmental body or funds of any governmental body, for personal benefit, convenience or profit, except in accordance with policies promulgated by the Council. This prohibition includes the use of city property or funds to advertise or promote the campaign of any official, except as provided in this section. Use of city property to promote a campaign is limited to areas made available to all candidates for public office, including public areas, areas used for public meetings and such city facilities that are designated as meeting space that is available to all candidates for public office. No campaign activities shall be conducted in those portions of city facilities that are dedicated as work areas for city employees.

As detailed above, Keller violated these provisions of the Ethics Code by using a paid City employee as his official agent collecting contributions from City employees during work hours and on City property.

The penalty under Section 8 of the Ethics Code for these violations includes removal from office: "Board may recommend to the Council that an appointed or employed official be suspended or removed from office or that an elected official be removed from office."

The fraudulent Cheney donations (without regard to the additional ethics and rules violations identified thus far) constitute a serious ethics breach and compels the withholding of all public funds if in fact the Rule of Law, the ethics code and rules actually apply to the Keller campaign.

### Seed Money Violations—In-Kind Contribution Limits and Reporting Requirements

Keller's actions also violate Article XVI, Open and Ethical Elections Code, Section 6, titled "SEED MONEY-IN-KIND CONTRIBUTIONS", subsection (F), which provides:

Applicable limit on Seed Money. An individual may volunteer personal services to an Applicant Candidate as long as the volunteer is not compensated. If an individual volunteers during working hours, paid by a third-party employer or the Applicant Candidate, then that employer makes an In-Kind Contribution to the Applicant Candidate.

Additionally, the 2021 Candidate Guide published by City Clerk Watson, page 47, states:

b. Volunteer Services vs. Paid Assistance. Individuals are permitted to provide their services for free to the campaign as volunteers. However, if the volunteer provides their services with the knowledge of their employer during their paid worktime, then the employer has made a Contribution to the campaign.

In this case, the employer is the City of Albuquerque. Since Justin Cheney solicited campaign contributions during his work hours, the Keller campaign was required to report the in-kind contribution from the City of Albuquerque to Keller's campaign. The Keller campaign provided no such disclosure. Just as he did in 2017, Keller has violated the seed money and reporting requirements for publicly financed candidates. And this time, rather than the fraudulent use of private dollars to support his campaign in 2017, Keller has managed to use the

City/taxpayers funds to facilitate the Union President's campaigning on his behalf on city property and city time.

Under Article XVI, Section 7 of the Open and Ethical Elections Code, titled "Certification of Participation" and cited by Watson in his denial letter to Gonzales, it provides that the Clerk was required to determine whether Keller "(4) complied with Seed Money contribution and Expenditure restrictions" in order to certify him for public financing. Keller violated these provisions when he initiated or facilitated the violations and then accepted an inkind contribution from the City of Albuquerque and failed to report that in-kind contribution on his campaign reports.

The Clerk's 2021 Candidate Guide, page 20, Section 8, has also been violated: to be certified to participate in the public financing program, candidates must meet the criteria listed in the City Charter Article XVI, Section 7(A) and 2021 Regulations for the Open and Ethical Elections Code, as well as have collected the minimum number of required qualifying contributions and have complied with seed-money and in-kind contribution restrictions."

The 2021 Regulations for the City of Albuquerque Election Code provides:

### PART M: USE OF PUBLIC RESOURCES BY CANDIDATES CURRENTLY HOLDING OFFICE

- 1. In addition to the prohibitions on the use of public property and city employees contained in Article XII, Sections 6 and 7, and AI 4-5, the following regulations apply to all elected officials running for any office covered by the Election Code or Open and Ethical Elections Code:
  - a. The Board of Ethics may assess penalties for violations of Article XII, Sections 6 and 7, and consider such violations as In-Kind Contributions that will count towards a candidate's Expenditure limit.

The value of the Union President's time spent collecting campaign contributions for Keller while on the job certainly exceeds \$250.00 in value, so in addition to being a prohibited contribution, it is over the limit and should disqualify him from public financing on that basis as well. Further, the Keller campaign collected seed money contributions from non-residents of Albuquerque, which are prohibited under the City Charter. See p. 7-8, infra. The Mayor's City Clerk who has been so helpful to the campaign failed to review the Keller seed money contributions, despite rules to the contrary.

The campaign finance report filed on June 14th falsely omitted the secret in-kind contributions of the Union President.

The illegal campaigning and donations of the Union President is particularly troublesome as Neri Holguin, the Keller campaign manager also represents the Albuquerque International Firefighters Union #244. Exhibit 3, client list from Holguin website. Ms. Holguin has filed more ethics complaints than anyone, including the complaint against Keller's opponent Manny Gonzales, demanding that ANY fraudulent Qualifying Contribution or any false statement or material misrepresentation in any report or other document is sufficient to stop any public financing pursuant to the 2021 Regulations of the Albuquerque City Clerk for the Open and Ethical Elections Code, Part C (17)(c). Ms. Holguin previously worked for the Measure Finance Committee that supported Mr. Keller and was found to have violated numerous ethics rules in the 2017 election including violations of the in-kind and reporting rules.

### Summary of Violations By Keller for the Union President's Activity

Keller used a City Union President as a representative of his campaign while the Union President was on the job, to solicit campaign contributions from other firefighters who were on

the job, in the City's firehouse during working hours and then paying the \$5 himself. The same Union President belongs to an organization that is represented by Keller's campaign manager, Neri Holguin.

Keller violated restrictions on using public employees to support his campaign. He violated the restrictions on misuse of public property. He violated the campaign reporting requirements for in-kind contributions, and he violated the restrictions on the use of public resources by candidates currently holding public office. He has violated the most basic tenets of the Ethics Code and the Open and Ethical Elections Code. The penalties for those violations must be applied to him just as they have been applied to other candidates in this election.

### Count II against Keller—Keller's Public Financing Must Be Revoked for Seed Money Violations and Submission of Fraudulent Signatures and Qualifying Contributions

### Violation of Seed Money Restrictions—Contributions from Non-Residents

The City Charter, Article XVI, Section 6 of the Open and Ethical Elections Code governs seed money contributions. Subsection (A) provides that "An Applicant Candidate may accept Seed Money not to exceed \$250.00 per Person."

A Person is defined in Article XVI, Section 3, as (1) a City resident; (2) a labor organization, club, association or organization who have members who are City residents; or (3) a corporation, limited liability company, firm, partnership, joint stock company or other entity conducting business in the City.

<sup>&</sup>lt;sup>1</sup> FN 1 In addition, because Keller and Union President are city employees, the Hatch Act may have been violated. Direct or indirect coercion or attempts to coerce, command or advising a local government employee to pay, loan or contribute anything of value to a candidate may be a violation. See 1501 USC § 1501 (4); 1502 (d) (1) and (2).

In the Campaign Finance Reports filed by the Keller campaign, they list the following seed money contributions from out-of-city and out-of-state individuals which were accepted and reported by the campaign:

Keller's filed Campaign Finance Reports are attached as Exhibit 4.

Keller violated the Seed Money requirements by accepting seed money contributions from prohibited donors. His public financing must be revoked based on the acceptance of illegal seed money contributions.

### Keller's Fraudulent Qualifying Contributions

Keller's campaign manager, Neri Holguin, acted as his representative for qualifying contributions. Exhibit 4 demonstrates that she signed and dated blank contribution forms, as well as submitted unsigned contribution forms. This is despite the requirement set out in the City Clerk's 2021 Candidate Guide, Part C (6) that specifies that "It is the candidate or candidate's representative's responsibility to ensure that the receipt books are filled out accurately, including a signature from the contributor." How many qualifying contributions did Neri Holguin sign in advance without any knowledge of an actual contribution and an actual signature by an eligible supporter?

The Affidavit contained in Exhibit 1 above quotes Keller's representative Justin Cheney and his offer to pay all the \$5 contributions for firefighters whose signatures he collected. The Candidate Guide provides, "All \$5 contributions must be paid by the contributor. If any of the funds are provided by someone other than the contributor listed on the receipt, those contributions will be deemed fraudulent." That guidance is also found in the 2021 Regulations of the City Clerk, in Part I (1), which provides that "[n]o person may make a Contribution in the name of another person... The Contributor identified in reports to ...the City Clerk must be the actual source of the funds for the Contribution."

The attached Exhibit 5 shows four (4) Qualifying Contributions completed by Catherine Jaramillo, which all appear to be signed by Catherine Jaramillo herself. The signatures of the two who are registered voters do not match the voter's signatures on Voter Registration cards. The other two people were not found in the voter file, but the alleged voters' signatures are in the distinctive handwriting of Catherine Jaramillo. If the voters did not sign the qualifying contributions themselves, or contribute the \$5, then the contributions are required to be deemed fraudulent under the Rules and standards established in this election by the City Clerk.

Exhibit 6 is a comparison of signatures and shows a qualifying contribution form signed by Keller Representative Rosemary Garcia. The contributor is Patricia Garcia, but the writing appears to Rosemary Garcia's own distinctive writing. The address listed on the form is Rosemary Garcia's own address. The Secretary of State's office reports that there is no voter named Patricia Garcia at that address, but it is the address of Rosemary Garcia. (Exhibit 6) Again this Qualifying Contribution form is required to be deemed fraudulent if: 1) it was not signed by someone named Patricia Garcia residing at Rosemary Garcia's address, and 2) if Patricia Garcia did not contribute the \$5.

Exhibit 7 is a comparison of signatures for voter Michael Montoya. The comparison shows three different signatures for Mr. Montoya on Keller's nominating petitions, qualifying contribution and Mr. Montoya's voter registration form.

Exhibit 8 includes copies of additional petition signatures that appear to be fraudulent.

When the City Clerk denied public financing to Sheriff Gonzales on July 9, he referred the complaint to the Ethics Board and requested an investigation by the City's Inspector General.

Complainant requests that this complaint against Keller also be referred to the Inspector General and be subjected to the same level of investigation and review as the Gonzales' documents.

### Keller's Public Financing Must Be Revoked For His Violations of Law

The City Clerk's 2021 Candidate Guide, under Section C, Part 17 specifically addresses revocation of a candidate's public financing at any time for these types of violations. It provides:

- 17. Revocation of Certification. The certification of a Participating Candidate may be revoked at any time if the City Clerk determines that the candidate or an agent of the candidate:
  - c. Submitted any fraudulent Qualifying Contributions or Qualifying Contributions that were not made by the named contributor, and the Participating Candidate knew or should have known of the fraudulence;
  - e. Failed to fully comply with the Seed Money and In-Kind restrictions;
  - f. Knowingly made a false statement or material misrepresentation in any report or other document required to be filed under the OEEC or the EC; or
  - g. Otherwise substantially violated the provisions of the OEEC or the EC.

### Summary of Violations by Keller

Keller has submitted fraudulent qualifying contributions, requiring revocation under subsection (c) above. Keller failed to comply with the seed money restrictions by accepting the in-kind contribution from the City of Albuquerque through the solicitation efforts of the Union Representative while the Representative was on the job. This unlawful action requires

revocation, as described in Count I. He failed to comply with the seed money restrictions by accepting seed money contributions from prohibited donors who are neither residents of the City of Albuquerque nor a business entity doing business in the City of Albuquerque. This requires revocation of his public funding. Keller made a material misrepresentation in his June 14 campaign report when he failed to disclose the in-kind contribution from the paid City employee who collected the contributions on work time. Again, this requires revocation of his public funding. Keller substantially violated the provisions of the Open and Ethical Elections Act and the Ethics Code by having a paid City employee solicit contribution from other paid City employees on work time, in the workplace.

Keller's multiple violations of the provisions outlined above absolutely require revocation of his certification for public funding under the same criteria and evidentiary standards established by the Clerk and the Hearing Officer in their review of the complaint filed against candidate Gonzales.

### ARE THE RULES AND RULINGS GOING TO BE APPLIED TO KELLER? The Clerk's Closing Argument on the Denial of Certification to Candidate Gonzales

The City Clerk, in an effort to deny public financing to his boss's opponent, states: "The purpose of the Open and Ethical Elections Code of the City of Albuquerque to "[d] iminish the public perception of corruption and strengthen public confidence in the governmental and election process," to "[i] ncrease the accountability of elected officials to their constituents who elect them," and to "[i] nsure that the City's . . . Mayoral election process is fair, responsible and ethical." Id. § 2 (emphasis added); [Closing Argument Of The City Clerk Of The City Of

Albuquerque In Re: In The Matter Of The Appeal Of The Denial Of Certification As

Participating Candidate For Public Funding Of Sheriff Manuel Gonzales III 7-16-2021]

The City Clerk purports to assure everyone that he is "mindful of his role as steward of public funds – based on the "obligation all officials have to safeguard public funds," [Id.] In his denial of public financing to his boss's opponent Candidate Gonzales, the City Clerk insisted that the candidate must have "otherwise met the requirements for obtaining financing pursuant to the Open and Ethical Elections Code," OEEC § (7)(A)(5), and "otherwise met any additional criteria for certification set forth in rules by the Clerk." OEEC § 7(A)(6). The requirements of Section 7(A)(5) include submitting "Qualifying Contributions," receipts of which must be "signed by the contributor." [Id.]

As asserted by the City Clerk in his closing argument:

These Open and Ethical Elections Rules – properly promulgated by the Office of the City Clerk – flesh out the requirements of the OEEC. They command that "[a]ll \$5 Qualifying Contributions must be paid by the contributor; if the funds are provided by any person other than the contributor who is listed on the receipt, the Qualifying Contribution will be deemed fraudulent." Ex. B, OEEC Part C(6). And they bar the Clerk from certifying a candidate when the candidate has "been found to have made a materially false statement in a report or other document submitted to the City Clerk," OEEC Part C(15)(a)(iii) or has "been found to have submitted any fraudulent Qualifying Contributions or any falsified acknowledgement forms for Qualifying Contributions or Seed Money Contributions, where the Applicant Candidate knew or should have known of the fraudulence or falsification." OEEC Part C(15)(a)(v). [emphasis added] [Id.]

The disqualification letter from the City Clerk to Candidate Gonzales, advised Gonzales "that the City Clerk determined he was required not to certify based in part on the rules Part C(15)(a)(iii) – the candidate "hav[ing] made a materially false statement in a report or other document submitted" – and C(15)(a)(v) – the candidate "having been found to have submitted any fraudulent Qualifying Contributions or any falsified acknowledgment forms for Qualifying

Contributions . . . , where the Applicant Candidate knew or should have known of the fraudulence or falsification." Id.

The City Clerk determined that Candidate Gonzales should have known of the fraudulent Qualifying Contributions submitted by his campaign, citing *Stevenson v. Louis Dreyfus Corp.*, 1991-NMSC-051, ¶ 16, 112 N.M. 97 ("One who intentionally remains ignorant is chargeable in law with knowledge.") (quoting *Taylor v. Hanchett Oil Co.*, 1933-NMSC-099, ¶ 13, 37 N.M. 606).

### These Same Standards Applied to Advantage Keller Must also be Applied Against Keller

The City Clerk has taken the position (again, as against his boss's opponent) that any apparently fraudulent qualifying contributions warrant non-certification. The City Clerk has also taken the position that a materially false statement in a report submitted to the Clerk warrants non-certification or revocation. If this action against Gonzales is not to be considered a one-off, one-time-only Banana Republic ruling, then Keller's public funding must also be revoked, otherwise the ruling against Gonzales becomes an obvious sham, and an obvious application of the law in a manner which is non-uniform and highly discriminatory. After all, Keller is obviously guilty of the corrupt misuse of his Union President supporter, the fraudulent Qualifying Contributions and petition signatures, and the failure to report the in-kind contribution from the City of Albuquerque when that very same City employee solicited contributions for Keller on work time.

The City Clerk's rules insist the Code and Rules are to be "fairly and consistently applied, to provide transparency for voters and bring accountability to Candidates and Offices."

(Introduction "Purpose"). Are the ethics codes and the rules going to be applied fairly and consistently?

<u>Disparate and Biased Treatment of the Mayoral Campaigns by City Clerk Nathan Watson</u>

<u>Requires His Disqualification from any proceeding involving Tim Keller, the Keller</u>

campaign or Keller's opponent, Manual Gonzales.

City Clerk Nathan Watson did not follow his own published rules in the processing and validation of Keller's qualifying contributions.

### Watson Violated His Own Rules for Verifying Qualifying Contributions

Nathan Watson's published rules, titled "2021 Regulations of the Albuquerque City Clerk for the Open and Ethical Elections Code," in Section 14, commands "the Office of the City Clerk will verify each and every Qualifying Contribution to ensure the Contribution meets all requirements."

Next, that Section of Rules says that "[T]he City Clerk will ensure that the verifying staff is adequately trained in the verification process. Using the New Mexico Secretary of State's and Bernalillo County Clerk's Voter Registration System, staff will physically verify each contribution by comparing the contributor's name, address and signature on the receipt to the voter registration rolls and ensuring that the requirements noted above in Subpart C(5)(a)<sup>2</sup> are met. [Emphasis added]

This Section also outlines the requirements for notifying candidates of accepted and rejected qualifying contributions and the City Clerk's process for handling of suspicious signatures or receipts. It says:

Qualifying contributions are accepted, rejected or left pending by the verifying staff. The City Clerk will notify Applicant Candidates of the number of accepted, rejected and pending Qualifying Contributions regularly during the Qualifying Period. Pending Qualifying Contributions are reviewed by a supervisor and the City Clerk to determine whether the Qualifying Contribution is accepted or rejected. In the case of a rejected Qualifying Contribution with some evidence of intentional wrongdoing, the City Clerk will notify the City Attorney for further investigation. The City Clerk will consider any Qualifying Contribution submitted to the City Attorney as rejected until receiving an opinion or court order that the Qualifying Contribution is acceptable.

### There Was No Signature Review of the Keller contributions

The City Clerk's office also did not engage in the required signature comparison for the Qualifying Contributions submitted by current Mayor Tim Keller's re-election campaign. *See* 2021 Regulations of the Albuquerque City Clerk for the Election Code, Part F, 2a and 3. The spreadsheet provided by the City Clerk's office does not list a signature mismatch as a reason for rejection of even one of Tim Keller's Qualifying Contributions and there is no evidence that the City Clerk's office even attempted to compare Keller's contributor signatures as required by the Clerk's own rule. When compared with the City Clerk's unprecedented efforts and unique penalty to disqualify the Mayor's opponent, the bias, prejudice, interest, motive, and opportunity compel the excusal of the City Clerk from any more assistance to his boss.

Nathan Watson used city resources and staff to benefit a one-sided investigation into his boss's opponent. He ignored his own obligation to conduct a signature review to avoid making any findings against his boss, Keller. He has engaged in such clear conflicts of interest that he cannot participate in any proceeding involving Tim Keller, the Keller campaign or Keller's opponent, Manuel Gonzales.

### **CONCLUSION**

The use of government employees to promote an incumbent elected official has been condemned for more than 100 years. The violations of the ethics codes and rules compel the withdrawal of all public funding. Keller has violated the public trust, the ethics codes and rules by using his position as Mayor to send his city paid employees out: (1) to promote his campaign to city employees; (2) to campaign on City time; (3) to campaign on City property; and (4) to pay the \$5 for any "donor". All of these actions violate the City's Ethics Codes and Rules. Keller also blatantly violated the Rules and Code provisions on seed money contributions. He violated the seed money limits when he used a public employee who was on the job to collect contributions for him, and he violated the seed money reporting requirements when he failed to report the in-kind contribution. On the seed money contributions that Keller did report, he accepted multiple seed money contributions from prohibited donors who are not residents of Albuquerque. Keller's campaign manager turned in pre-signed and dated contribution forms, as well as unsigned contribution forms – more violations of the Rules. Finally, the public documents attached demonstrate that Keller submitted a number of fraudulent signatures on both nominating petitions and qualifying contributions.

Keller broke the law in half a dozen different ways so he could fraudulently obtain more City money—\$660,000 in public financing. That funding must be revoked, and the Mayor must be required to return the entire \$660,000 he received.

Additionally, the City Clerk has demonstrated a history of bias in favor of Tim Keller and must be disqualified from any further involvement with the Keller campaign or any complaints

against it, and this matter should be referred to the Inspector General for an independent investigation of Keller's illegal and fraudulent activities.

### **DECLARATION OF SHAWN McDONALD**

Shawn McDonald makes this Declaration under penalty of perjury of the laws of the State of New Mexico and states:

- My name is Shawn McDonald. I am over the age of eighteen (18) years and competent to testify to the matters stated in this Declaration.
- While on duty with the Albuquerque Fire Department on June 1, 2021, the Albuquerque 2. Fire Rescue Union President (IAFF Local 244) visited the station and discussed contract matters, negotiations, and the mayoral election.
- The Union President asked people to sign Keller's \$5 donation cards. One of the members asked him, "What is this \$5 deal? You didn't say anything about five bucks."
- In response, the Union President told everybody at the meeting, "I got that, don't worry about it. It's too hard for me to go around and ask people to sign this and donate five dollars. I only have three books. It's a hundred and fifty bucks, and I'm going to cover it for all the guys who want to sign it."
- I spoke up and told him and everyone present that "You're not allowed to do that." 8.
- 9. The room went silent for a bit, but members then continued to review the donation cards.
- I was talking to some members and could not see how many cards were signed, as I was distant from the table and the cards.
