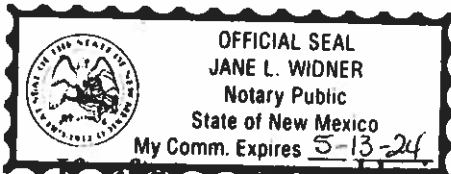

STATEMENT OF FACTS IN SUPPORT OF COMPLAINT – EXHIBIT “A”

1. Eddy Aragon is running as a privately financed candidate for mayor.
2. The 2021 Regulations of the City of Albuquerque for Elections provide limits on the amount a privately financed candidate for mayor may receive from any individual. That limit is \$6,250 from any individual.
3. The 2021 Regulations of the City of Albuquerque In-Kind Contributions are goods or services that are donated or provided to the campaign at no cost, or at a cost discount of 20% or more.
4. In-kind contributions are subject to contribution limits for both publicly financed and privately financed candidates.
5. Under the City’s Regulations, Eddy Aragon, as a privately financed candidate for mayor, is limited to \$66,130 in aggregate in-kind contributions.
6. Eddy Aragon is the owner of a Limited Liability Company, Rock of Talk, LLC, which is the owner of a radio station in Albuquerque identified as KIVA, which broadcasts on the internet and on AM radio. (Attachment 1- Secretary of State’s office records for Rock of Talk, LLC)
7. Eddy Aragon’s Financial Disclosure Statement on file with the City of Albuquerque lists “Rock of Talk” as his only source of income. (Attachment 2 – Eddy Aragon’s Financial Disclosure Statement).
8. The 2021 Regulations of the Albuquerque City Clerk for the Election Code, Part E(2)(e), provides that “if a candidate has a business entity and that entity provides goods or services to the campaign without charge, or at a 20% or more discount, those contributions are In-Kind Contributions that must be disclosed.”
9. Aragon has openly used the radio station platform on a daily basis to obtain nominating petition signatures and raise money for his political campaign.
10. Eddy Aragon filed his Candidate Registration with the City of Albuquerque on April 21, 2021 and has amended his Candidate Registration twice since that time. All three Candidate Registration forms list the website, RockofTalk.com, as his campaign website. That website link goes directly to the KIVA radio station website. (Attachment 3 – Eddy Aragon’s Candidate Registrations).
11. Eddy Aragon filed a Candidate Contact Sheet with the City of Albuquerque on July 26, 2021. That Candidate Contact sheets lists his campaign website as 1ABQ.com. That link goes to a campaign website for Eddy Aragon with a button for viewers to make donations to his campaign. The campaign website also provides viewers with a link to another website, EddyWins.com. (Attachment 4- Eddy Aragon Candidate Contact Sheet; Attachment 5- screenshots from 1ABQ.com.)
12. There is no expense listed on Eddy Aragon’s first two campaign reports for any website or domain name, or broadcast advertising except Alexander Media on October 4. The only expenditures listed on Eddy Aragon’s first two campaign reports are for signs, t-shirts, consulting fees, check printing, and Antedot transaction fees. (Attachment 6- Eddy Aragon Campaign Finance Reports filed 8/10/21; 9/13/21 and 10/11/21.)
13. Eddy Aragon did not report any in-kind contributions from any source on any of his campaign finance reports. (Attachment 6)
14. Importantly, Aragon has not reported any in-kind contributions from his wholly owned business, Rock of Talk, LLC. on either of the campaign finance reports he filed in August or September 2021.
15. KIVA and Eddy Aragon promote the radio station as the “Fox News of New Mexico,” and broadcasts syndicated conservative talk radio shows in addition to a daily hour and a half show featuring Aragon himself. (Attachment 7- screenshot of programming lineup for KIVA radio)

16. Section 315(a) of the Federal Communications Act and Section 73.1941 of the Federal Communication Commission's (FCC) rules require that if a station allows a legally qualified candidate for any public office to use its facilities (i.e., make a positive identifiable appearance on the air for at least four seconds), it must give equal opportunities to all other candidates for that office to also use the station. Equal opportunities apply to all commercial and non-commercial stations, as well as all legally qualified candidates for public office (federal, state, and local) throughout their campaigns
17. Section 315(b) of the Federal Communications Act and Section 73.1942 of the FCC's rules require that during the 45-days preceding a primary or primary runoff election and during the 60-days preceding a general or special election, stations cannot charge legally qualified candidates or their authorized organizations more than the lowest unit charge for the same class, same amount of time, and same daypart as they charge their most favored commercial customers.
18. Therefore, during these narrow windows, candidates are entitled to the benefit of all volume discounts even if they purchase a single advertisement. At all other times during political campaigns (i.e., outside of the windows), stations can charge candidates no more than they charge commercial advertisers for comparable use of their facilities.
19. Section 315(e) of the Federal Communications Act and Section 73.1943 of the FCC's rules require all stations to maintain online political files.
20. Information must be uploaded to <https://publicfiles.fcc.gov> (<https://publicfiles.fcc.gov>) as soon as possible when a station receives a request for the purchase of airtime that is made by – or on behalf of – any legally qualified candidate (federal, state or local) or is made by an issue advertiser and the ad communicates a message relating to any political matter of national importance. In addition, records of all free time must be placed in the political file. The information that must be uploaded about requests for the purchase of broadcast time include whether the request is accepted or rejected, the rate charged, the date/time the ad ran or will run, the class of time purchased, the name of the candidate, the office being sought, the issues that are referenced, the name of the person or entity purchasing the time, and a list of executives of the sponsoring entity.
21. Eddy Aragon has not posted any political files for 2021 for KIVA on the FCC's site for maintenance of political files as of October 12, 2021, despite his daily appeals for support, petition signatures and funding on KIVA for his political campaign. (Attachment 8 – Screenshot of FCC public files page for KIVA radio).
22. In his campaign reports filed with the City of Albuquerque in August and September, Aragon did not disclose any in-kind contributions from Rock of Talk, LLC despite the fact that he is using the KIVA radio station on a daily basis to raise funds and support for his candidacy.
23. Rock of Talk, LLC, doing business as KIVA radio, broadcasts syndicated programming and Fox News updates.
24. Rock of Talk, LLC has paid advertisers supporting the syndicated programming as well as Eddy Aragon's own talk program.

25. The amounts paid by those advertisers constitute an in-kind contribution to Eddy Aragon's campaign because he is using the station to promote his mayoral candidacy. (Attachment 9– KIVA rate sheet)
26. Eddy Aragon is actively violating the in-kind contributions limits established for mayoral candidates in the City of Albuquerque by making excessive in-kind contributions from his wholly owned company, Rock of Talk, LLC, through daily radio advertising for his campaign, and by linking his campaign to nationally syndicated news programs.
27. Eddy Aragon is actively violating the City of Albuquerque's reporting requirements by failing to accurately report his in-kind contributions and expenditures on his campaign finance reports.
28. Eddy Aragon is acting in violation of the FCC rules governing the KIVA radio station and Rock of Talk, LLC's broadcast license in order to benefit his campaign for mayor.
29. The 2021 Regulations of the Albuquerque City Clerk for the Election Code (the Regulations), Part G(1), provides:

When a person makes an Expenditure to finance an audio or visual communication advocating the election or defeat of a candidate or ballot measure through broadcasting stations, cable television systems, newspapers, magazines, campaign signs or other outdoor advertising facilities, publicly accessible internet sites, email, text messages, direct mail, handbills, bumper stickers, and other non-periodical publications, or other similar types of general public political advertising, the communication, if authorized by a candidate, a candidate's authorized political committee, or their agents, must clearly and conspicuously state the name of the person who made or financed the Expenditure for the communication.
30. The daily use of the KIVA radio station by Eddy Aragon to promote his campaign is subject to the disclosure requirement in Part G above. In addition to failing to report the expenditure or in-kind contribution associated with the radio broadcasts, Eddy Aragon has failed to include the required disclaimer information on the broadcasts and KIVA website.
31. Part G(5) of the Regulations provide that "a person may not publish or submit to be broadcast a communication described in subparts 1 to 3 without including the disclosure required by this Part."
32. Part G(8) of the Regulations provide:

As part of each Campaign Finance Disclosure Statement, every Candidate, Treasurer or Chairperson shall submit a detailed accounting of any political communications that resulted in an expenditure. This includes, but is not limited to: signs, billboards, doorknockers, promoted or boosted social media posts, broadcast media, t-shirts, bumper stickers or buttons. The Campaign Finance Report shall include certain details regarding such communications including the size and quantity where applicable. Each Campaign Finance Report shall be accompanied with images or proof of how funds were expended.
33. Eddy Aragon has used his radio station and radio station website on a daily basis to promote his candidacy and has failed to comply with the requirements of Part G in the filing of his campaign finance reports.

34. In the Campaign Report filed on October 11, 2021, Eddy Aragon listed a \$6000.00 contribution on September 24, 2021, from Ann Cherry, no address, None, NM 87120. That contribution is near the limit, and the entry shows a blatant disregard for the reporting requirements. (Attachment 6)

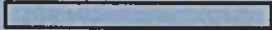
