I. CALL TO ORDER.

VII. LB 12-02, ORDER DENYING THE CITY OF ALBUQUERQUE'S MOTION FOR REHEARING, MODIFYING THE COURT'S MEMORANDUM OPINION AND ORDER, FILED APRIL 22, 2016 AND REMANDING THIS MATTER TO THE BOARD FOR FURTHER PROCEEDINGS AS APPROPRIATE.

James Montalbano, Attorney for AFSCME stated that the District Court has remanded this matter back to the Labor Board for further findings but the Union believes there are no further items to be considered. The Court remanded this matter back for further findings regarding the issue of waiver and management rights. He stated that the Board has already considered the issues of waiver and management rights and asked the Board to close this matter and enter an Order in accordance with the District Court Order.

Samantha Hults, Assistant City Attorney appeared on behalf of the City. She stated that the City disagrees with Mr. Montalbano because the Board never got to the City's arguments regarding waiver and management rights. The Board issued an Order on only one of the three issues and therefore, the City asked the District Court to send this back to the Board for further findings.

Chairman Baca moved that the Board consider and rule on the issues of waiver and management rights. Mr. Wartell seconded. Vote taken and passed 3-0. Chairman Baca then ordered both parties to submit Brief's within sixty days, due by August 29, 2017.

Melissa Kountz, Assistant City Attorney appeared and asked the Board to hold off on scheduling LB 10-19; LB 12-18; LB 12-28; LB 15-01; LB 15-29 and LB 15-34 until after November when she returns from a three month leave. Mr. Montalbano appeared on behalf of AFSCME and agreed to not schedule the six cases until after November but if the Union has an urgent matter will contact City Attorney's office to discuss scheduling or will make the request to the Board. Chairman Baca agreed to reset the cases for argument in November 2017.

Scheduling was discussed by the Board for July meetings and the Board agreed to schedule a meeting on July 13, 2017 and July 17, 2017. The parties and the Board agreed to schedule LB 12-20; LB 14-20 and LB 15-18 for a Motions Hearing on July 13, 2017. For July 17, 2017 they agreed to schedule Motions Hearing for LB 14-11; LB 15-27; LB 15-28 and LB 15-32. Cases LB 15-33 and LB 15-35 will be rescheduled to discuss scheduling on July 13, 2017.

James Montalbano appeared on behalf of AFSCME and stated that he received a request from Assistant City Attorney Ian Stoker to reschedule this hearing because he was not available to attend the meeting. Kelly Garcia, Assistant City Attorney stated that the City will be filing a Motion to Stay Proceedings in this matter. Chairman Baca agreed to reschedule this Motions Hearing for July 13, 2017.


XI. ADJOURNMENT.
