Minutes

I. CALL TO ORDER.

Chairman Ted Baca called the meeting to order. Board members Juan Montoya and Bruce Perlman were also present.

II. REVIEW AND APPROVAL OF THE SECOND AMENDED AGENDA FOR MONDAY, AUGUST 22, 2022.

Mr. Montoya moved to approve the amended agenda. Mr. Perlman seconded. Voted and passed 3-0.

III. REVIEW AND APPROVAL OF LABOR BOARD MINUTES FOR JULY, 20, 2022.

Mr. Perlman moved to approve the minutes for July 20, 2022. Mr. Montoya seconded. Voted and passed 3-0.

IV. PUBLIC COMMENTS *Limited to three (3) minutes total time per person.

Chairman Baca stated that Mr. Montoya's membership on the Board is expiring in September and the Union's were notified to submit their candidate information for re-appointment or to nominate a new member. VIII. STATUS CONFERENCE:

- **LB 15-07, PROHIBITED PRACTICE COMPLAINT FILED ON BEHALF OF AFSCME LOCAL 1888, 624 AND 2962 AGAINST THE CITY OF ALBUQUERQUE HUMAN RESOURCES DEPARTMENT FOR VIOLATIONS OF THE LABOR MANAGEMENT RELATIONS ORDINANCE SECTIONS 3-2-9.**

Rocky Gutierrez appeared on behalf of AFSCME. Assistant City Attorney Ian Stoker appeared on behalf of the City. The parties stated matter has been resolved and pending closing documents. Chairman Baca rescheduled this matter for status conference on September 12, 2022.

- **LB 20-51, PROHIBITED PRACTICE COMPLAINT FILED BY THE INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS LOCAL 244 AGAINST THE CITY OF ALBUQUERQUE AND CITY OF ALBUQUERQUE FIRE DEPARTMENT FOR VIOLATING THE COLLECTIVE BARGAINING AGREEMENT AND THE PAST PRACTICES BETWEEN THE PARTIES.**

Mr. Stoker appeared on behalf of the City and stated that the parties have settled this matter and a Motion and Order of Dismissal were filed with the Board but was not listed on the agenda. Chairman Baca stated that the Order of Dismissal will be placed on the next Board meeting agenda.

VIII. LB 22-30, THE ALBUQUERQUE POLICE OFFICERS' ASSOCIATION'S PETITION FOR CERTIFICATION AND REPRESENTATION.

Mr. Stoker appeared on behalf of the City. Mr. Mowrer appeared on behalf of APOA and Paul Broom for APOA. The Board discussed the one-day notice and three-day notice that the Board would be issuing regarding this Petition. Chairman Baca signed the Notice of Filing of Representation Petition, Request for Petition Information and Request for Payroll Information. He then stated that Jessica Enriquez would issue the notices to the parties. The Board scheduled a meeting for September 2, 2022 for a second status conference for LB 22-30.
