In the letter dated May 30, 2025, Mr. Watson states in the last sentence of the 2nd ¶ That the Clerk's office would NOT be "referring [my] complaint to the BOE + Campaign Practices." Yet, on June 11, 2025, Mr. Watson presented my complaint to the BOE at their regular mtg. I had not filed an appeal. I did not appeal to BOE and now do not believe the BOE would be impartial
- The presentation of a constituent's lay person's concerned ~~me~~ of ethics was received as one violations that was disparaging.

I am not sure what exact ordinances, rules, or regulations it violates to have a City Clerk lie, but Mr. Watson presenting <sup>2</sup> my complaint 2 wks after his denial of my complaint AND after my very
