CONSULTING CONTRACT

THIS CONSULTING CONTRACT is made and entered into effect by and between the, The Barnett Law Firm P.C., Colin Hunter, hereinafter (BLF or Consultants) 1905 Wyoming N.E. Albuquerque, N.M. 87112 and Freedman Recycling Companies, hereinafter (Friedman), 3640 West Lincoln Street Phoenix, AZ 85009.

In consideration of the mutual covenants herein contained the parties agree as follows:

1. **Employment.** Friedman contracts with, retains the BLF in matters hereinafter mentioned.
2. **Services.** It shall be the duty of the Consultants to advise, consult with and represent Friedman before the City of Albuquerque, the Mayor of Albuquerque, and the Albuquerque City Council, neighborhood associations, and other possible governmental entities regarding a Materials Recovery Facility in partnership with the City and other issues of importance to Friedman's business interests in the state of New Mexico. The scope of work does not include legal work on behalf of Friedman.
3. **Compensation.** As consideration for the services rendered pursuant to Paragraph 2 of this Contract, the Consultant shall be compensated Four Thousand Dollars (\$2,500.00), plus gross receipts tax of (\$175.00), for a total compensation amount of \$2,750.00, for month for services rendered.
4. **Assignment.** No assignment of the obligations of this Contract in whole or in part, and no assignment of any interest in the compensation agreed to be paid

under this Contract shall be made without the consent previously obtained by Friedman.

5. **Term.** This agreement shall be deemed effective for a minimum of three months as of May 1, 2011, after which it may be terminated at any time upon thirty (30) days' written notice by either party. If so terminated, the Consultant shall be entitled to compensation up to the date of termination in accordance with the Contract at the rate specified in Paragraph 3.
