## Minutes

#### I. CALL TO ORDER.

Chairman Ted Baca called the meeting to order at 9:05 a.m. Board members Juan Montoya and Bruce Perlman were also present.

II. REVIEW AND APPROVAL OF THE AGENDA FOR FRIDAY, JANUARY 10, 2020.

Devon Moody, Assistant City Attorney appeared on behalf of the City and stated that the parties filed a Joint Motion to Continue and Order for item VIII, LB 19-21 scheduled for merits hearing.

Ian Stoker, Assistant City Attorney appeared on behalf of the City and stated that the parties reached a settlement in LB 19-22 scheduled for merits hearing under item VIII. An Order of Dismissal was presented to the Board and approved. See item V.

Mr. Montoya moved to approve the agenda with changes for January 10, 2020. Chairman Baca seconded. Voted and passed 3-0.

III. REVIEW AND APPROVAL OF LABOR BOARD MINUTES FOR DECEMBER 16, 2019. Mr. Perlman moved to approve the minutes for December 16, 2019. Mr. Montoya seconded. Voted and passed 3-0.

Justin Pennington, Assistant City Attorney appeared on behalf of the City for LB 16-16 and stated that the parties settled this matter and the merits hearing on January 13, 2020 is cancelled

Mr. Stoker appeared on behalf of the City for LB 16-12 and stated that the parties have resolved this matter and the merits hearing for January 13, 2020 is cancelled.

Chairman Baca discussed the Findings of Facts and Conclusions of Law that were submitted by the Union in LB 16-20 and asked if they were stipulated. Mr. Stoker stated that the findings were submitted also as form of an Order and the City approves as to the form. This matter will be placed on a future agenda for entering of the decision.

Chairman Baca asked for the status of LB 17-01. Mr. Pennington stated that there are two pending motions filed by the City and that is a Motion to Dismiss for Mootness and Motion to Dismiss. Chairman Baca scheduled this matter for motions hearing on January 24, 2020. Rocky Gutierrez appeared on behalf of AFSCME and stated that the Union has responded to the first Motion to Dismiss and will submit a response for the second Motion to Dismiss for Mootness.

Mr. Pennington stated that the parties are discussing a possible resolution for LB 17-17 which is scheduled for status conference on January 13, 2020. He also asked to schedule a hearing pending the resolution. Chairman Baca scheduled this matter for merits hearing on February 10, 2020.
