As a PRC member, Marks had many other legislative accomplishments advancing clean energy and consumer protection, and he partnered with Think New Mexico to draft and pass the 2012 constitutional amendments that created the Office of Superintendent of Insurance as an independent agency and removed Corporations from the PRC.
